'Thankful' MMA Pro **Fights for Freedom In Robbery Case Bv** David Brand

He's just 7-9 in the octagon as a professional mixed martial artist, but he hopes to have better luck against his latest opponent: Queens County prosecutors.

Opening statements begin today in the bank robbery trial of MMA fighter Sergio DaSilva, who is charged with first-degree robbery while displaying a firearm and third-degree robbery, for allegedly sticking up a Citibank in Astoria on Aug. 31, 2017. Prosecutors say DaSilva stole \$44,964 and fled on Steinway Street.

After the robbery, a bank teller told police that a man jumped over the teller window to where she was seated, told her he had a gun and threatened to shoot her if she did not give him money, according to the criminal complaint.

Surveillance camera footage allegedly showed DaSilva wearing a dark hooded sweatshirt with his face partially covered when he demanded the bank teller to hand over the Continued on page 2

loot. He was identified by fingerprints left on the partition glass that matched the prints he gave after a 2008 arrest, according to the criminal complaint.

A spokeswoman for the Queens District Attorney's office said DaSilva pled guilty to a violation in the 2008 case. That case was sealed and the DA's office could not share information about the arrest, though the information is available in the County Clerk's office, the spokeswoman said.

DaSilva, pleaded not guilty at his supreme court arraignment in January 2018 and was released on his own recognizance.

He has been active on social media leading up to the trial, frequently posting his opinions about National Football League playoff games, wishing his attorney David Fish a happy birthday and musing about his upcoming trial. "Crazy to think this but tomorrow I start trial," DaSilva tweeted Monday. DaSilva, who goes by the nickname "The Savage," has 2050 followers and tweets under the handle @ thesavage125.

Judge Leslie Leach will preside at the jury trial. Jury selection wrapped up last week and on Monday morning, DaSilva also tweeted his optimism that the jury will be impartial.

"I'm just thankful for a fair jury," read a graphic that he posted on Twitter. DaSilva attributed the quote to rapper Beanie Sigel.

Since his arrest in September 2017, DaSilva has used social media to wage his bout in the court of public opinion.

"I got all the text, calls, emails, messages etc. thank you to my phenomenal lawyer I'm home and my attorney is working hard to clear this up," he said on Facebook in September 2017. "As much as I would love to speak more about the allegations my legal team has rightfully advised me against discussing any details until the case is over."

On Jan. 3, he posted a video demonstrating that his swagger extends beyond the ring. "My attorney and I are very confident with

how the trial is going to go," he said.

DaSilva, who fought in the Bellator MMA promotion, is represented Fish, who describes himself as a "Mixed Martial Arts agent/ manager; employment lawyer; trial attorney; law school professor and sports law faculty advisor" in his Twitter bio.

Fish did not respond to request for comment as of press time.

If convicted, DaSilva faces five to 25 years in prison.

ARMORED-TRUCK DRIVER ACCUSED OF STEALING \$1.6 MILLION FROM JOB

Former Armored truck driver Riguerson Avril is expected in APN for a scheduled conference.

Avril, 37, of 85th Street was charged on July 24 for first- and second-degree grand larceny charges, along with additional counts of criminal possession of stolen property, after he allegedly swiped about \$1.6 million in cash from the truck he was driving.

Avril was allegedly caught on camera taking the money bag in the vicinity of Vernon Boulevard and Fifth Street in Long Island City.

He was arrested the next day when he showed up to work and allegedly admitted to taking the bag, shoving it under the truck toward the vehicle's cab and covering it with a raincoat.

"The defendant allegedly took advantage of his access to enrich himself. He stashed a bag of bills under a truck and then left with the money.



He returned to work the following day as if nothing was amiss," Queens District Attorney Richard A. Brown said in a statement. "If the allegations are proven true, the defendant will face a long term of incarceration as a result of his greed."

TRIAL BEGINS FOR SWORD-WIELDING WOMAN WHO ALLEGEDLY SLASHED BOYFRIEND

Karla Barba is charged with first-degree assault for allegedly striking her boyfriend with a sword. Barba appears in K15 for trial.

In 2017, Barba was arrested for allegedly hitting her boyfriend in the head with a samurai sword, unsheathed the weapon and slashed him with it during an argument. The victim's sister told *The New York Post* that Barba was yelling at her boyfriend and got the sword when the boyfriend asked her to stop. The man's son witnessed the alleged incident.

Barba is the ex-girlfriend of former State Sen. Hiram Monseratte who was charged with slashing Barba in the face with a glass in 2009 and expelled from the senate.

ALLEGED SHOOTER AIMED AT GIRLFRIEND, STRUCK BYSTANDER

Snooze Brown is charged with seconddegree attempted murder for allegedly firing a bullet at his girlfriend and striking a 28-yearold woman in January in Long Island City. He appears in TAP A for a conference.

Brown allegedly argued with his girlfriend before pulling out a gun and shooting at her. The bullet missed, but struck the victim after she exited the 21st Street - Queensbridge F subway stop.

ALLEGED WALK-BY SHOOTER HEADS BACK TO COURT

Jamaica resident Pharoah Ferguson is charged with second-degree murder for allegedly shooting into a parked car, killing one person and injuring another in Ozone Park. Ferguson appears in TAP C for a conference.

Ferguson allegedly approached a parked car with four passengers and killed the front-seat passenger near the Van Wyck Expressway in January. The driver was also shot in the neck and two other passengers were injured in the shooting

"This was yet another senseless shooting in our community. A man is dead and his friends are still healing from their wounds," Queens District Attorney Richard Brown said in a statement. "The defendant in this case will be held accountable for this needless slaying and now faces spending the rest of his days locked away from a civilized society."

RAPPER'S ALLEGED KILLER RETURNS TO QUEENS COURT

Quincy Homere is charged with seconddegree murder for allegedly shooting and killing Lionel Pickens, a rapper also knonw Chinx, an up-and-coming rapper from Far Rockaway. Homere appears in TAP C for a conference.

In May 2015, Pickens was sitting inside his luxury car at a red light on Queens Boulevard in Briarwood when another car pulled up next to him and a passenger fired bullets into Picken's vehicle, shooting and killing the rapper.

The alleged beef between Homere and Pickens dates back to 2009 when the two men fought inside Rikers Island where they were detained.

Prosecutors say Homere and a friend learned that Chinx was performing at a bar in Brooklyn the night of the murder and followed him to a hookah bar after the show.

They allegedly followed him as he drove along Queens Boulevard, where prosecutors say Homere shot and killed Pickens. Homere and his alleged accomplice were arrested for the

SCHUMER WARNS THAT NYC RESIDENTS WILL SOON FEEL PAIN OF FEDERAL SHUTDOWN

The economy of New York is under threat, and everyday New York City residents will soon begin to feel the pain from the partial government shutdown, U.S. Sen. Chuck Schumer said on Sunday. After meeting with President Donald Trump last week, Schumer said the president told him the shutdown, which Schumer calls "needless," could last months or even years. ELMHURST MOM CHARGED WITH KILLING TODDLER

Shangbo Xiangshengjie is charged with second-degree murder for allegedly strangling her 15-month-old daughter to death. She appears in TAP D for a conference.

In 2017, Xiangshengjie, an Elmhurst resident, was charged with murder after she admitted to killing her daughter with a charging cord and a religious item hanging on the wall of their apartment, *The New York Post* reported.

"This is truly a very sad case in which a fifteen-month-old baby lost her life allegedly at the hands of her own mother — the woman who was supposed to nurture and care for her," said Queens DA Richard Brown. "If the allegations prove true, the defendant will have to live the rest of her life knowing that her actions and hers alone were responsible for the death of her child."

FAR ROCKAWAY MAN ALLEGEDLY STABBED GIRLFRIEND WHO USED WHEELCHAIR

Jonnie Jones is charged with second-degree murder for allegedly stabbing a woman to death in 2017. Jones appears in TAP D for a conference.

Prosecutors say Jones, 42, argued with his ex-girlfriend — who was using a wheelchair while she recovered from foot surgery — and the woman's son before he stabbed the woman to death at their home on Beach 32nd Street.

According to the *Daily News*, Jones became extremely angry with the woman and her son and accused the son, 21, of jumping him in the lobby earlier that day. Before the alleged murder, cops had visited the apartment five previous times to respond to domestic violence complaints.

New York Lawmakers Return to Take Up Pot, Tolls, Sports Bets

Legalized marijuana, sports betting and new traffic tolls in Manhattan are just some of the measures Democrats believe they can push through the New York Legislature in a 2019 session that begins this week with their party in control of both chambers and the governor's office for the first time in a decade.

Lawmakers swept into office in a backlash against President Donald Trump's plan to fight back against his policies on immigration, the environment and health care, while also seeking to catch up to neighbors such as Massachusetts, which has already legalized marijuana, and New Jersey, which has approved sports betting.

Other items on their wish list include expanding state health care programs, codifying protections for abortion rights, reforming antiquated voting laws and eliminating cash bail for criminal defendants.

"People will finally get the government they have been voting for so many years," predicted Senate Democratic leader Andrea Stewart-Cousins of Yonkers, the first woman to lead a legislative body in New York.

First up when lawmakers convene tomorrow may be the Child Victims Act, a long-debated bill that would extend the statute of limitations for child molestation and create a one-year window for victims to sue over old abuse claims now barred by the statute of limitations. The measure has repeatedly passed the state Assembly only to be blocked by the Senate's Republican leaders under pressure from the Roman Catholic Church.

"It's been obstructed for such a long time, but I believe it will be done within the first 30 days of the session," said Gary Greenberg, a leading supporter of the Child Victims Act who created a political action committee to support candidates who backed the bill.

But having a solidly Democratic majority doesn't mean there is consensus on everything

While there's broad support for legalizing marijuana, for example, lawmakers don't yet have agreement on several thorny details, such as how many retail establishments to permit or how high the taxes on the product will be.

Cuomo wants to include marijuana legalization in the state budget, due by April 1, a remarkably short time frame for such a complicated issue. Regardless of what form legalization may take, many lawmakers want a phased-in approach similar to the one adopted in Massachusetts, where personal possession and cultivation of marijuana were legalized long before the first retail shops were allowed to open.

Assembly Speaker Carl Heastie and many members of his chamber want lawmakers to also consider expunging the criminal records of thousands of people who were arrested for using the drug — a proposal that could complicate legalization even further. Officials say they also want to examine the experiences of Massachusetts, California, Colorado and other states that have already legalized the drug.

"I don't support people smoking cannabis, but here's a fact: they do, and they do in big numbers," said Buffalo Democrat Crystal Peoples-Stokes, the Assembly's incoming majority leader and a key proponent of legalization.

Approving new congestion tolls for New York City will be just as politically challenging. Supporters, including environmental groups, transit advocates and even local chambers of commerce, argue that new surcharges on vehicles entering the busiest parts of Manhattan are the best way to discourage driving while raising billions to repair and modernize the city's subways. Gov. Andrew

repairs or else the nation's largest city will have to live with a system that has fallen far behind its peers in other global cities.

"New York City's subways are falling apart. Service disruptions and frequent delays have become all too common, contributing to what has become a daily nightmare for many of New York City's riders," said Jaqi Cohen, of the Stranghangers Campaign, a coalition of subway riders.

National politics and the Trump administration will continue to play an outsized role in Albany. Cuomo, fresh off a convincing re-election win in November, has offered up New York and his progressive agenda for 2019 as a beacon for the rest of the nation to follow. His soaring rhetoric and decision to deliver his third inaugural address on Ellis Island have done little to squelch speculation about whether he will run for president in 2020.

'It is New York's duty, it is New York's destiny, once again, to bring the light that leads the way through the darkness," the 61-year-old Cuomo said during his inaugural address. "To show the nation the way forward and upward. And we will."

The six-month session is likely to test Cuomo's certitude and the sincerity of lawmakers who now have the chance to enact policies they've spent years talking about. Last year's elections sent a wave of new, liberal lawmakers from New York City to Albany, where they may butt heads with Capitol insiders and more moderate lawmakers from the suburbs and upstate. Cuomo may find himself in the middle, forced to balance the ambitions of liberals with the realities of governing a state with 20 million people and a \$168 billion budget.

And don't forget the Republicans, who promise to do what they can to force the governing party to the bargaining table. That includes GOP senators still smarting from November's defeat.

"Even though Senate Republicans now make up the minority of this chamber," said Sen. John Flanagan, the Republican minority leader, "Our voice on issues important to hardworking middle-class families will be more critical than ever."



Where's the Beef for Gov. Cuomo's L Line Partial Shutdown

Gov. Andrew Cuomo's announcement that the work on the Canarsie Line tunnel scheduled to start in April will be changed lacks critical details.

How much longer will it take for NYC Transit and private contractors to complete work with only overnight and weekend closures than the previously announced 15-month 24/7 project duration? MTA and NYCDOT have already spent millions in planning, environmental review, design and engineering, assuming a 15-month 24/7 shut down. They normally would perform value engineering, a method to look at alternative methods for performing work, which would result in cost savings. This work was performed by experienced engineers and engineering consulting firms. They have firsthand knowledge of how the nation's largest subway system works.

Cuomo's outside experts came from the Columbia and Cornell University world of academia. If their new design idea was used abroad, both the MTA and NYC Transit President Andy Byford (who previously ran transit systems in London and Toronto) would have discovered it under value engineering.

The most cost-effective time to do construction work is when contractors have 24/7 access. The contractor is on site full time, mobilized with a staging area for workers, supplies and debris removal. There is little need for NYC Transit to provide expensive Force Account (track employees) Flagging protection for construction workers. Third Rail power is turned off with no active subway service. Forcing contractors to mobilize workers prior to tunnel access evenings and weekends increases project costs. So does having to stop work prior to resuming of subway service.

Cuomo's proposed new strategy could add millions to the project costs. Having only one tube open overnight weekdays and on weekends provides operational problems. Bidirectional service on one track is risky. Headways between trains could be up to 20 minutes. Rather than wait, many riders will switch to Lyft, Uber, taxi or other car services. Any train with mechanical difficulties in the tunnel could result in chaos. Significant numbers of riders use the L Line evenings, overnight and on weekends.

Work for installation of new elevators and entrances along with other station, track, lighting and power work outside of the tunnels in Manhattan will also require significant additional NYC Transit employee support. It will cost millions more to provide protection for private construction employees.

Several hundred million was previously provided under a Federal Transit Administration Super Storm Sandy Recovery and Resiliency grant in 2016. Washington doesn't pay for the same work twice.

Will the MTA have to pay back Uncle Sam for any previous design and engineering work which may be rendered useless given the "new design"? Will the MTA now have to update FTA's previously approved project Environmental Impact Statement? It is clear that the scope of work, project schedule, completion date and budget will be different from the original grant approval commitments. Has the MTA formally informed FTA of these changes?

The MTA is legally required as part the master grant agreement with FTA to provide monthly financial and milestone progress reports. This includes any changes to scope of work and contract change orders over \$100,000. This is accomplished under the FTA Transit Award Management System known as TRAMS. MTA and NYCDOT provide these reports on many other active capital improvement projects and programs worth over \$12 billion. Has the MTA met with FTA and its own independent engineering oversight consulting firm to provide a presentation on the new "design" changes? Have they explained in detail the impact on scope of work, budget, project implementation milestone schedule and useful life of investments? What has the FTA's response been?

MTA HQ and NYC Transit looked like a deer caught in headlights by Cuomo's announcement. Was it designed to

ingratiate himself with voters rather than serve the long-term interests of riders? When will the MTA HQ, Board members, NYC Transit, NYCDOT managers and engineers formally review and comment on this "new design" and budget impacts?

The same is true for both the MTA and FTA independent oversight engineering consulting firms who were hired to provide detailed oversight. Both prepare monthly reports for their respective employers. What will the impact be on the final project budget?

The winning contractors Judlau and TC Electric \$477 million bid was based on the original scope of work and design proposed by the MTA. This included 24/7 site access to both tunnels with no active subway. This contract will now have to be renegotiated. They now have the basis to request additional reimbursement in the millions. These added costs will be far more than any credits given the contractor for deletion of work as a result of the new design.

Contractors claims for additional financial reimbursement

can be based upon delay claims due to limited site access and change orders for significant design and work scope changes to the original contract. Who will cover costs for materials previously ordered by the contractor in preparation for initiation of work in April that may now not be needed? How will the MTA find additional funding to supplement previously approved federal funding?

Cuomo attempts to portray himself as the second coming of the late President Franklin Roosevelt and master builder Robert Moses. He is not an engineer, transportation expert or daily commuter. Cuomo does excel at photo ops when walking the tracks without wearing either a safety vest or hardhat as required by FRA. I doubt he is ever taken and passed the standard FRA safety training like thousands of MTA employees or has used a MetroCard like millions of commuters.

Queens' 'Boulevard of Death' Collapses Amid Gas Line and Water Main Ruptures

Queens' new "Boulevard of Death" became the Boulevard of Depth on Friday afternoon when a large chunk of street and sidewalk caved in.

The street and sidewalk at Northern Boulevard and 114th Street in East Elmhurst collapsed into a 40-foot-wide crater near a construction site as a gas line exploded and a water main ruptured.

The city said no one was injured in the collapse.

Manhattan-based Perini Group Inc. is developing a 12-story mixed-use building at the site and said they were looking into the cause of the cave-in.

"We're still investigating the reasons for that, we had a stop work order so no one was hurt," assistant project manager Angela Li told the *Eagle*.

Li said the building will feature mostly commercial tenants.

After the collapse Con Edison shut down a gas line along Northern Boulevard. The cave-in occurred a few miles from the site of an equipment malfunction that triggered an explosion and illuminated the sky above Astoria on Dec. 27.

The cave-in sent debris flying through the area, piercing a car roof, shattering the windshield of another vehicle and stopping traffic amid a cloud of dust.

Department of Buildings spokesman Andrew Rudansky said that inspectors found a section of sidewalk and roadway that caved into the construction excavation.


The city issued a stopwork order on Dec. 19 after someone submitted a complaint that the work was causing cracks on the sidewalk and the road.

The site also lacked the required construction plans, inspectors said. The stopwork order was still in effect at the time of the collapse.

The retaining wall of the construction site developed a large hole, which allowed dirt to pour in and caused the street to give way, the FDNY said.

Transportation safety advocates have dubbed Northern Boulevard the "Boulevard of Death" because it accounts for more traffic-collision fatalities than any other street in Queens.







Schumer Warns that NYC Residents Will Soon Feel Pain of Federal Shutdown

The economy of New York is under threat, and everyday New York City residents will soon begin to feel the pain from the partial government shutdown, U.S. Sen. Chuck Schumer said on Sunday.

After meeting with President Donald Trump last week, Schumer said the president told him the shutdown, which Schumer calls "needless," could last months or even years.

"Sometimes, when we talk about the Big Picture — what's happening at the national level with cabinet departments and federal agencies and furloughs and funding levels — you might not realize that this Trump shutdown is affecting all sorts of everyday folks here in New York," Schumer said in a statement.

He listed numerous areas where the shutdown is primed to hit locals where they live. These include subway and bus service, area airports and tax refunds, among others.

The struggling MTA can hold out for four to six more weeks without its monthly \$130-\$170 million in reimbursements from the Federal Transit Administration (FTA), but cuts will likely have to be made after that, Schumer warned. Federal funds are used for track repair work and construction, affecting almost every line.

Travelers flying to their destinations also face risks

as Transportation Security Administration (TSA) agents have been furloughed and are working without pay.

Airport agents are already spread thin, Schumer said. More TSA workers are calling in sick than usual, according to numerous news reports. Hundreds of travelers were stuck on endless lines inside the Delta Airlines terminal at LaGuardia Airport on Sunday afternoon as a handful of airport employees tried to manage the situation, ABC News reported.

More than 41,000 law enforcement and correctional officers and as many as 88 percent of Department of Homeland Security employees are currently working without pay, Schumer said, jeopardizing residents' safety in a variety of ways.

Hitting New Yorkers financially, millions of residents will fail to see their tax refund checks processed if the shutdown continues, Schumer said. In Fiscal Year 2017, 16 million New Yorkers received \$27 billion in tax refunds. Last year, by Feb. 2, the IRS had already paid out \$12.6 billion in refunds to 6 million people. In New York City, 1.5 million people receive Nutrition Supplemental Assistance Program (SNAP) benefits, also known as food stamps, including roughly 13.2 percent of people in Queens, according to CCC New York. Queens Community District 14 in the Rockaways had the highest rate of food stamp use in the

borough, with 23.7 percent of residents using SNAP.

These benefits will be jeopardized if the shutdown goes beyond February, Schumer said. Across the state, an additional 400,000 mothers and families rely on the health care intervention program WIC (Women, Infants and Children). Thousands will also lose rental assistance payments.

Thousands of home loans are on hold, dashing home ownership dreams and local economies. New home loans are not being processed at all, and "loans in queue are at major slowdowns," Schumer said. In 2018, 28,900 FHA loans were made in New York.

The ongoing U.S. Census has also been suspended. Schumer points out that this jeopardizes "the socioeconomic estimates of New York City, which are needed to allocate hundreds of billions of dollars annually in federal assistance to state and local governments for all kinds of things from housing to transportation."

In addition, almost all National Transportation Safety Board (NTSB) employees have been "The NTSB furloughed. sends inspectors to New York any time there is a terrible accident on our roads or railways. Only 27 of their 401 employees are not furloughed," Schumer said. Other cuts impacting

city residents include the

FDA, which safeguards food and medicine, school lunch programs and the Environmental Protection Agency.

Across the U.S., 450,000 people are currently working without pay, and another 380,000 workers are furloughed. Many of these federal workers are in New York — more than 50,000 — and more than 16,000 of them work in departments or agencies that are currently shut down.

Two Appear in Criminal Court for Separate Attacks on Law Enforcement Officers

A Maspeth man and a Jackson Heights woman both appeared in Queens Criminal Court Monday on charges of attacking law enforcement officers at their homes.

Wysk, 55, Edward is charged with assault on a police or peace officer and related assault charges for allegedly grabbing a Department of Environmental Protection (DEP) employee and later injuring two police officers who visited his Maspeth property to issue a work stoppage order on Jan. 23, 2018. He pleaded not guilty at his Queens Supreme Court before Justice Barry Kron on Monday.

Wysk allegedly struck an NYPD Officer in the forehead with an object he threw from his doorway, according to the criminal complaint. The officer was taken to a local hospital where he received five stitches to mend the wound.

When another officer attempted to arrest Wysk, Wysk flailed his arms and forced the officer to slam his arm into a metal scaffolding, according to the criminal complaint. The officer was also treated at a local hospital for bruising and swelling to his arm.

Wysk told officers that he was told the DEP employee was at his home to issue the stop work order and hurried back from a trip to Home Depot, the criminal complaint states. Wysk said he became angry and did not trust the DEP employee's credentials.

Wysk was order to return back to court on April 4. Jackson Heights

resident Elizabeth Grant also returned to court on charges related to an alleged assault on a parole officer on Monday.

In March 2018, Grant

was convicted of 108 counts of animal cruelty for housing sick and malnourished pets in her home. She was sentenced to three years probation and allegedly attacked her probation officer during a routine visit in September 2018.

Grant yelled homophobic slurs at the probation officer, according to the criminal complaint. Grant then pushed the

probation officer down

a short set of stairs and caused "substantial pain," according to the criminal complaint.

Grant was arraigned on a top charge of seconddegree assault on a peace or police officer, fireman or emergency medical services professional and assault as a hate crime in addition to other charges. Her attorney pleaded not guilty on her behalf before Judge Stephanie Zaro on Monday.

LIC Straphanger Wanted For Slugging MTA Worker With Bag

An MTA employee who was attempting to break up a fight between two passengers was seriously injured when an assailant's handbag slapped him in the face, police said.

Police are looking for the passenger who allegedly struck a 48-year-old mo-

torman in the face with her handbag during a verbal dispute. Police said she had three small children with her at the time of the attack.

On Dec. 27, the MTA employee saw two women fighting on the subway platform of the Court Square and Jackson Avenue G line and attempted to intervene. As the employee was

separating the two customers one of them, hit him in the face and caused his tooth to chip. The train conductor suffered a laceration to his lip and was taken to Mount Sinai Hospital-Queens.

The alleged assailant is described as an African-American woman, who is approximately 35-years-old, 5-foot-6 inches, medium

complexion and thin build. She was last seen wearing a dark grey hat, black waistlength jacket, grey tights and red sneakers.

She was accompanied by three small children.



#SurvivingSJU: Students Speak Out About On-Campus Sexual Assaults

On the heels of Lifetime's six-part docuseries "Surviving R. Kelly," students and alumni of St. John's University are taking to social media to share their experiences with on-campus sexual violence and exposing their alleged attackers using the hashtag #SurvivingSJU.

On Jan. 3, the cable television network Lifetime premiered the first two hours of a six-part series anecdotes that features of R&B from survivors singer Robert F. Kelly. The women, including Kelly's Andrea, accused ex-wife the superstar musician of preying on them when they were under the legal age of consent, kidnapping them and committed sexual violence against them.

Nearly two million people watched the first of the three night broadcast, according to Entertainment Weekly, and many of the viewers discussed their thoughts on social media using the hashtags "SurvivingRKelly" and "MuteRKelly."

The next day, the topic #SurvivingSJU emerged on Twitter, coupled with tweets from the user @goneeeee_,

anonymous account an operated by someone who claims to be a St. John's alum. The account has posted photos of several male students and identified them as alleged "sexual predators."

"#SurvivingSJU The individuals I will list have been recognized & discussed as sexual predators and rapists on the campus of St. John's University," @goneeeee_ said on Twitter, adding, "ALSO NO VICTIMS WILL BE MENTIONED FOR SECURITY PURPOSES! these women have suffered enough."

The Eagle requested an interview with @goneeeee_, but the account holder did not immediately respond on Monday. The main tweet was retweeted over 850 times and liked over 1,000 times as of press time.

As of Monday afternoon, @goneeeee_ had posted photographs, names and titles of 14 men, saying that victims of each of the men asked the user to post the information. "ALSO FOR THE PPL MAD AT ME, THESE ARE REPORTS I AM SIMPLY LISTING BECAUSE MOST OF THE VICTIMS CANT! (sic)," @goneeeee_ wrote Sunday. The Twitter user

requested other

victims to send private messages calling out other alleged predators.


The hashtag prompted other current and former students to describe their own negative experiences with university administrators when they attempted to report their own sexual assault cases.

"Time and time again, year after year, it's the Black students of St. John's who are responsible for starting these conversation with the university about race discrimination and sexual assault," said a spokeswoman for Students of Consciousness (SOC).

St. John's Executive Director of University Relations Brian Browne told the Eagle the school has connected with students who have shared their stories of sexual assault online.

"The University's Title IX team has been reaching out to any student who has posted on social media allegations of wrongdoing to advise them of our policies and procedures and to offer support services," Browne said.

Several student organizations, including the Black Student Union, Spectrum and SOC, released statements requesting a "strict revision of the University's Title IX pol-

icies, hiring policies for student and non-student workers and overall campus safety protocols."

"We are tired of statements from Brian Browne brushing these cases under the rug. We are tired of St. John's basketball to be the only thing in the news, we are tired of being discriminated against by public safety," said Kendall Clark, the president of the Black Student Union. "Time's Up St. John's."

Another anonymous Twitter account @vincentianteens, tweeted that St. John's published false sex crime statistics in 2015 and shamed victims for reporting incidents if they were intoxicated. According to the Jamaica Campus crime statistics, one rape was reported in the on-campus residence halls in 2015 and four in 2017.

The account also posted text messages it said depicted a student apologizing to another fellow Johnnie for sexually assaulting her.

"St. John's CANNOT continue to disrespect especially survivors those who are Black, Latino, LGBTQ+, and/or belong to other marginalized communities — by sweeping their cases under the rug,' Spectrum said in a statement.

Browne told the *Eagle* that in 2017, out of all 244 higher education institutions in the state, St. John's was "fully compliant" with New York Education Law Article 129-B — the most aggressive law in the nation to protect students from sexual assault.

Browne said students are encouraged to reach out to their "Sexual violence Outreach, Awareness, and Response" (SOAR) Office and to file reports through the University's website. He said the school grants amnesty to any student who is intoxicated or impaired and

reports sexual assault.

"The very purpose of granting amnesty is to eradicate sexual assault by encouraging students to come forward and make reports without the fear of disciplinary action," Browne said.

Incidents of students publishing names of alleged sexual predators at the St. John's Jamaica campus have gone back as far as the early 2000s when students printed names of male students alleged to have sexually assaulted women on campus. Students copied the lists of names and shared them in dormitories.

On Saturday, SOC released a 20-minute survey to evaluate the effectiveness of campus resources for sexual violence. The organization is encouraging past and present students as well as employees whom have or haven't had a sexual assault incident - to take the survey.

Ex-Mexican Prosecutor Pleads Guilty With El Chapo Nearby in Federal Court

A former state attorney general from Mexico pleaded guilty on Friday to U.S. drug-trafficking charges at a courthouse where an infamous kingpin was also appearing at a conspiracy trial.

Both Edgar Veytia, once chief law enforcement officer in the Pacific coast state of Nayarit, and Joaquin "El Chapo" Guzman are being prosecuted in separate cases in federal

court in Brooklyn.

Shortly after Guzman's ongoing trial wrapped up for the week, Veytia was brought into another courtroom to plead guilty to charges he was bought off to help cartels smuggle cocaine, heroin and methamphetamine to the U.S. from 2013 until the time of his arrest in 2017.

The 48-year-old Veytia admitted that he arranged for drug dealers to avoid arrest and or to be released from custody. He didn't specify which organizations he supported, but it's not believed that Guzman's Sinaloa cartel was one of them.

"I used my official position . to assist drug trafficking organizations," he told the judge.

Veytia faces at least 10 years in prison at sentencing later this year, though the term could be more than double that if the judge follows sentencing guidelines as calculated by prosecutors. According to an indictment, the goverment could also seize

"a sum of approximately \$250 million in United States currency" under forfeiture laws.

According to press reports, Veytia survived a 2011 assassination attempt and promoted himself as a law-and-order candidate when he ran for attorney general.

"Nayarit is not fertile ground for lawbreaking," he once said. "Here, there is no room for organized crime." The case fit a pattern

of allegations of brazen corruption on display at Guzman's trial. Jurors have heard testimony from cooperators claiming multiple instances of various law enforcement officials taking bribes from the Sinaloa cartel to look the other way or demanding a piece of drug profits in the 1990s and 2000s.

Former cartel member Jesus Zambada has testified that he personally made at least \$6 million in hidden payments to the former federal security chief, Genaro Garcia Luna. He said the cash was delivered during two meetings at a restaurant in Mexico between the start of 2005 and the end of 2007, an allegation denied by Luna.

Earner this week. Zambada's nephew Vicente described a meeting in the mid-2000s in which representatives from corrupt Mexican politicians asked if the cartel could help them ship 100 tons (91 metric tons) of cocaine in an oil tanker ship. He said he was arrested before he learned whether the shipment ever occurred.
