New York City Honors Chisholm, Trailblazer for Women in Politics

"If they don't give you a seat at the table, bring a folding chair."

These powerful words came from former U.S. Rep. Shirley Anita Chisholm — and thanks to SheBuiltNYC, Chisholm's presence is expected to forever stand at the entrance of Prospect Park.

In June, Deputy Mayor Alicia Glen and First Lady Chirlane McCray announced a campaign to construct more monuments of historic women across the city. Currently, there are over 90 statutes across the five boroughs and only five are women. All five are located in Manhattan, and the group of statues includes only one woman of color, Harriet Tubman.

Sunnyside Cyclists Under A-Tack

A suspected cyclist saboteur got right to the point in expressing their opposition to new bike lanes, Sunnyside residents say.

Police are investigating allegations of an anti-bike lane bandit who scattered several thumbtacks in Sunnyside bike lanes.

On Thursday, Councilmember Jimmy Van Bramer learned that a family of constituents were almost injured while riding on 43rd Avenue when one of wheels of the bicycle suddenly burst.

"I just want it to be known that whomever did this is obviously in opposition [to] this already existing bike lane and their protest could have seriously injured or even killed me or one of my kids," the angry dad said on social media, according to Van Bramer's Twitter account.

In July, Mayor Bill de Blasio announced that the Department of Transportation would construct parking-protected bike lanes and other safety precautions for pedestrians despite opposition from Community Board No. 2, which voted against the plan.

Construction for the bike lanes began in August and eliminated 116 parking spaces over a span of 2.6 miles.

The father found three thumbtacks in the deflated wheel and several others scattered along 43rd Avenue, Van Bramer said.


Before Van Bramer filed a complaint for the

108th Precinct, he took to Twitter to call out the possible mischievers.

"Let me be clear: the bike lanes are not going away. I support them. And while people may disagree, the increasingly desperate campaign against them is now riling up the worst elements of our community and inspiring criminal vigilantism," Van Bramer said in a statement on Twitter.

If there is an arrest, police could hit the suspect with criminal mischief charges.

"The Commanding Officer of the 108 Precinct is aware of and looking into the allegation that thumb tacks were intentionally placed on the bike lane at 43rd Avenue," said NYPD spokesman Lieutenant John Grimpel.

TRIAL CONTINUES FOR ALLEGED HOLLIS PIMP

Hollis resident Corey Hannah is charged with first-degree kidnapping for allegedly forcing a young woman and a teenager to perform sex work. Hannah appears in TAP C for trial.

Hannah, 34, was indicted in 2017 for allegedly kidnapping a 15-year-old girl and forcing her to have sex for money. Hannah was also indicted on separate charges for allegedly pimping a 21-year-old woman.

"The defendant has now been twice accused of holding women against their will, forcing them to engage in prostitution acts, and turning over all the money that they earned to him," Queens District Attorney Richard Brown said in a statement. "If convicted, the defendant faces a lengthy prison term for sex trafficking – one of the most exploitive and degrading crime against

TRIAL CONTINUES FOR AC INSTALLER

Yuriy Kurk, the owner of a Jamaica Estates HVAC company, is charged with attempted assault for allegedly for allegedly attempting to poison a family with toxic mercury. He appears in court today for the continuation of his trial.

Kruk, a Rego Park resident and the owner of A+HVAC and Kitchen Corporation, laced the family's AC unit with merwcury in retaliation for the family's frequent complaints, Queens County District Attorney Richard Brown said in May.

Each family member later tested positive for mercury poisoning.

"The defendant allegedly had a final fix for the complainers and is alleged to have placed poisonous mercury in the new AC. Exposure to the element could prove fatal over time and did make the residents sick. Fortunately a family member spotted the chemical commonly referred to as quicksilver and alerted police," Brown said in a statement in May.

JUSTICE KRON PRESIDES

CARDI COMES THROUGH DRIPPIN'

Cardi B, whose real name is Belcalis Marlenis Almánzar, is charged with reckless endangerment for her alleged role in a College Point strip club fight. She appears in Queens Criminal Court today.

The hip hop superstar was at Angels Strip Club in College Point on Aug. 29 when a fight broke out around 3 a.m.

The rapper reportedly told companions to throw objects at two of the bartenders, including one who she allegedly believed slept with her husband Offset, a member of the Migos hip hop trio

Cardi was issued a desk appearance ticket in a Flushing police precinct earlier this month.

Outside the precinct in October, Kern said he was "aware of no evidence that she caused anybody any harm," the AP reported. The two strip club employees who were the alleged targets of the attack have hired attorney Joe Tacopina. "The crimes alleged here are beyond senseless and the defendant now faces a lengthy term of incarceration if convicted," Queens District Attorney Richard A. Brown said.

Prosecutors say Harry was parking his Hyundai Sonata around 4:30 a.m. outside an Ozone Park lounge when he allegedly tapped the bumper of the BMW behind him. No damage was done to the BMW, but two men got out of the car anyway and confronted Harry, prosecutors say. Harry allegedly stabbed both men, returned to his car and crashed into a group of six people, including his friend Richardo Chattergoon, who had driven with him to the

City Honors Shirley Chisholm, Trailblazer for Women in Politics

New Yorkers across the city sent SheBuiltNYC more than 2,000 submissions of women, groups of women and events in women's history they believed should be memorialized. The committee narrowed the submissions down to 17 nominations. On Friday, McCray announced that Chisholm was the inaugural selection.

"The trailblazer in American politics ... one of Brooklyn's favorite daughters, who carved the path for herself and specially women of color," said McCray of her "Bajan sister" Chisholm.

Friday also marked Chisholm's 94th birthday. She died at age 80 in 2005.

In January, more than 120 women will represent districts in the House of Representatives. These are "more women than ever," McCray pointed out. "And thanks to Shirley, they won't need a folding chair."

Chisholm was a first generation born-American whose mother immigrated from Barbados, West Indies. She grew up in Bedford-Stuyvesant, where she graduated from Girls High School, which later merged with the boys' school to form Boys and Girls High School — and went on to earn a sociology degree from CUNY's Brooklyn College.

"There were first talks that the statute would be in Manhattan, but we said 'No! Shirley is Brooklyn!"" said an enthusiastic Councilmember Laurie A. Cumbo at the press conference.

Chisholm was the first African-American woman elected to Albany. She was the first woman elected to Congress, where she represented the 12th Congressional District, which covered Lower Manhattan and sections of Brooklyn and Queens. In 1972,

she became the first woman to run for president in the Democratic Party and the first black woman to run in either party.

"There are few New Yorkers more deserving of a monument than the great Shirley Chisholm, and there is no place better to erect it than the entrance to Prospect Park, right in the heart of the Congressional District she represented and championed," said Brooklyn Borough President Eric Adams. "This honor is overdue, as are similar honors for so many of our city's outstanding women, people of color immigrants and members of our LGBTQ+ community."

Chisholm's legacy included financial aid programs for

CUNY students, founding Martin Luther King Jr. Day, daycare funding, helping create Title IV and aiding the formation of the Congressional Black Caucus, McCray said.

The monument is expected to stand at the entrance to Prospect Park on Ocean and Parkside avenues, which will also undergo a \$6.7 million restoration. The sculpture's artist-to-be will be announced 2019, — "Hope-

fully a woman," Deputy Mayor Glen said.

Among those who spoke their praises of the selection were political strategist Donna Brazile, former U.S. Rep. Ed Towns, state Sen. Kevin Parker, former U.S. Rep. Charlie Rangel, Assemblymember Jo Anne Simon, Councilmember Helen Rosenthal, Councilmember Mathieu Eugene and Assemblymember Rodneyse Bichotte.

Police: Pipe Bomb Suspect Accused In Urine-Throwing Incident


Mail pipe-bomb suspect Cesar Sayoc, born in Brooklyn, was accused earlier this year of throwing urine from his van at two women on a moped in an apparent road rage incident in Florida, according to a police report.

The Hollywood Police Department report obtained Friday says Sayoc pulled up near the moped at a traffic light in his white van plastered with pro-President Donald Trump political stickers, began yelling obscenities and tossed two vials of urine at the women, drenching one of them.

The women, 32-year-old Indiana Parra and Rimbow Gomez, 29, told police Sayoc attempted to chase them during the March 16 encounter and possibly tried run them off the road, but they swerved into a warehouse parking lot and he drove on.

One of the women told a police officer that a "maniac Trump supporter threw [urine] on us" and they knew it was urine "by the smell," according to the report.

The women reported the license tag on Sayoc's van, gave a description of both him and the vehicle and gave samples of clothing for DNA testing. Court records, however, show Sayoc was never charged.

Months later, authorities say he began sending out the pipe bombs. He was arrested Oct. 26 in Plantation, Florida, in an auto parts store parking lot with his Sayoc, 56, is accused in New York of mailing 16 improvised explosive devices to Democrats, critics of President Donald Trump and to CNN. He faces life in prison if convicted.

How LocalJournalism Can UpendThe 'Fake News' Narrative

"For the first time media is the least trusted institution globally," Edelman, the global PR and marketing firm concluded in its annual worldwide study on trust in institutions like the media, business and government.

These international findings are in line with recent data coming out of the U.S. A 2016 Gallup poll reported that just 32 percent of Americans trusted the mass media, while an Ipsos poll from summer 2018 found that nearly one-third of Americans agreed that the news media is the "enemy of the people."

How did it come to this?

First, it's important to recognize that our national media, just like our politics, has become highly partisan.

Second, it's necessary to acknowledge that existing media business models fuel this polarization. The drumbeat of an us-versus-them narrative has created what Tim Dixon, co-author of a new study titled "The Hidden Tribes of America," calls a "cartoonish view of the other side."

So what can be done to remedy this state of affairs?

Moving forward, I believe that local journalism — a key focus of my research and journalistic background — can play an important role in turning the tide and tackling this media malaise.

The Trust Factor

Traditionally, the most important function of the Fourth Estate has been seen as watchdog reporting — journalism that holds authority to account.

But, this type of journalism is not exclusive to larger publications. The impact and potential importance of these efforts at a local level can be seen each week in the "Local Matters" newsletter founded by the journalists Joey Cranney, Alexandra Glorioso and Brett Murphy.

It was also recognized last year when Art Cullen of *The Storm Lake Times* won the 2017 Pulitzer Prize in Editorial Writing. The twice-weekly newspaper in Iowa has nine-person staff and covers a town with a population of 10,000.

Yet Cullen beat fellow finalists from bigger papers — the *Houston Chronicle* and *Washington Post* — because he "successfully chal-lenged powerful corporate agricultural interests in Iowa" in "editori-als fueled by tenacious reporting, impressive expertise and engaging writing."

Research shows, however, that audiences don't just want local news outlets to be watchdogs. They want them to be a "good neighbor" too

Local journalists are often the only journalists that most people will ever meet. So they play a significant role in how the wider profession is perceived.

For Caitlyn May, editor of the *Cottage Grove Sentinel* in Oregon, this means "it's essential that journalists leave the office and go out into the community." One way she does this is by holding a monthly, informal, "Meet the Editor" discussion at a local coffee shop.

Other outlets, such as the *Dallas Morning News* with their Curious Texas project, and KUOW Public Radio in Puget Sound, Washington, are partnering with a startup called Hearken to encourage audiences to submit questions they want answered or suggest topics that they want local journalists to cover.

Poynter's 2018 Media Trust Survey identified that trust in local media is considerably higher than for national media. By blending watchdog reporting with community engagement, newsrooms can build on this foundation.

Local News on Shaky Ground

But what happens when local media disappears?

"Our sense of community and our trust in democracy at all levels suffer when journalism is lost or diminished," researchers at the University of North Carolina wrote in a recent report.

"In an age of fake news and divisive politics," they added, "the fate of communities across the country — and of grassroots democracy itself — is linked to the vitality of local journalism."

Indeed, data suggests a correlation between consumption of local news and civic engagement. This reinforces earlier research linking local media consumption and "institutionalized participation."

Put another way, if you consume local news, you're more likely to vote, contact local officials and participate in other forms of civic and democratic engagement.

Although many local newsrooms are going through a period of reinvention and reinvigoration, the sector needs to be on a more even

financial keel if it is to successfully move forward. Outlets have to consistently produce high quality work in order to demonstrate their unique value to communities.

This isn't necessarily easy at a time when there are fewer journalists. Nearly half of all newsroom jobs — more than 20,000 of them — have disappeared in the past 20 years.

Recent research has highlighted the potential impact of these cuts at the local level.

Data produced by Duke University found that "less than half of the news provided by local media outlets is original. Only 17 percent is "truly local" in the sense that it's actually about events that have taken place within the city or town.

Journalism professor and researcher Jesse Holcomb has noted that local news outlets are still struggling to adapt to digital. He likens the internet to "an ill-fitting suit: functional, but not made for them"

Holcomb's analysis of 1,808 local news outlets revealed that less than half offer video content or newsletters. About one-in-10 local news outlets don't even have a website.

"The Expanding News Deserts," a book published in October by journalism professor Penny Muse Abernathy, showed that 171 U.S. counties do not have a local newspaper at all.

Nearly half all counties in the U.S. — 1.449 in total — have only

Nearly half all counties in the U.S. — 1,449 in total — have only one newspaper, and it's usually a weekly. Their research identified a net loss of almost 1,800 local newspapers since 2004.

Diminished resources — which may, in turn, lead to a less ambi-

tious editorial mission — can have a profound impact on the health of our communities and democracy.

Looking Ahead

To succeed, local news providers must be relentlessly local and offer something different if they want people to pay for their product.

They also need to be more visible, embracing opportunities for real life engagement and consciously diversifying the range of people they interview.

According to a 2006 study by journalism professors Don Heider, Maxwell McCombs and Paula Poindexter, this means that investigative and watchdog reporting should appear alongside stories that demonstrate "caring about your community, highlighting interesting people and groups in the community, understanding the local community, and offering solutions to community problems."

That way, local journalists act as a check on those in power and create an informed citizenry, while also fostering a sense of community.

And local journalists don't just help communities make sense of the world around them. They're also a proxy for the wider news industry

It's harder to believe that everything is "fake news" when the journalist you meet at back-to-school night, your kid's football practice, or in the local coffee shop is not just your neighbor, but someone who is also reporting on important local stories that you know to be true.



New State-of-the-Art Academy Honors Court Officers Who Died On 9/11

New York court officers are getting a new training center, built to honor those who made the ultimate sacrifice on September 11, 2001.

Chief Judge Janet DiFiore and Chief Administrative Judge Lawrence K. Marks will join court and local leaders today at 11 a.m. to unveil a new, state-of-the-art training facility dedicated to the memories of three heroic court officers who lost their lives in the World Trade Center rescue efforts on 9/11.

The Captain William H.

Thompson, Sergeant Thomas Jurgens and Sergeant Mitchel Wallace Court Officers Academy, located at 541 St. Johns Place in Crown Heights, will soon serve as the primary training facility for roughly 4,000 uniformed court officers in New York State. Family members of the three fallen officers will attend at the inauguration.

Thompson was 57 when he was killed while attempting to rescue victims who had been trapped immediately following the World Trade Center attacks. For 27 years, Thompson had worked at

the New York State Office of Court Administration and also served as an instructor at the Court Officers Academy.

Jurgens, a U.S. Army veteran, was 27 when he was also killed attempting to rescue victims of the World Trade Center attacks. He had been employed by the New York State Office of Court Administration for three years.

Wallace, who was 34, had been assigned to the Supreme Court for just three months. He had worked at the New York State Office of Court Administration for years before September 11.

Union Bust(le): Ahead of Purchase, Mic Purges Unionized Newsroom

Another union-busting media company has bulldozed a New York City newsroom.

On Thursday, the news and entertainment website Mic fired its entire editorial staff hours before Bustle Media Group, which owns the online women's magazine Bustle, announced it had purchased

Bustle bought Mic for about \$5 million, the Wall Street Journal reported. It's a significantly lower price than the \$59.5 million that Mic received from venture capital between March 2013 and June of this year.

Mic retained just one editorial staff member: cofounder and editor-at-large Jake Horowitz, the HuffPost reported.

In a statement, the Mic Union said a tearful CEO Chris Altchek announced the layoffs to the staff without mentioning the Bustle sale.

"While many of us have experienced layoffs and upheavals in the past at other media companies, this level of deception from Mic cofounders Chris Altchek and Jake Horowitz represents a new low in corporate mendacity," the union said in a statement on Twitter. "While we were mourning the loss of our newsroom, that shock

and disillusionment quickly turned to anger as it soon became apparent that we were lied to, once again, by Mic management."

In a vague memo to staff, Mic publisher Cory Haik said media was an "unsettled"

"The macro forces at play are all going through their own states of unrest," Haik wrote in the memo, obtained by various news outlets. "If anyone tells you they have it figured out, a special plan to save us all, or that it's all due to a singular fault, know that is categorically false. Like the truth, it is indeed complicated."

Haik, who resigned Thursday, did not mention union-busting as a one of those "macro forces."

February, In Mic's editorial staff voted to join the NewsGuild of New York, which represents nearly 3,000 media professionals in and around New York City, according the NewsGuild. Mic had previously laid off 25 workers in August 2017.

In 2017, Gothamist/ DNAinfo's billionaire owner Joe Ricketts shut down the two New York City websites and fired the staff after they had voted to unionize.

Other New York Citybased news organization have also cut their staffs suddenly in recent months. In June 2017, HuffPo laid off dozens of reporters and editors. And in July, Tronc, which owns the Daily News, laid off about half

of the *News*' editorial staff. Bustle and its new subsidiary Mic did not respond to requests for comment.



Einstein's Religious Views on **Display at 2 New York Auctions**

Did Albert Einstein believe in God? The famous physicist was constantly questioned about his religious beliefs during his lifetime.

Two Einstein artifacts being auctioned in New York could contain clues to the spiritual beliefs of the 20th century's bestknown thinker.

Sotheby's auctioned a Bible Friday in which Einstein inscribed in 1932: "This book is

Christie's, meanwhile, is auctioning a 1954 letter tomorrow in which Einstein declared, "The word God is for me nothing more than the expression and product of human weaknesses, the Bible a collection of honorable but still primitive legends."

The Bible being auctioned was a gift from Einstein and his wife, Elsa, to Harriet Hamilton, an employee of the couple. The leatherette-bound English-language Bible is inscribed in German by Einstein and is expected to sell for \$200,000 to \$300,000, said Cassandra Hatton, a specialist in books and manuscripts at

Hatton said it's hard to reconcile the description of the Bible as a source of "living wisdom" with the harsher view of religion that Einstein expressed

"It's possible that this gift was given to someone who was quite religious," Hatton said. She speculated that Einstein might have penned the inscription "out of respect for her religion."

The letter Christie's is selling was written the year before Einstein's 1955 death and was addressed to Eric Gutkind, a philosopher who had written a book about Jewish spirituality and the pursuit of science.

Einstein wrote in German that while he "gladly" belonged to the Jewish people, he believed that the Jewish religion "like all other religions is an incarnation of the most childish superstitions.

As Isaacson recounts in the book, everyone from clerics to schoolchildren quizzed Einstein about his religious views. A New York rabbi sent a telegram demanding, "Do you believe in God? Stop. Answer paid. 50 words." Einstein answered, "I believe in Spinoza's God, who reveals himself in the lawful harmony of all that exists, but not in a God who concerns himself

with the fate and the doings of mankind."

Isaacson said it's not surprising that Einstein's faith or lack thereof sparked so much interest.

"There was a delightful be-

lief that a genius who could fathom the laws of the universe could give us the answer to timeless questions such as about the existence of God," Isaacson said. "And many people were hungering for a way to reconcile science and religion. They were hoping that he would say, 'Yes, there is a God. You can quit worrying about it now.' But his beliefs were not that simple."



ACS Launches Simulator Aimed at Training Child Welfare Workers

For child welfare specialists, it's just like the real deal.

The first-ever series of simulated training sites for child welfare workers will soon provide "on the job" training for Child Protective Specialists on the front lines in Queens and Manhattan, the Administration For Children's

Services (ACS) revealed last week.

Mock apartments, a courtroom and a detention center — just a few of the settings often encountered by child welfare workers throughout their duties — will be on display at the simulation centers, located at Union Hall in Jamaica and Harlem. Together, the centers will see the training of more

than 11,000 staff members employed in the child welfare sector.

"Our Child Protective Specialists are the first responders for New York City's childrenwhen they may be in danger, and they need the same state-of-the-art training experiences that other first responders have access to," said Commissioner David A. Hansell.

City Council Passes Jailhouse Voting Rights Bill

It's your right to vote — and now individuals released from the city's jails have a right to know, thanks to the passage of a new council bill.

The City Council voted 41-2 in favor of passing Intro. 514 on Wednesday, requiring the Department of Correction (DOC) to inform every person released from a city jail of their voting rights.

"An overwhelming number of individuals released from DOC custody have the right to vote, yet the majority are unaware of that right," said Councilmember Rory Lancman, the bill sponsor, after the vote. "We know that rebuilding societal ties reduces recidivism for justice-involved people and my legislation is another step we must take to re-enfranchise those communities."

More specifically, the bill mandates that DOC provide every person released from a city jail with written notice outlining the voting rights

of formerly incarcerated individuals in New York State as well as details on voter eligibility.

"For too long, the incarceration of our clients has stripped them of their right to vote resulting in the disenfranchisement of entire communities, regardless of their status they are entitled to express their opinion and deserve to be heard just like everyone else," said Anthony Posada, Supervising Attorney with the Community Justice

With the Community Justice
Unit at The Legal Aid Society.
"The City must do a
better job at re-enfranchising

individuals and provide them better access to voting. The Legal Aid Society applauds the Council for passing this important legislation, which is a good first step to begin correcting this injustice," Posada added.

The new legislation also requires that the DOC offer every formerly incarcerated person a voter registration form.

Councilmember Joseph C. Borelli and Councilmember Steven Matteo, both of Staten Island, were the only members who voted against the bill

Each simulation center will be able to accommodate up to 250 trainees at a time, with mobile furniture and training sets allowing for the accomodation of "diverse needs."

"Our new simulation centers will give future child welfare workers a realistic sense of what it's like to conduct home visits during investigations, interview parents and children, and testify in court," said Hansell. "Robust and realistic training

is critical for ensuring that children across New York City are safe, which is why we've expanded training over the last year and why we're building these new sites."

Inspiration for the simulation sites, according to Hansell, comes in part from other first responders, such as the FDNY and NYPD, which already have access to simulated training sites.

At the police academy, for example, prospective police

officers go through scenariobased training that takes them through "mock-environment training rooms," including a precinct station house, multifamily residence, grocery store, restaurant, park, court room, bank, a subway car and subway platform.

Since 2017, newly-hired CPS agents have participated in training at the police academy to reinforce their investigative skills, according to ACS.

Drug Lord Who Changed His **Face Testifies Against 'El Chapo'**

A former Colombian drug lord known for an extreme plastic-surgery makeover meant to hide his identity testified Thursday at a U.S. trial about his lucrative drugtrafficking alliance with notorious Mexican counterpart Joaquin "El Chapo" Guzman.

Asked about his distorted facial features, Juan Carlos Ramirez Abadia explained that he had undergone at least three surgeries that altered "my jawbone, my cheekbones, my eyes, my mouth, my ears, my nose."

Ramirez Abadia told the jury that he bribed authorities in Colombia to destroy any criminal records naming him to better stay ahead of the law while he was overseeing the Norte del Valle cartel.

In a 20-year career, the witness estimated, he

smuggled 400,000 kilos of cocaine, ordered 150 killings and amassed a fortune so large that he forfeited \$1 billion after his arrest in Brazil in 2007.

Ramirez Abadia was extradited to the United States, where he pleaded guilty to murder and drug charges and agreed to become a government witness in major narcotics prosecutions like Guzman's. He was the third former drug dealer to testify so far at the trial in federal court in Brooklyn, where Guzman has pleaded not guilty to conspiracy and other charges.

On Thursday, Ramirez Abadia described a meeting at a hotel in Mexico in the early 1990s where he struck a deal with Guzman whereby the Colombian cartel would fly his cocaine into Mexico for the Sinaloa cartel to smuggle it into Los Angeles and New York City, the witness said.

When Guzman asked for

the purest product possible, Ramirez Abadia was happy to oblige because he wanted "a reputation for myself for my cocaine being so good," he said.

Guzman also demanded a bigger cut of the proceeds than other Mexican kingpins because his network was so efficient at getting it across the border.

"I'm a lot faster. You'll see," he recalled Guzman bragging.

After Ramirez Abadia relocated to Brazil and redid his face, he looked so different that drug investigators were forced to use voice recognition technology to make the positive identification needed for a search warrant, his lawyer said after his capture. He was found in a luxurious home with a gym, sauna, swimming pool and nearly \$1 million in stashed cash.

Though she live in Queens, Bruno said she has never performed at a venue in her home borough because few allow performers under 21.

"I haven't found a place in Queens to perform," she said. "A lot of Queens natives have to go into the city to find new spaces to perform."

Woodside Man Finds His Niche With Afghan Food Truck

First-generation Afghan-American Mohibullah Rahmati, who was born in Woodside, Queens, and still lives there, has found a niche in the city's food truck world – selling traditional Afghan food.

Working from a former mail truck in Chelsea, Manhattan, and from a stand at Smorgasburg in Fort Greene, Rahmati's specialty is mantu, a type of beef dumping, according to *The New York Times*. The dumplings are served with "garlicky yogurt, oddly punchy and soothing at once, and a rubble of split peas in a rich korma of tomato paste and onions caramelized to a near burn."

Among the other dishes he serves, the *Times* said, are kofta, or ground meat and onions bound by chickpea flour; chicken thighs cooked in their own fat; and potatoes and peas. Each dish comes with a sweet mixture of carrots and raisins as well as a spicier mixture of red onions and tomatoes.

The name of Rahmati's truck, Nansense, is a play on "naan," the Afghan word for bread, the Times said. The bread itself comes from New Kabul Bakery in College Point, Queens, owned by Rahmati's two older brothers.


