### LIRR IMPOSES SANTACON ALCOHOL BAN

In order to maintain safe and orderly travel during this weekend's SantaCon event, alcohol will not be permitted on Long Island Rail Road and Metro-North trains and stations from noon on Saturday, Dec. 8, through noon on Sunday, Dec. 9, according to the MTA. MTA police officers will be on duty at Penn Station, Grand Central Terminal and stations throughout Queens, as well as on trains to enforce the restriction. Police will confiscate alcoholic beverages and issue summonses carrying fines or imprisonment. Violators may also be subject to removal from the train or station by police. This ban on alcohol during SantaCon has been in effect for the past five years.

A decorated educator was disciplined by the NYPD on Friday evening for allegedly driving drunk and disobeying traffic laws after drinking one glass of wine, according to court documents. ### DOC Fails to Uphold Young Adult Housing Directive

With a January deadline approaching, the Department of Correction (DOC) has failed to uphold oversight directives to house young adults in separate facilities or units, even as the DOC successfully implemented new "Raise the Age" standards for adolescents.

Beginning in 2015 — three years before the DOC moved children off Rikers and into a juvenile facility in the Bronx — the DOC began changing the way it detained and provided services to young adults between the ages of 18 and 21. The Board of Correction (BOC) directed the DOC to house young adults "separate and apart" from adults over age 21.

Over the past year, however, the DOC has backed off the young adult plan by reintroducing young adults aged 19, 20 and 21 back into the general population, according to DOC statistics

A training facility for court officers across the state opened in Crown Heights on Monday — a deal that was nine years in the making.

The corner of St. John's Place and Classon Avenue — once the location of a catholic school where nuns lived — has transformed 60,000 square feet of classrooms, auditorium and gym into The Captain William H. Thompson, Sergeant Thomas Jurgens and Sergeant Mitchel Wallace Court Officers Academy.

The facility was named in honor of the three court officers killed in the line of duty during the terror attacks on Sept. 11, 2011 at The World Trade Center. The academy will be the primary training center for more than 4,000 of the Unified Court System's Court Officers which man all the courthouses in the state.

### Cardi Court: Bronx Rapper A No-Show At Queens Arraignment

She didn't come through drippin' this time. Cardi B, the acclaimed Bronx rapper whose real name is Belcalis Marlenis Almánzar, was nowhere to be found on Monday at her scheduled arraignment in Queens Criminal Court on charges related to her role in a College Point strip club brawl.

After a previous adjournment in October, hip-hop's rising star was scheduled to be arraigned for reckless endangerment charges on Dec. 3, but her lawyer, Jeff Kern, requested

another adjournment to Friday, Dec. 7. Kern alerted the judge that Cardi had a previous, "outof-town commitment" that was "entertainmentrelated.'

"I apologize to the court — my client is not here today," Kern told Queens Criminal Court Judge Sean Dunn. "As you probably know, she's a fairly notable hip-hop artist," Kern added.

Cardi was originally scheduled to appear in court on Oct. 29, but the case was adjourned until yesterday, a fact noted by Assistant District Attorney Brian Nicolosi.

"We've given six additional weeks and the defendant is still not here," said Nicolosi, who asked the court to issue Cardi a bench warrant.

Though Judge Dunn said Cardi's absence was "not acceptable," he agreed to adjourn the case until Friday.

Cardi was at Angels Strip Club in College Point at around 3 a.m. on Aug. 29 when the fight began. She allegedly told two of her companions to throw objects at two of the bartenders, including one who she allegedly believed slept with her husband Offset, a member of the Migos hip-hop trio.

Cardi, 26, was issued a desk appearance ticket in a Flushing police precinct in October.

Outside the precinct in October, Kern said he was "aware of no evidence that she caused anybody any harm," the AP previously reported.

The two strip club employees who were

### ST. ALBANS BLOODS BUST NETS SIX ALLEGED **GANG MEMBERS**

Brandon Bledman and Kaminski Gauthier are charged with second-degree conspiracy for allegedly conspiring to kill rivals. Bledman and Gauthier appear in K5 for a conference.

Bledman and Gauthier, along with four other alleged members of the Bloods gang, were indicted on multiple charges of conspiracy to kill their rivals, Queens County District Attorney Richard A. Brown announced in a joint statement with NYPD Commissioner James O'Neill in September.

Brown said the six men, who ranged in age from 22 to 29, belong to the Wood City Gang, a Bloods subset, based in St. Albans and Springfield Gardens.

'The defendants in this case are accused of shooting at two rival gang members — creating havoc in our neighborhoods and threatening the lives and safety of innocent bystanders," Brown said in a statement. "The defendants are variously accused of turning our communities into danger zones with senseless gun violence. The individuals are charged with acting in concert with one or more co-defendants to

Mixed Martial Arts fighter Sergio Da Silva is charged with robbing an Astoria Citibank in 2017, allegedly making off around \$50,000. Da Silva appears in K23 for a conference.

Da Silva allegedly jumped over the counter of the bank into the teller area wearing a ski mask and threatened to shoot people in the incident, TMZ reported in 2017.



### Naming of Long-Awaited Court Officer Training Facility Reignites Controversy

Officers will go through a four-month basic training that includes instruction in criminal, civil, family and constitutional law as well as arrest procedures. The academy also provides training with weapons including baton, pepper spray and firearms. Officers will learn proper use of force, first aid, CPR, crowd control and other skills deemed necessary by the courts.

The state's Chief Judge Janet DiFiore said the new facility will play a "critical role" in safeguarding the courts and will aim to be the "public face of the court system."

"Even with the best training, we are asked to make instantaneous decisions [regarding] things that occur — that's what Harry, Mitch and Tom did over 17 years ago [on 9/11]," said Chief Michael Magliano with the Department of Public Safety.

"There is no greater call in life [than] when a man or woman lays down his or her life in the service of others. The names inscribed on this plaque never wanted the spotlight and always put the welfare [of others] above themselves."

"They must be highly prepared to handle a wide range of situations, including life-threatening emergencies that require courage and decisiveness," said Judge DiFiore.

"We now have a customized facility that will enable our team of top-notch instructors to pursue and instill excellence in our court officers through a broad range of training activities."

Across the city for the last two years, courtrooms — in Civil, Family, Housing, Criminal and Supreme courts — were unable to open because of short staffing of court officers. Yesterday, while the ceremony was underway, 11 courtrooms were closed due to short staffing, according to Dennis Quirk, the New York State Court Officers Association president.

Quirk, referring to Court Officers Francis Carroll and Albert Gelb, whose names were not included in the building's final title.

"The other men who were named, they do deserve it — but those two other men too deserve

During the past two years, more than 60 court officers suffered injuries while on the job either by inmates or members of the public.

Quirk, along with Patrick Cullen, State Supreme Court Officers Association president, organized several protests at each courthouse in Brooklyn, Queens, Manhattan and the Bronx to bring awareness to the ongoing issue.

"By next spring, along with the opening of a new Court Officers Academy, three new classes of recruits — totaling an additional 380 officers — will be assigned to the courts," Lucian Chalfen, a spokesman for the Office of Court Administration told the *Eagle* last month.

Quirk has spearheaded the facility's opening since the disgraced Gov. Eliot Spitzer and former Chief Judge Jonathan Lippman were in office but declined to attend yesterday's event.

"The academy was supposed to be named for three court officers killed during 9/11 and two others killed in the line of duty. They changed that and put two photos in the building," said

to be on that building. This was a total disgrace to their families. So no, I did not attend."

Carroll was the first court officer killed in the line of duty during a robbery in progress in Midtown in 1973. Gelb was killed in 1976 in front of his home on 109th Street in Queens, days before he was slated to testify in a mob-related trial.

Quirk said that though the facility is open, it's still unfinished because the dormitory portion of the building — where the nuns were housed — was not renovated and is a part of the lease.

"What takes nine years to renovate the building? If a court officer lives far away now, they have to get put up in hotels that the state will have to pay for instead of having a dormitory on the site," said a disappointed Quirk.

Chalfen said the facilities' two buildings are completed, with a third reserved for expansion opportunities. He added that there are plans underway for a memorial wall where all slain court officers will be remembered.

A Pitch and Plea: Revamp the GOP

The fall of state Sen. Marty Golden (R-Brooklyn), U.S. Rep Dan Donovan (R-Staten Island) should put the Brooklyn GOP on notice: there is a need for younger, more diverse candidates that can connect with the community and provide unique solutions to problems plaguing our urban neighborhoods.

It's no secret that New York City is a liberal bastion that has made it difficult for Republicans and the Republican Party to find a niche audience.

However, the fault lies just as much with the local party apparatus as it does the tribalist politics of the five boroughs.

Brooklyn's GOP has so far failed to reflect the people it's trying to represent.

I agreed with U.S. Rep. Mia Love (R-Utah) when she said, "Republicans never take minority communities into their home and citizens into their homes and into their hearts. They stay with Democrats and bureaucrats in Washington because they do take them home — or at least make them feel like they have a home."

We need a message that sets us apart, that moves us beyond the demagoguery of President Donald Trump and provides solutions to problems plaguing all New Yorkers when it comes to housing, education, criminal justice and health care.

If that means adopting liberal ideas or compromising in order to codify a kinder, more gentle society then that is exactly what we should do — and we can do it without sacrificing our core principles of fiscal probity, free enterprise, personal freedom, individual responsibility and self-government.

According to the New York State Board of Elections, there are 3.5 million registered Democrats and 522,540 registered Republicans in New York City.

Time to face reality.

The GOP has a lot to offer, but we need to be consistent.

We have an obligation to stand up for everyday New Yorkers who are struggling to make it, who yearn to start a family or are striving to raise one. If we're about the working class, then our statutes and our systems need to sing it from the rafters. We can't get caught up in the quagmire of self-aggrandizement or appeasing special interests

If we're for rooting out corruption, then let's root out corruption. No more corporate PAC money. No more union money. Only individuals.

And yes, we can have a great message, but messaging means nothing without the proper messengers.

Running young, qualified, well-vetted candidates that reflect the local community is our best way of our communicating our ideas to a new audience. Communities outside of Manhattan, Cobble Hill, Queens and anywhere along the L line have been ignored and require more forceful, more vociferous representation at the state level.

Ultimately, it's not about right versus left or Democrat versus Republican. It's about practical versus fantastical. Issues like homelessness, housing and income inequality have skyrocketed in New York. The status quo of corporate welfare is not working.




It's time for both parties to genuinely and unequivocally advocate for the working class and those struggling to make it, or else we will all get left behind.

# Review: John McPhee Is at His Brilliant Best in 'The Patch'

Eighty-seven and 33. That's the age of John McPhee and the number of books he's written, counting his latest, "The Patch."

One could forgive McPhee if he spent all his time in a canoe with a fishing rod when not enjoying the company of his 10 grandchildren. But McPhee is a writer, arguably America's greatest nonfiction essayist ever, and if he can find a practical way to do it, one senses he'll pen something from his coffin.

If he does, count me as one of the millions who will read it.

"The Patch" is a slim book divided in two. The first part is a collection of five essays he dubs "The Sporting Scene" — stories about fishing, football, golf, lacrosse and bears that all appeared over the years in *The New Yorker*.

The second, which McPhee likens to an "album quilt" he fastidiously took the time to assemble from previously written work, consists of various fragments of things from over the years that haven't yet been bound up in a book.

The standout in part one is the title essay that first ran in 2010, which begins as a tribute to chain pickerel, the "lone ambush hunter" that can "accelerate like a bullet" when prey swims past. By the end, this fish tale is really about fatherhood as McPhee's dad suffers a stroke in a Baltimore County hospital.

The second part, the "album quilt," features writing about everything from Oscar Hammerstein to McPhee's first drink when he was 10 years old. ("One thing it wasn't was unpleasant.") All are rich with detail and

McPhee's direct style and trademark sense of humor. "He is predictably unpredictable," writes McPhee in a remembrance of the late tennis star Arthur Ashe.


And in an ode to satirist Felicia Lamport, commenting on where writers write: "Lamport tops them all with Elihu Linot, who always wrote on the backs of women, starting at the neck and working down. His editor eloped with a manuscript. There was no carbon."

McPhee's curiosity is legendary and evident throughout this volume. There's a two-page tribute to actress Sophia Loren ("Her hands are huge. Her forehead is low. Her mouth is too large. And, mamma mia, she is absolutely gorgeous."), a profile of Bill Wagner, the chief taster at Hershey's, empowered to "send ninety thousand pounds on its

way to be eaten" and a laughout-loud list of Hollywood stars who have stage names ("Boris Karloff could not have frightened a soul as William Henry Pratt").

Fans will recognize many of the subjects from the books McPhee has published — Bill Bradley, geology, Alaska, to name a few — but they don't read as outtakes and are as fresh as when he first encountered them. Some context before each patch of the quilt would have been welcome, just a line or two detailing when and why he wrote it.

But McPhee, famous for the unique ways he structures his creative process, has decided to present it as a quilt that can be enjoyed as individual squares or an entire blanket, and really, who are we to quibble with such a Master Seamstress?

Yousafzai is a cofounder and board member of Malala Fund. She began her campaign for education at age 11, when she anonymously blogged for BBC Urdu about life under the Taliban in Pakistan's Swat Valley. Inspired by her father's activism, Yousafzai soon began advocating publicly for girls' education, attracting international media attention and awards.

At age 15, she was at-

tacked by the Taliban for speaking out. Yousafzai recovered in the United Kingdom and continued her fight for girls. In 2013, she founded Malala Fund with her father Ziauddin. A year later, Yousafzai received the Nobel Peace Prize in recognition of her efforts to see every girl complete 12 years of free, safe and quality education. She is currently a student at Oxford University, pursuing a degree in philosophy, politics and economics.

Callimachi has been called "arguably the best reporter on the most important beat in the world." A three-time Pulitzer Prize finalist, she covers the Islamic State for The New York Times. Born in Communist Romania, Callimachi and her family fled the country when she was five years old, becoming refugees in Switzerland before immigrating to America. After years of covering city hall and park district meetings at a small newspaper in Illinois, she joined The Associated Press and was posted to Senegal in 2006. She became the news agency's West Africa bureau chief in 2011. In 2014, she was hired by The New York Times, covering first Al-Qaeda and later ISIS around the world.

Besides being a Pulitzer finalist in 2009, 2014 and 2016,

she has won the George Polk Award, the Michael Kelly Award for the Fearless Pursuit and Expression of Truth, and the Sigma Delta Chi Award. She is also the only journalist in the 75-year-history of the Overseas Press Club to win both of the club's top two reporting awards in the same year.

### DOC Fails to Uphold Young Adult Housing Directive

and statements.

On Nov. 30, there were 540 young adults between ages 19 and 21 detained in 13 jails across the city, according to DOC census data. About 26 percent — 159 young adults are detained at the Robert N. Davoren Complex, the Rikers Island jail that used to house adolescents and now houses mostly 18-year-olds. The majority of detained 18-yearolds are housed separately to easily meet standards developed by a 2015 federal consent decree to ensure more humane treatment of 16- to 18-year-olds.

The DOC's latest deadline to develop and implement a plan for the hundreds of other young adults in general population facilities is Jan. 9, 2019, but the DOC has specifically asked to change the young adult housing rule.

"The DOC doesn't have the same commitment to young people anymore and that's a real shame because what they were doing was working," said Bryanne Hamill a retired New York Family Court Judge and a member of the BOC. "What the DOC is saying and what they are doing are two different things.'

The BOC first announced the young adult plan directive in September 2015. In January 2016, the BOC voted, in good faith, to give the DOC a sixmonth extension to gradually move young adults between 18 and 21 into facilities separate from older adults. It was the first of several variances that

enabled the DOC to gradually implement the plan without falling out of compliance.

Then-DOC Commissioner Joseph Ponte embraced the measure and the DOC began moving young adults into separate housing at the George Motchan Detention Center (GMDC).

"We strongly believe that the 18- to 21-year-old brain is about the same" as a juvenile, Ponte told The Associated Press in Sept. 2015. "I'm very confident that this model will work well for us in New

By January 2018, however, the DOC announced it would close the GMDC in September and move young adults back into facilities with adults of all

Though the DOC had already began moving young adults from separate facilities and units and placing them back into the general population, the closure announcement was a clear indication of DOC's rejection of the BOC directive, Hamill

said.

"That to me was a concrete action that demonstrated the commissioner was not committed to the young adult plan," she said. "Things were going very well. They were on track and they were making progress, but there was a management failure that resulted in some violence that seemed to be the impetus to slow down and reverse.'

After young attacked a correction officer at the GMDC, the DOC overcorrected and began moving young adults back into general population, Hamill said. The DOC contends that the young adult plan obstructed it from transferring violent or rival young adults into different facilities.

Despite that seeming rejection, the BOC issued another waiver in July to extend the date by which the DOC had to implement the requirement that inmates aged 19-21 be housed separately and apart from inmates over the age of

At the BOC's Oct. 9 public meeting, their Executive Director Martha King said that, as of Oct. 1, the DOC housed 36 percent of young adults in young adult housing, according to the meeting minutes — down from 60 to 70 percent in past years, Hamill said.

The recent census numbers masked the disparity between the number of 18-year-olds in separate housing and the number of 19-, 20- and 21-year-olds housed "separate and apart" from older adults. While 93 percent of 18-yearolds were in separate housing, just 27 percent of 19- to 21-year-olds were separated as of Oct. 1, King said, according to the meeting minutes posted on the city website.

The BOC has repeatedly issued variances to enable the DOC to catch up to the minimum standard. The most recent variance, issued Oct. 9, allows the DOC to house young adults ages 19-21 with people over the age of 21 for three months until Jan. 9, 2019. In the meantime, the DOC is required to provide a monthly census of which housing units and jails house 18 to 21 year olds and "provide the board with a monthly progress report on its implementation of the Young Adult Plan."

The BOC addressed a previous variance made in July during that October meeting.

"Because the Board remains committed to the vision of the young adult plan, it voted in July 2018 to grant a three-month variance instead of the requested six months, to assess DOC's progress towards its stated goal to have 60 percent of young adults housed in young adult housing at RNDC, and to review a new plan to house 'substantially all' young adults in young adult housing," King said, according to the meeting minutes. "The department has sought and the board has repeatedly granted a variance on this requirement for the past few years.

Hamill said that the DOC began screening young adults out of the young adult facilities by asking them when they entered jail if they wanted to go to school, to which they have a legal right through age 21. Most young adults who declined to attend school in iail were transferred to general population adult facilities, she said.

"The best shot is working with young people who have chance to turn their lives around with early intervention," Hamill said.

A growing number of municipalities have implemented their own young adult jails and units to address the mental, emotional and social development of offenders and defendants between 18 and 25. South Carolina, Connecticut and Massachusetts' Middlesex County are among the states and counties that have partnered with the Institute for Justice to develop

young adult jails. "As every parent knows, and neuroscience now shows, young adults in this age group are still developing in important ways," the Vera Institute for Justice wrote in a blog post on its website. "They are forming their identity, learning to better manage their emotions and impulses, and preparing for their life goals. But prison presents an unnatural social context which creates challenges for young adults to achieve these key developmental milestones. Instead, young adults in prison too often are left sitting in their cells with little to no opportunity to learn from past experiences, cope with underlying trauma, engage

in meaningful accountability, and prepare for their future."

Legal Aid's Adolescent Intervention and Diversion Team Director Nancy Ginsburg said the evolving approach to addressing young adults in the criminal justice system reflects a movement common in other fields.

"This is a larger conversation about how young adults are managed throughout all systems ... I think it's bigger than the criminal justice system, Ginsburg said. "Is it appropriate to send an 18or 19-year-old to an adult shelter? Arguably not. There's a lot of conversation in the medical field about whether or not mental health provisions and pediatrics should be moved to that age.'

The DOC has implemented BOC reforms, including eliminating the use of solitary confinement for young adults, and said it is working to house young adult inmates and detainees in ageappropriate housing according to classification and risk assessments.

In a statement, DOC Commissioner Cynthia Brann said she disagrees with the "one-size-fits-all" approach to detaining young people in separate facilities or

"We agree with the board that there is a great benefit to providing services based on a population's specific needs, and that's crucial to our approach to housing," Brann said. "18-21 year-olds do not all have the same needs so we can't address them all the same way."

"Keeping young adults separated from all other populations can be beneficial in many cases. We remain committed to doing this as best as we can," Brann continued. "But we've also seen positive results when mixing them with older individuals who have similar experiences or can provide a mentoring relationship. This is especially beneficial for young adults with mental health designations and those reluctant to participate in programming when only surrounded by their peers.'

Hendricks Walls was last seen leaving the Calvary Baptist Church Senior Housing facility located on Claude Avenue after midnight on Nov. 29.


Walls, 85, was reported missing the following day and his body was found 30 miles away off the Great South Bay in Lindenhurst, L.I, police said.

# It's Real: 1st New Concourse

A new concourse with 18 gates opened this weekend at LaGuardia Airport, part of a broader plan to modernize the dilapidated and oft-mocked facility.

The new gates are part of

LaGuardia's Terminal B and opened to passengers Saturday. The concourse also includes additional dining and shopping for those traveling through the airport.



## Bronx Duo Faces 25 Years In Prison For Astoria Bodega Robbery

Two Bronx Bodega bandits madea mistake crossing the RFK Bridge. prosecutors say.

Two robbers from the Bronx are facing up to 25 years in prison after being charged for their part in holding up an Astoria grocery store at gunpoint last month, Queens District Attorney Richard A. Brown announced on Friday.

Hannibal Ali, 55 and Luis Zayas, 25, were part of a fourman robbery team that held up Bonoful Supermarket, located on 36th Avenue and 29th Street on Nov. 17 at around 8:20 p.m. Some of the robbers who were spotted wearing masks and look-alike police shields around their necks shot at the store owner's teen chase them

As the robbers burst into the store, one of the suspects walked around the store's counter and grabbed a bag with cash inside. The same suspect also opened the cash register, took all the money out and dropped it into a black bag, prosecutors said.

The robbers then exited the store and ran to a getaway van allegedly driven by Zayas. When the store owner's brother, who was in the bodega at the time of the robbery, ran after the vehicle, he heard a loud pop and realized he had been shot in the left leg, prosecutors said.

"A young man quashed down any fear to pursue the gun-toting robbers into the night. For that, he is a hero," said District Attorney Brown. in the leg and will thankfully survive the injury. Two of the four suspects have now been apprehended and will answer for this brazen robbery. This kind of violence and thievery is unacceptable and will not be tolerated."

Both Ali and Zayas are charged with first- and seconddegree robbery and seconddegree criminal possession of a weapon in two separate complaints. Queens Criminal Court Judge Toni Cimino set bail at \$100,000 for Ali and \$25,000 bond or \$10,000 cash for Zayas. Both men were ordered to return to court on

Two of the robbers have yet to be apprehended by police. An investigation is still

### Mailbox Fishermen May Catch Seven Years In Prison For Richmond Hill, Forest Hills Thefts

It was the catch of the day for cops from the 102nd Precinct.

Two men believed to be behind a series of mailbox fishings — a scheme in which a makeshift rod is lowered into a mailbox for the purpose of stealing mailed checks, cash or other items of value were arrested and charged, Queens District Attorney Richard A. Brown announced on Friday.

Alvaro Martinez, 28 and Luis Velazquez, 22, of Manhattan and the Bronx respectively, were arraigned on Friday after investigators say the duo pilfered multiple mailboxes throughout Richmond Hill and Forest Hills.

"Paying bills or sending a gift check to a loved one is now a real hazard if dropped in a mailbox thanks to these growing "fishing" schemes. The defendants in this case were allegedly caught red handed with their makeshift rods in the belly of blue mailboxes," Brown said.

"These two individuals allegedly sought to enrich themselves by taking advantage of others' long-held trust that once you place your mail in the box, it'll get to the intended recipient," Brown continued. "The pair nabbed by police will now face prison time for their "fishing" expedition."

The string of thefts began at around 4:30 a.m. on Oct. 29, when Velazquez was allegedly caught on surveillance video standing in front of a blue U.S. Postal Service mailbox at 64th Avenue and 108th Street in Forest Hills, along with a second box about a block

Velazquez can be seen on the video inserting an object into the mailboxes and pulling it out again along with pieces of mail, according to court

On Nov. 17, at around 4 a.m., Martinez was observed on video surveillance standing in front of a blue mailbox at 62nd Drive and 108th Street, also in Forest Hills. Martinez could allegedly be seen on the video placing something inside the mailbox and then retrieving that item along with mail attached.

In a third incident, which occurred around 3:50 a.m. on Nov. 28 both Velazquez and Martinez were spotted at the intersection of Lefferts Boulevard and Jamaica Avenue in Richmond Hill. Martinez was allegedly

seen with his hands near the opening slot of a mailbox while Velazquez leaned on the box.

As a NYPD detective approached, both men moved away from the mailbox, but a shoestring was left dangling from the slot, prosecutors said.

A member of the U.S. Postal Police later opened the box and found the shoestring attached to a juice bottle covered with glue.

Velazquez later admitted that a nearby vehicle belonged to him and inside that car police recovered dozens of pieces of both unopened and opened mail along with mouse and rat glue traps, which are commonly slathered on an object used to "fish" mail from boxes, according to Brown. One of the recovered envelopes contained a check for \$4,000.

Martinez and Velazquez were charged with charged with third-degree burglary, firstdegree criminal tampering, third-degree possession of stolen property, first-degree identity theft and possession of burglar's tools. They are ordered to return to court on Dec. 13 and face up to seven years in prison if

## Long Island City Principal Busted For DUI

A decorated educator was disciplined by the NYPD on Friday evening for allegedly driving drunk and disobeying traffic laws after drinking one glass of wine, according to court documents.

Principal Louis Pavone was busted near 24th Street and 24th Avenue in Ditmars-Steinway for allegedly driving while intoxicated, driving while impaired and operating a motor vehicle above the state's legal limit of .08 percent.

Pavone, 59, was driving on the wrong side of the street in a 2015 black Lexus allegedly in an attempt to pass a car that was in front of him.

When police pulled over the veteran educator, Pavone had bloodshot watery eyes, slurred speech, a strong odor of an alcoholic beverage on his breath and was unsteady on his feet when he exited the car, according to the criminal

complaint.

Pavone was arrested and a breathalyzer was administered at the precinct that read .098 percent, according to the criminal complaint.

"I was operating the vehicle, I had one glass of red wine," Pavone allegedly told the police at the 112th Precinct, according to court documents.

Pavone has been the principal of P.S./I.S. 78Q a Pre-K to eighth grade school on Center Boulevard in Long Island City since 2006. The allegedly intoxicated school leader is expected to earn over \$160,000 by the end of the year, according to public records.

Queens Criminal Court Judge Toko Serita released Pavone on his own recognizance and ordered him back to court on Jan. 29.

It's unclear if Pavone will be in attendance at school this

"The well-being of our school communities is our

top priority and we take this allegation seriously. We are reviewing the matter, and will take any necessary follow up action," said Doug Cohen, a spokesman for the Department of Education.

In 2012, Pavone was named a Cahn Fellow, a program for well-received principals through Teachers College at Columbia University and "gets high marks from teachers," according to InsideSchools.

Pavone received the After School Hero Award from the Cheering for Children Foundation for his work in after-school programs. He was honored by the United Federation of Teachers, by former Mayor Michael Bloomberg and in 2015 was presented with a proclamation from Jimmy Van Bramer, then the Majority Leader of the City Council, according to The New York Academy of Public Education website.

## Hammer-Wielding Spa Customer Breaks Piggy Bank

A frustrated spa customer is wanted by police for threatening workers with a hammer when they refused to give him a happy ending after his massage and for stealing money from the business' piggy bank, police said.

The man received spa treatment from a 55-year-old female employee on Nov. 29 at the Tao Spa Bodywork and when she was finished, he requested for "a favor in exchange for money," a law enforcement source told the *Eagle*.

When the employee of the Flushing spa refused, the customer demanded a refund for all his services. After the employee denied the man a second time, he allegedly dragged the woman out of the room and into the waiting area where he punched her in the

During the attack, the employee was able to flee to the back of the building as three other female employees confronted the man.

The man allegedly grabbed a 56-year-old female employee by the throat, shoved her against the wall and threatened the other two female employees with a hammer.

The business' surveillance cameras captured a majority of the incident.

The desperate employees tried to stop the hammer-wielding man by offering \$40 in cash with hopes he would leave the Flushing establishment, police said.

The man took the money

the employee offered and used the hammer to smash open a piggy bank on the counter. Before leaving the scene on 40th Road, the man took some of the coins and cash from the shattered piggy bank, police said

Emergency responders treated the women at the scene.

The suspect is described as a male Hispanic, between 20 to 30 years old, 5-foot 6, 160 pounds, with black hair. He was last seen wearing a gray hooded coat, dark colored jeans, tan work boots and he had on a light colored

backpack.



## Amazon Has Role in Overhauling Transit, Making Queens More Equitable, Katz Says

Count Queens Borough President Melinda Katz among the local elected officials who see a prime opportunity to extract some concessions from Amazon — the borough's newest resident — especially in the wake of large-scale opposition from city council members and community activists to the trove of state and city subsidies gifted to the online retail giant.

Monday, announced that Amazon which is receiving roughly \$3 billion to set up shop in Long Island City while bypassing the city's land use review process — has a duty to invest in its new home. In the same statement, Katz announced several proposals to overhaul expand Queens' and transportation system.

"Amazon's pick of Long Island City is a game-changer for Queens," Katz said. "That said, the community's significant concerns about capacity, equity and alreadystrained infrastructure needs are certainly valid, especially given the substantial tax incentives offered to Amazon."

Katz, who has long advocated for the arrival of Amazon, specifically said that Amazon should help fund the proposed Brooklyn-Queens Connector (BQX) — her office repeatedly deemed in a press release the Queens-Brooklyn Connector (QBX).

"Asubstantial and meaningful investment by Amazon that helps ensure the feasibility of [the BQX] would be a fair investment into its new home and a welcome opportunity for

a good corporate neighbor to directly benefit the existing, impacted communities of Western Queens," Katz said. "The company and the public sector must work together to make investments in necessary transit improvements that will support Queens residents."

In the same announcement, Katz called for the BQX to include a free transfer to MTA subways and buses and adopt the "Fair Fares" model to better integrate the project into the existing transit system and to make it affordable for lower-income New Yorkers.

The BQX, which will

receive substantial funding from real estate developers, has been criticized as a project designed for wealthier waterfront residents and a vehicle for further gentrification and displacement.

She also said the city should develop more municipal parking lots and that MTA should rehab two underused Long Island Railroad stations to reduce congestion.

"Finally, to help alleviate overcrowding on our subway lines, the 'Long Island City' and 'Hunterspoint Avenue' LIRR stations should become full-time

enhanced service," she said.

Katz announced the proposals as the City Council prepares for a series of hearings about Amazon's arrival. The corporation, one of the wealthiest in the world, was able to avoid the city's Uniform Land Use Review Process (ULURP) because the project is being shepherded by the state under a controversial urban renewal program known as the General Project Plan. The plan enables the state to steer projects in "blighted"

Appearing on the "Brian Lehrer Show" on WNYC on Friday, Mayor Bill de Blasio said he would hold Amazon accountable to fund vital infrastructure improvements and suspend their incentives. De Blasio has championed Amazon's pledge to add thousands of new jobs to Long Island City and has downplayed concerns about displacement.

"My job is to hold them to every element of what's been agreed to so far," de Blasio said. "Public space that they'll make available, promenade, a public school building, training programs for folks in public housing, recruitment efforts, all of that."

"Remember if at any point they do not keep to any element of the deal then all of the incentives are suspended," he continued. "So job one is make sure that they keep their end of the deal. The second is to go farther, to look for opportunities to get Amazon to do more for the people of Queens, and the people of New York City. More job opportunities, more training, any other community improvements we can make. I think there's a lot they could do for the community. Our job is to push them to go farther."

Before her election borough president in 2012, Katz, a Forest Hills native, served as city councilmember from 2002 to 2009 and a state assemblymember representing District in Queens from 1994 to 1999.

Between 2009 and 2012, Katz worked for the law firm Greenberg Traurig. She earned her law degree from St. John's University School

According to Campaign Finance Board, Katz raised more than \$417,550 from 323 donors between Jan. 13 and July 12. She had \$341,477 remaining as of the July 12 report.

Councilmember Rory Lancman and retired Judge Gregory Lasak, a former assistant district attorney. have already announced their candidacies.

### Lender and Service Alert: Waiver of Defenses Is Ruled Valid Again

Too many of our alerts bemoan the difficult path of foreclosures in New York. albeit for good reason: this is a tough state for such actions and the pitfalls seem endless. We advise of these entanglements as an aid to avoiding them – if possible. So, it is pleasing indeed when we can report on a positive case which supports the foreclosure process.

One such recent example reaffirmed the potency of a mortgage provision whereby a borrower waives defenses and counterclaims. [Rugg v. O'Donnell, 159 A.D.3d 1606, 73 N.Y.S.3d 853 (4th Dept. 2018)]. It will be immediately

meaningful.

Foreclosing lenders recognize that the desperation of the situation encourages borrowers to interpose any number of defenses, whether apparently legitimate or not. It is not anecdotal to observe that many a defaulting borrower's answer can contain up to 25 affirmative defenses, or more. Is it possible that the foreclosing party has committed so many gaffes? The answer is obvious — no — but this is the way the game is played.

Many a well-written mortgage, however, will have a provision whereby a borrower waives the right to interpose defenses, set-offs

not mean that a foreclosing lender is excused from notices required by statute or that the statute of limitations is waived, among others. But it does mean that fanciful claims can be stricken and rejected by the court for the very reason that the borrower waived the right to have such things heard.

An immediate thought, not surprisingly, is whether public policy supports such a waiver. The answer is that it does pleasing for lenders - and case law is consistent in taking this position. So it is always welcome when the point is litigated and the courts recite anew that indeed, a borrower efficaciously

defenses and counterclaims. The circumstances in the new cited case were slightly different, but still very enlightening. Here, a CEMA contained the waiver of defenses provision and a defaulting borrower decided that its answer had been insufficient and thereupon moved to amend that answer

to present fraud claims against the lender. However, because the waiver of defenses provision was valid and enforceable, that rendered the counterclaim for fraud to be of no merit. In turn, where a proposed cause of action is without merit, that

alone is a basis to deny any

amendment of a pleading. So,

the borrower's defense was rejected and could not appear in the case.
