Judge Margulis Leaves Mark On Court Through Mental Health and Courtroom Tech

During his nearly seven years serving in Queens Supreme Court, Criminal Term, Justice Ira Margulis has left his mark on the court.

Margulis, who was first elected to the civil court bench in 2003 before becoming a Supreme Court justice, purchased brighter, energy-efficient lighting for his courtroom, introduced new chairs for jurors and staff and set up a projector and 100-inch screen to ensure that jurors, attorneys and staff can view important video evidence and materials.

That courtroom TLC reflects Margulis' commitment to the criminal justice system in his native borough. So does his work presiding over cases involving defendants with mental illness, a role that has given Margulis important perspective on how the justice system addresses mental health.

A federally-funded program that helps Queensborough Community College students move on to four-year colleges so they can begin to pursue careers in the biomedical field has gotten a big boost with the renewal of a \$1.6 million grant, City University of New York (CUNY) officials announced on Monday.

The grant from the National Institutes of Health (NIH) will allow Queensborough Community College to extend the NIH's Bridges to the Baccalaureate program for another five years.

"When I started college, I had no idea what biomedical science meant. But in retrospect the Bridges program was a perfect fit for me," said Vanessa Almonte, a Queensborough graduate who is now a Ph.D. candidate in cardiovascular

Trial Begins in 'Old-Fashioned' Stick-Up Case

A Queens man heading home early one Saturday morning in November 2016 had a feeling he was being followed. He was right.

Ronald Horton testified that he froze when he realized two men were about to rob him steps from his St. Albans home.

"I wasn't frightened," Horton told Assistant District Attorney Barry Frankenstein on redirect examination Tuesday evening. "If it was one person, I would have gotten out of it, but with a second person, I couldn't."

Horton identified Frederick Holloway and Perry Pointer to the jurors in Queens Supreme Court as the suspected robbers who stole his car keys, Blackberry phone, credit cards, Rolex and cash before fleeing in a getaway car.

After Horton parked his car and was walking to his home near 205th Street and 116th Avenue,

Long Island City resident Keith Richard is charged with second-degree attempted murder for allegedly running over a teenager who egged his car on Halloween 2017. Richard appears in TAPA for trial

Richard, 50, allegedly crushed a 17-year-old with his minivan and fractured the boy's skull and spine.

"That's what happens," Richard said, according to the criminal complaint.

ALLEGED KISSENA PARK PREDATOR ON TRIAL

Charles Tobin is charged with predatory sexual assault for allegedly raping two women at knifepoint in Kissena Corridor Park in 2017. Tobin appears in TAP B for a conference.

Prosecutors say the first assault occurred when Tobin demanded money from a 32-year-old woman in the park at knifepoint then pulled her into a trail in a wooded area and allegedly raped her.

Tobin also allegedly forced a 17-year-old girl into the woods with a knife and made her perform a sex act. Both victims were treated at a local hospital. Police caught Tobin after they saw a man fitting the suspect's descriptions in the park again.

allegedly shooting and killing a 15-year-old boy as he exited a bus in Far Rockaway in February. Donaldson and Edmond appear in TAP C for a conference.

Victim Youssef Soliman was shot twice, once in the hand and once in the torso, and died from the gunshot wounds When police arrived on scene, Soliman was conscious but unresponsive, according to Queens Patch. He died soon after.

"This senseless act of gun violence — which has taken the life of a young boy— will not be tolerated in Queens County and my office will continue to work tirelessly to combat the proliferation of guns in this county," Queens District Attorney Richard A. Brown said in a statement.

The shooting is believed to be gang related, the *Daily News* reported.

JUSTICE HOLDER PRESIDES

GLENDALE CREEP CHARGED WITH PIMPING TEEN NIECE

Eddy Florence is charged with first-degree kidnapping for allegedly forcing two teenage girls to perform sex work. He appears in K10 for a hearing.

Florence, a Glendale resident, allegedly forced his 13-year-old niece to perform sex work, forced her to take drugs and even had sex with her.

In December 2017, the Queens District Attorney's office said Florence, 32, asked his niece to perform sex work beginning in November of that year. He then posted her photos on websites used for the purpose of soliciting sex workers.

Florence also allegedly brought his niece and another girl to a Staten Island hotel to perform sex work.

JUSTICE VALLONE PRESIDES

ALLEGED CHILD PORN TRADER CHARGED

Brooklyn resident Steven Gallardo was charged with promoting a sexual performance by a child for allegedly possessing child pornography featuring children under the age of 12—including some children as young as 1. Gallardo appears in AP6 for a conference.

Gallardo, 39, allegedly traded sexual images of children with a Queens man over a cell phone messaging app.

In one conversation, prosecutors said, the men shared images of infants engaging in sex acts. In another conversation, the Queens man asked Gallardo to trade images and Gallardo sent the other man a photo of a young child engaging in a sex act with an adult man, prosecutors said.

"While the internet is a valuable learning tool, it unfortunately is also a doorway for deviant sexual predators who gather to share vile and disturbing videos and photographs of young children being sexually abused," said District Attorney Richard A. Brown in a statement. "It is important for the public to remember that the images and videos being exchanged are, for all intents and purposes, footage of crime

scenes as they depict real children being cruelly victimized both physically and emotionally. The victims will have to carry the painful memory of that which occurred to them for the rest of their lives."

JUSTICE MORRIS PRESIDES

ANIMAL HOARDER RETURNS TO COURT

Elizabeth Grant is charged with attempted assault on a peace or police officer for allegedly pushing a parole officer and violating a court-ordered ban against owning pets. Grant appears in AP6 for a return date.

Grant, a resident of Jackson Heights, was caught housing 67 sick and neglected animals, including 55 cats, inside a home filled with urine and feces, Jackson Heights Patch reported in 2016. She was convicted for animal cruelty earlier this year.

Grant avoided jail time for animal abuse when a judge demanded she seek counseling and steer clear of pets for at least ten years. In August, however, Grant allegedly assaulted a probation officer who stopped by her home and found even more mistreated animals.

"You can't come in here, you don't have a warrant, my case is on appeal, You can't do this to me," Grant reportedly shouted. She also directed racist slurs at the probation officer.

The probation officer took pictures as evidence. When the officer was leaving, Grant allegedly attempted to push her down the stairs. The incident led to a raid of the home, where police found seven dogs, one cat, two guinea pigs, two rabbits, two turtles and two Beta fish — all of which were allegedly mistreated.

JUSTICE MORRIS PRESIDES

NIGHTCLUB KILLERS RETURN FOR SENTENCING

Neon Osouna, 38, and his cousin Brandon Williams, 36, were both found guilty of second degree murder last month and return to TAP D for sentencing.

Osouna and Williams shot and killed Donald Reed, 35, outside a bodega after Reed spent the night partying at Osouna's club, the Smoke Shop on Dec. 25, 2015. Williams worked as a bouncer at the Smoke Shop.

Prosecutors said Reed's friends left the club without him around 6:30 a.m. and he caught up with them a few minutes later at a nearby bodega. Osouna and Williams followed Reed from the club before all three men began firing guns on Guy Brewer Boulevard.

Reed was shot four times and died.

"This is yet another example of the senseless gun violence that has plagued our community. A 35-year-old father was gunned down in the early morning hours in a residential neighborhood. The defendants in this case were tried before a jury of their peers and found guilty. Both men now face a lengthy term of incarceration for this deadly shooting," District Attorney Richard A. Brown said in a statement.

Osouna and Williams both face 25 years to life in prison.

NYC SETS MINIMUM WAGE FOR FOR HIRE VEHICLE DRIVERS

The NYC Taxi and Limousine Commission (TLC) announced the passage of a new minimum wage for for-hire vehicle (FHV) drivers who work for ride-hailing app companies on Tuesday. The TLC said the new measure will increase wages for more than 80,000 drivers. "Convenience costs, and going forward, that cost will no longer be borne by the driver," said TLC Chair Meera Joshi. "Today's rules will raise driver earnings by on average \$10,000 a year and require companies to be completely transparent on how they calculate pay and car leasing costs."

GLENDALE MAN FOUND DEAD UNDER L MAY HAVE FALLEN

A Glendale resident who was found dead under the L train trestle near the border of East New York and Brownsville may have fallen off the tracks, police say. Jared Adams, 32, was found dead on the street near the intersection of Blake and Van Sinderen Avenues at around 5:30 a.m. Monday, police said. The site is located between the Sutter Avenue and Livonia Avenue L train stations. Police said Adams was unconscious and unresponsive when they arrived. He was pronounced dead at Brookdale Medical Center. Read more on page 16.

Brooklyn and Queens CUNYs Seek to Lessen Student Hardship with Single Stop

When you're a student facing hardship, every bit of help counts.

That's the message behind the City University of New York's "Single Stop" initiative,

a program providing crucial financial resources at CUNY's seven community colleges and one four-year college, including three in Brooklyn and Queens.

"The demands of college can overwhelm a student facing hardships outside the classroom," said CUNY's Interim Chancellor Vita C. Rabinowitz. "The campus-based Single Stop makes it easier for students to get a range of non-academic help so they can stay focused on their studies. This initiative is another way that CUNY works to help students overcome obstacles to academic success and degree completion."

Through Single Stop, CUNY students can learn how to obtain nutrition benefits, health insurance, legal and financial services and tax preparation assistance—

typically overwhelming and tedious processes.

From 2009 through 2017, Single Stop and its partner programs have connected 107,569 families and individuals with \$274,113,613 in benefits, tax refunds and supportive ser-

to CUNY, including at Kingsborough Community College in Manhattan Beach, LaGuardia Community College in Long Island City and Queensborough Community College in Bayside.

Single Stop also helps to streamline the benefit eligibility

vices CUNY-wide, according

streamline the benefit eligibility process by way of a short question-and-answer session with on-campus counselors. Students can also find out their eligibility status through an online screener.

The following services are offered through Single Stop, free of charge:

- Benefit screening for Supplemental Nutrition Assistance Program; temporary
- Assistance for Needy Families; and Women, Infants and Children
 - · Available food pantries
 - Financial counseling
 - Legal counseling
 - Tax assistance
 - Health care enrollment

CUNY's Brooklyn and Queens colleges have long been a site of vertical economic mobility, thanks in part to the Single Stop program. In October 2018, LaGuardia ranked among the top 1 percent of colleges out of 604 two-year colleges nationwide "with the greatest success in lifting the poorest students into jobs where they earn good wages and create better lives for themselves and their families," according to a Stanford University analysis.

Brooklyn's New York City College of Technology and Brooklyn College also ranked among the top 15 in the list, at No. 5 and No. 7, respectively.

'El Chapo' Consort Opens Up About Cartels' Ruthlessness

A key government witness at the U.S. trial of notorious Mexican drug lord Joaquin "El Chapo" Guzman spelled out the bloodshed and other cold realities of international drug-trafficking Tuesday without expressing regret or making excuses.

Former Colombian kingpin Juan Carlos Ramirez Abadia was asked on cross-examination by a lawyer for Guzman whether he ordered scores of murders, whether he kept a ledger that showed how much hit men were paid, and whether he repeatedly lied to and bribed Colombian authorities with tens of millions of dollars to stay in business.

Among the matter-of-fact answers he gave through a Spanish interpreter: "Totally correct." "Obviously." "At the time, of course I lied." "That's how it was, sir."

The testimony by Ramirez

Abadia, known for radically altering his face through plastic surgery, came during the third week of the trial in federal court in Brooklyn. Guzman's lawyers say the witness is part of a crew of low-life cooperators who are framing their client to get breaks in their own drug-trafficking cases.

Ramirez Abadia testified how his Norte del Valle cartel used a fleet of planes and boats to ship tons of cocaine to Mexico, where the Sinaloa cartel was tasked with smuggling it into the United States under the direction of Guzman and others. Prosecutors say the massive amounts of drugs and cash flowing back and forth across the U.S. border in the 1990s and early 2000s were documented in ledgers that looked like mundane business records.


Seeking to drive home the human toll of the violent drug trade, defense attorney William Purpura got Ramirez Adadia to confirm the ledgers also showed the expenses for murders for hire — \$45,000 to have three people killed and \$338,776 in another instance because, he said, so many hit men were involved.

The dead included a top lieutenant rubbed out in prison after his arrest merely because, Ramirez Adadia suggested, "he knew a lot about my organization." Another time, the witness said he lured a mutinous cartel member to a meeting where the victim and his entourage were slaughtered in a gangland-style ambush, their bodies then loaded in pickup trucks for disposal.

He also acknowledged lower-level operatives in the New York City area were knocked off under suspicion of stealing or snitching, including a woman in Fort Lee, N.J. Her husband and son also perished in the process, according to the defense.

Once he learned he had been

U.S. Attorney's Office for the Southern District of New York via $\ensuremath{\mathsf{AP}}$

indicted in the U.S., Ramirez Adadia fled to Brazil, where he made his face look like a theatrical mask with implants and injections. He also used disguises for photos on fake identification cards with various aliases in a bid to hide his identity, which ultimately failed.

On Tuesday, he was asked

about the meaning of "Chupeta," the nickname cited in the U.S. indictment filed against him.

"Un dulce," he said. "Candy."

New York's Private Waste Industry Has Been The Second-Chance Program The City Doesn't Have

Before I became incarcerated, I had a well-paying job managing a chain of restaurants. I drove the company car, and I wore a suit to work every day. When I was released from prison following a brief sentence, I had to start all over again — but with the stigma of a criminal record

After many unreturned phone calls and rejections, my cousin found me a job in private waste collection. Thanks to the industry, I've been able to rebuild my life and support my son through college. But the de Blasio administration's waste zones proposal will most likely force me to start all over again for a third time.

Along the way, I've learned that I'm not alone; New York's private carting industry employs hundreds of people like me with limited education and a criminal record, giving us the second chance to work hard, regain our dignity and support ourselves and our families.

From Chicago to Atlanta and Boston, cities across the country have developed Second Chance Programs to employ formerly incarcerated individuals like me in government jobs. Chicago hires ex-offenders for entry-level positions in their transit and sanitation departments, while Atlanta employs ex-offenders in their watershed department. Boston extends paid internships in city government to their ex-offenders and at-risk youth, and those opportunities often turn into full-time employment. Boston's Operation Exit — a three-week intensive training program that prepares ex-offenders for apprenticeships with unions — is just another way the city provides ex-offenders with a pathway to a career.

Although New York also has a transitional employment program, its scope simply pales in comparison. The city only gives short-term, transitional jobs to inmates leaving city jails after serving a sentence of one year or less — which applies to an incredibly small percentage of those who have dealt with the criminal justice system. And if we were to try to find jobs with the city on our own, we would be out of luck: even sanitation employees must pass a background check, because the city is not required to follow its own Fair Chance Act.

For a city that claims to have such progressive values, the way it treats the formerly incarcerated says otherwise. Where the city has failed to give men like me a second chance, the private hauling industry helped me — and hundreds of other men like me across the city — get back on my feet.

Now, the de Blasio administration's waste zones proposal will jeopardize our futures. By limiting competition, many private waste haulers will either merge or go out of business, costing many men and women our jobs, as well as our second chances.

Waste management is a dangerous job, and we need to raise safety standards in both the public and private sectors. But the waste zones plan will do too much harm to vulnerable families across the city.


Councilmember Robert Cornegy introduced legislation in June to give the Business Integrity Commission more authority to regulate the private waste industry. Under his plan, BIC could regulate the industry's safety standards, without costing anyone their jobs — especially for the hundreds of formerly incarcerated men who have relied on the industry for the support they didn't receive from their city.

City Council should enact Councilmember Cornegy's Intro 996 if it's interested in really helping formerly incarcerated men like me. We made good on our second chance, and we're not so sure we'll be able to get another.



Judge Margulis Leaves Mark On Court Through Mental Health And Courtroom Tech

"I've been doing this now for four years or so and I have seen a major improvement in what Rikers Island does in keeping people on their medications," Margulis said. "Now they take more care in making sure [defendants] stay on their medications [and] I'm getting a lot more people who are staying fit when they come to see me."

Margulis said he, his staff and other judges have visited mental health facilities, including the Kirby Forensic Psychiatric Center on Ward's Island, to better understand mental health treatment.

Margulis grew up in Forest
Hills and graduated from
Forest Hills High School
before attending CUNY
Queens College. He earned
his law degree from Hofstra
and joined the Queens County
District Attorney's office,
where he served for six years
under Nicholas Ferraro and
John Santucci.

He next worked as a court attorney and as chief of the Bureau of Labor Law for the state comptroller. His career path was a departure from the family business.

Growing up, Margulis'

father owned a women's clothing store on Queens Boulevard.

Margulis, meanwhile, delivered meat for a butcher — a job he held throughout his time at Queens College.

He said he decided to pursue law after taking a class with former State Assemblymember and State Comptroller Alan Hevesi. Through that class, Margulis interned with Judge Seymour

Boyers and developed a passion for law.

"He was very popular and he was the administrative judge in Queens," Margulis said. "I interned with him while going to school at night and I saw how he worked, how he treated the litigants and once I was involved with that, it got me interested in the law."

Margulis' own experiences reflect the diversity of

Queens. His mother grew up in Brooklyn and his father emigrated from Argentina. His grandmother, and her pet parakeet, both spoke Yiddish.

Margulis married a public school teacher and raised two children, one a dentistry chief at a Bronx hospital and the other, a speech pathologist who teaches at Queens Vocational and Technical School. He has two granddaughters.

While not presiding over murder cases — like a recent trial that featured nine days of jury deliberations before ending in a mistrial — Margulis satisfies his tech interests by flying his drone and geocaching, a GPS-based scavenger hunt. There are hidden items in Forest Park and around the courthouse, he said.

Though he turns 70 in two years, Margulis said he has no interest in slowing down at the mandatory retirement age. Instead, he will continue to evolve on the bench and in the tech sector.

"I was in the AV club in junior high school," he said. "I have an interest in technology ... more and more cases involved audio or video or both."

Most NYers Welcome Amazon But Are Split on Subsidies, Poll Says

The results of a Quinnipiac University poll released Wednesday are generating controversy among Amazon opponents.

Quinnipiac surveyed 1,075 New York City voters about whether they approve of "Amazon locating one of its new headquarters in Long Island City in Queens" and reported that 57 percent of NYC voters say they approve.

About 60 percent of Queens voters who participated in the poll said they approved of Amazon's arrival, Quinnipiac reported.

"While New Yorkers give the thumbs up to Amazon moving one of its new headquarters to Long Island City, they are divided over the sizeable carrot offered to the online retail giant," said Quinnipiac University polling analyst Mary Snow. "They are united, however, in their view that New York City should have more of a say about Amazon's plans."

Voters were nearly even split in their responses to city and state subsidies totaling roughly \$3 billion. About 46 percent of people polled said they support the incentives while 44 percent say they opposed.

About 55 percent of Queens voters said they supported the incentives while 39 percent said they opposed.

Abou 31 percent of New York City voters who oppose Amazon's arrival say housing is their biggest concern. About 25 percent said they are most concerned about transportation, 20 percent cite "quality of life" and 19 percent say they are concerned about three issues.

More than three-quarters of

More than three-quarters of respondents say New York City should be more involved in the plan to bring Amazon to Long Island City.

In a joint statement, Councilmember Jimmy Van Bramer and State Sen. Michael Gianaris, who represent the area picked by Amazon, said those results demonstrates that, despite the approval response, residents have major issues with the deal.

"New Yorkers are making clear they agree that too much inequality exists in our communities and giving billions of taxpayer dollars to trillion dollar corporations makes things worse, not better," Van Bramer and Gianaris said. "It is also clear that the more people learn about the deal, the less they like it."

Retail, Wholesale and Department Store Union (RWDSU) President Stuart Applebaum criticized the poll. The RWDSU has criticized Amazon's record on workers' rights since the Amazon deal was announced.


"This Quinnipiac poll means nothing. The reality is that opposition to this terrible Amazon HQ2 deal continues to grow by leaps and bounds," Applebaum said. "This poll does nothing to change the fact that Amazon's current HQ2 deal for New York City is fundamentally bad for workers and communities."

tanite who teams up with an enigmatic private investigator to search for her friend's daughter, who has gone missing in the unknown and unforgiving terrain of



California's high desert.

Soon after quitting her job at The New York Times in the wake of the 2016 presidential election, Phoebe Siegler learns that Arabella, her best friend's Leonard Cohen-loving daughter, has gone missing from her small Oregon university.

With a job going nowhere and still reeling from the election, Phoebe takes up the search. A stray credit card charge leads her to Southern California's Inland Empire, where she is put in contact with Charles Heist, whom she immediately nicknames The Feral Detective.

A laconic, strange private eye with no shortages of secrets and a surprisingly docile opossum in his desk drawer, Heist has a reputation for finding people who don't want to be found. Heist and Phoebe traverse the stunning desert just east of Los Angeles, navigating enclaves of hippies and vagabonds who dwell in abandoned developments and shabby encampments.

They learn that these outcasts exist in groups — the Rabbits and the Bears - and that Arabella is likely caught in the middle of a decadeslong, some-



We Asked Artificial Intelligence to Analyze a Graphic Novel and Found Both Limits and New Insights

With one spouse studying the evolution of artificial and nat-ural intelligence and the other re-searching the language, culture and history of Germany, imag-ine the discussions at our table. experience the stereotypical clash in views be-tween the based approach of natural science and the more qualitative approach of the humanities, where what matters most is how people feel something, or how they experience or interpret it.

We decided to take a break from that pattern, to see how much each approach could help the other. Specifically, we wanted to see if aspects of artificial intelligence could turn up new ways to interpret a nonfiction graphic novel about the Holocaust. We ended up finding that some AI technologies are not yet advanced and robust enough to deliver useful insights – but simpler methods resulted in quantifiable measurements that showed a new opportunity for interpretation.

Choosing a Text

There is plenty of research available that analyzes large bodies of text, so we chose something more complex for our AI analysis: Reinhard Kleist's "The Boxer," a graphic novel based on the true story of how Hertzko "Harry" Haft survived the

Nazi death camps. We wanted to identify emotions in the facial expressions of the main character displayed in the book's illustrations to find out if that would give us a new lens for under-

standing the story. In this black-and-white cartoon, Haft tells his horrific story, in which he and other concentration camp inmates were made to box each other to the death. The story is written from Haft's perspective; interspersed throughout the narrative are panels of flashbacks depicting Haft's memories of important personal events.

The humanities approach would be to analyze and contextualize elements of the story, or the tale as a whole. Kleist's graphic novel is a reinterpretation of a 2009 biographical novel by Haft's son Allan, based on what Allan knew about his father's experiences. Analyzing this complex set of authors' interpretations and understandings might serve only to add another subjective layer on top of the existing ones.

From the perspective of science philosophy, that level of analysis would only make things more complicated. Scholars might have differing interpretations, but even if they all agreed, they would still not know if their insight was objectively true or if everyone suffered from the same illusion. Resolving the dilemma would require an experiment aimed at generating a measurement others could reproduce independently.

Reproducible Interpretation of Images?

Rather than interpreting the images ourselves, subjecting them to our own biases and preconceptions, we hoped that AI could bring a more objective view. We started by scanning all the panels in the book. Then we ran Google's vision AI and Microsoft AZURE's face recognition and emotional character annotation as well.

The algorithms we used to analvze "The Boxer" were previously trained by Google or Microsoft on hundreds of thousands of images already labeled with descriptions of what they depict. In this training phase, the AI systems were asked to identify what the images showed, and those answers were compared with the existing descriptions to see if the system being trained was right or wrong. The training system strengthened the elements of the underlying deep neural networks that produced correct answers, and weakened the parts that contributed to wrong answers. Both the method and the training materials - the images and annotations — are crucial to the system's performance.

Then, we turned the AI loose on the book's images. Just like on "Family Feud," where the show's producers ask 100 strangers a question and count up how many choose each potential answer, our method asks an AI to determine what emotion a face is showing. This approach adds one key element often missing when subjectively interpreting content: reproducibility. Any researcher who wants to check can run the algorithm again and get the same results we did.

Unfortunately, we found that these AI tools are optimized for digital photographs, not scans of black-and-white drawings. That meant we did not get much reliable data about the emotions in the pictures. We were also disturbed to find that none of the algorithms identified any of the images as relating to the Holocaust or concentration camps - though human viewers would readily identify those themes. Hopefully, that is because the AIs had problems with the black-and-white images themselves, and not because of negligence or bias in their training sets or annotations.

Bias is a well-known phenomenon in machine learning, which can have really offensive results. An analysis of these images based solely on the data we got would not have discussed or acknowledged the Holocaust, an omission that is against the law in Germany, among other countries. These flaws highlight the importance of critically evaluating new technologies before using them more widely.

Finding Other Reproducible Results

Determined to find an alternative way for quantitative approaches to help the humanities, we ended up analyzing the brightness of the pictures, comparing flashback scenes to other moments in Haft's life. To that end, we quantified the brightness of the scanned images using image analysis software.

We found that throughout the book, emotionally happy and light phases like his prison escape or Haft's postwar life in the U.S. are shown using bright images. Traumatizing and sad phases, such as his concentration camp experiences, are shown as dark images. This aligns with color psychology identifications of white as a pure and happy tone, and black as symbolizing sadness and grief.

Having established a general understanding of how brightness is used in the book's images, we looked more closely at the flashback scenes. All of them depicted emotionally intense events, and some of them were dark, such as recollections of cremating other concentration camp inmates and leaving the love of his life.

We were surprised, however, to find that the flashbacks showing Haft about to punch opponents to death were bright and clear suggesting he is having a positive emotion about the upcoming fatal encounter. That's the exact opposite of what readers like us probably feel as they follow the story, perhaps seeing Haft's opponent as weak and realizing that he is about to be killed. When the reader feels pity and empathy, why is Haft feeling positive?

This contradiction, found by measuring the brightness of pictures, may reveal a deeper insight into how the Nazi death camps affected Haft emotionally. For us, right now, it is unimaginable how the outlook of beating someone else to death in a boxing match would be positive. But perhaps Haft was in such a desperate situation that he saw hope for survival when facing off against an opponent who was even more starved than he was.

Using AI tools to analyze this piece of literature shed new light on key elements of emotion and memory in the book — but they did not replace the skills of an expert or scholar at interpreting texts or pictures. As a result of our experiment, we think that AI and other computational methods present an interesting opportunity with the potential for more quantifiable, reproducible and maybe objective research in the humanities.

It will be challenging to find ways to use AI appropriately in the humanities — and all the more so because current AI systems are not yet sophisticated enough to work reliably in all contexts. Scholars should also be alert to potential biases in these tools. If the ultimate goal of AI research is to develop machines that rival human cognition, artificial intelligence systems may need not only to behave like people, but understand and interpret feelings like people, too.



biology at Albert Einstein College of Medicine. "I developed a strong curiosity for biology and I learned first-hand how to design and conduct an experiment, perform literature searches and foster long-lasting relationships with mentors. Eventually I presented my research findings at national conferences."

Almonte began her pursuit of science while attending Queensborough Community College. Her enrollment in the Bridges to the Baccalaureate program inspired her interest in science, she said.

The Bridges to the Baccalaureate program, which began in 1993, is designed to assist community college students, including minority students, make the transition to from community colleges to four-year degrees and then pursue careers in the biomedical or behavioral sciences.

The five-year NIH grants go to colleges that award associate's degrees and work to forge partnerships with four-

year colleges. The program offers research training, experience and mentoring to qualifying students.

Several students who have entered the program over the years have gone on to earn doctoral and medical degrees.

In the 25 years since its inception, the program has assisted nearly 700 students at the three schools, according to CUNY officials. About half of those students have gone on to graduate from four-year colleges with baccalaureate degrees. That's nearly four times the graduation rate for

community college students overall.

Dozens of students have completed Master's Degrees and 18 students have earned medical degrees or science Ph.D.s.

Another success story is Carlos Correa, who emigrated from Colombia when he was 16 and dreamed of becoming a doctor. One of his teachers at Queensborough urged him to apply for the program. He graduated with a biology degree from City College this year and has been accepted into two medical schools.

"The Bridges program opened the door for me to the world of science and gave me the boost of confidence I desperately needed. There are many students like me out there with the potential to succeed and accomplish great things, but who need a little push in the right direction. This is especially true for minority students who often face more significant challenges in education," Correa said.

In addition to Queensborough Community College, the program is available at LaGuardia Community College in Astoria and the New York City College of Technology in Brooklyn.

Acting CUNY Chancellor Vita C. Rabinowitz said the program's impact can be seen in the experiences of the participating students.

"The program's success can be observed in the hundreds of CUNY students, primarily those from underrepresented groups, who have completed associate's degrees, continued their science education at CUNY senior colleges and later launched their careers," Rabinowitz said in a statement.

Examining the Link Between Climate Change and Foodborne Illness As Queens Leaders Sign Onto Green New Deal

Veteran U.S. Rep. Nydia Velazquez announced Tuesday that she was endorsing U.S. Rep.-elect Alexandria Ocasio-Cortez's "Green New Deal," a plan to focus United State energy policy around renewable sources, address climate change and create thousands of new jobs. Both Velazquez and Ocasio-Cortez represent parts of Queens.

"We cannot delay when it comes to addressing this existential threat to our planet," Velazquez said on Twitter. "Water-adjacent cities, especially like New York, cannot stand by as sea levels rise."

On Wednesday, a reader wrote to EarthTalk to learn about the link between climate change and foodborne illness, a problem that scientists say will worsen as temperatures rise.

"I read the federal government's recently released climate change report, and was surprised to learn that global warming is even being blamed for an increase in foodborne illness," said Jeremy Brotherton of Camden, Maine. "What's the connection?"

Yes, the new federal climate report (the "Fourth National Climate Assessment") paints a dire picture of our future—including compromised food safety—if we don't rein in greenhouse gas emissions.

According to the nonprofit Stop Foodborne Illness (SFI), climate change is already starting to affect food safety as a result of increased bacterial adaptation to fast changing environmental conditions brought on by warming surface temperatures.

In essence, the bacteria that rules the world is getting better at adapting to new environments.

The stronger the bacteria, the better it can do colonizing new territory—and making more of us sick. One side effect of increased bacterial resistance is much more use of antibiotics by veterinarians, farmers and ranchers to keep animals healthy. But it's a zero-sum game: The more antibiotics we use on ourselves and animals, the better bacteria get at developing resistance to them.

Additionally, global warming brings increased flooding, which spreads pathogens from misdirected waste streams across soils, including where children play and food crops grow. Meanwhile, warming-induced drought compromises overall soil health and brings new

bacterial challenges to farmers and ranchers.

Another way global warming contributes to more foodborne illness is by increasing the incidence and severity of natural disasters where first responders may not prioritize food safety and many of the affected are left without power or running water that could help them sanitize food.

Likewise, agricultural experts worry that exaggerated "mycotoxin" growth in a warmer world could also contaminate food sources.

"Mycotoxins are a group of highly toxic chemical substances that are produced by toxigenic molds that commonly grow on a number of crops," reports SFI. High temperature, humidity and precipitation brought on by climate change can create optimal conditions for mold growth. At high doses, mycotoxins produce acute symptoms and deaths, and particular mycotoxins may possess carcinogenic, immunosuppressive, neurotoxic. estrogenic and teratogenic activity," adds SFI. What's scary is that we could already be ingesting these contaminants—and surely will be more so in the future-by eating inadvertently infected crops and/or meat derived from livestock raised on contaminated feed.

And then there's "zoonosis," the transmittal of diseases from pets and livestock to people through direct contact with infected animals, meat or wastes. Climate change will increase the susceptibility of animals to disease, says SFI, thus increasing the likelihood of our contracting illnesses from animals.

While we can try our best to eat responsibly grown foods and stay out of the way of potentially infected

animals, the solution to global warming-induced increases in food-borne illness is to stop emitting greenhouse gases. But as we are finding, that's much more easily said than done.

he heard footsteps from behind him get faster and faster, he said.

"Give me all you got," Horton said that Pointer told him. He said Pointer ran in front of him and pointed a silver .45 caliber gun to his chest.

Seconds later, Horton felt the barrel of another gun pressed into the small of his back, he said.

Horton said he refused to turn over his property when one of the men directed him to lay on the sidewalk face down. Pointer, 21, allegedly directed Holloway to shoot Horton.

But the stick-up artists spared him, prosecutors said. Instead, Horton said, they ripped the items off of him and fled.

Horton, who works in financial real estate, ran to safety inside his home and called the police. He said he was "impressed" with the amount of officers which responded to the St. Albans block.

Defense attorneys Warren Silverman and Randall Unger separately probed Horton on cross-examination about his initial description of the men who robbed him.

"Didn't you tell the police the person in front of you was 5 foot, 6 inches?" Unger asked Horton.

"I don't remember. I remember he was shorter than me," Horton replied, adding that Pointer stood in front of him and Holloway stood behind

Holloway — who is held on Rikers Island on \$300,000

bail — is 6 feet, 2 inches tall, according to Department of Correction records.

Pointer's height is unclear. He is out on bail. In December 2017, Horton pointed out Holloway and Pointer in a police lineup. He never recovered any of his property.

"What we have here is an old-fashioned, one-eyed witness case," Unger said outside of court.

Unger said that no forensic evidence, cell phone tower pings, DNA, fingerprints or surveillance video evidence place Holloway or Pointer at the scene.

If convicted, both defendants face up to 30 years in prison for robbery and gun possession charges.

The trial continues on Wednesday in front of Justice Leslie Leach.

The Voelker-Orth House will be decorated in traditional 19th Century German-American style.



Glendale Man Found Dead Under L May Have Fallen

A Glendale resident who was found dead under the L train trestle near the border of East New York and Brownsville may have fallen off the elevated tracks, police say.

Jared Adams, 32, was found dead on the street near the intersection of Blake and Van Sinderen Avenues at around 5:30 a.m. Monday,

police said. The site is located between the Sutter Avenue and Livonia Avenue L Train stations.

Police said Adams was unconscious and unresponsive when they arrived. He was pronounced dead at Brookdale Medical Center.

Police initially said Adams had suffered a gunshot wound to the head, but on Wednesday, the *Daily News* — citing "police sources" — reported that he may have fallen off the tracks.

When contacted by the *Eagle*, an NYPD spokeswoman deferred to the police sources cited by *News*.

The 75th Precinct in East New York did not respond to request for comment.
