LIRR ANNOUNCES TIMETABLE CHANGES DUE TO AMTRAK AND MTA WORK

As a result of multiple infrastructure projects the Long Island Rail Road announced on Friday new timetables will be in effect beginning Jan. 7 through March 3, 2019. The LIRR will divert or cancel seven of 144 morning rush trains and six of 130 evening rush trains. Five trains are being added before and after the rush period. By lengthening select trains, the LIRR is limiting the overall reduction in seating capacity to less than 1 percent. These changes include: three morning peak trains to Penn Station will be diverted to Atlantic Terminal; one morning peak train to Penn Station will terminate in Jamaica and one morning peak train to Penn Station will not operate.

The 'Bucks' Stops Here: Streetwear Mogul Gets Four Years For Gun Possession

The co-founder of a once-popular clothing line was sentenced to four years in prison on Friday for illegally carrying a gun.

Streetwear mogul Rodney "Bucks" Charlemagne, co-founder of the Slowbucks clothing brand, walked into Queens Supreme Court sharply dressed and seemingly unprepared to learn that a weapons possession conviction carries a minimum sentence of three and-a-half years.

"So everyone is clear, probation is not an option by law," said Queens Supreme Court Justice Kenneth Holder.

Charlemagne, 31, was found guilty of illegally possessing a gun after a jury trial this summer. He said he found the gun by accident three days before the arrest in November 2015.

Defense attorney James Kousouros argued

Fulfilling its commitment to combat food insecurity on its campuses, the City University of New York announced on Thursday that it will soon unveil a free food pantry at its York College campus in Jamaica.

The new food pantry will officially open on Wednesday, Dec. 19, thanks in part to a grant funded by The Carroll and Milton Petrie Foundation and CUNY' Central Office. The pantry is currently accepting donated items from individuals and businesses.

Multiple CUNY colleges in Queens, including Queens College and LaGuardia Community College and York College, announced in August that they planned to established free food pantries in order to provide

A homophobic Manhattan man faces up to 15 years in prison for attacking a woman and causing her to fracture her spine aboard an E train traveling through Forest Hills.

Allasheed Allah's intolerance for the LGBTQ community pushed him over the edge on Nov. 20 when he saw 20-year-old Avneet Kaur kiss another woman in front of him on a rush hour train approaching the Forest Hills/71st Avenue Station, prosecutors said.

Allah, 54, admitted that he told Kaur "not to kiss her again in front of me because she was disrespecting me with all that gay [expletive] she been doing."

When Kaur and the other woman attempted to get away from Allah on the Manhattan-bound train, he took his hate-filled opinion to another

"I stood up and told her 'kiss her again you [expletive] and watch what happens.' I pushed the girl, she turned around and then she fell," Allah allegedly said.

Kaur hit her head and neck before falling to

the floor. She was taken to a local hospital to receive treatment for a fractured spine.

"Queens County is the most diverse county in the nation. It is home to many races, nationalities and sexual orientations. Crimes motivated by bias — particularly those involving violence - will never be tolerated in this county," said Queens District Attorney Richard A. Brown in a statement.

Allah was arraigned in Queens Criminal Court late Thursday night on charges of secondand third-degree assault as a hate crime and second-degree aggravated harassment. He is

He is scheduled to return to court on Dec. 27. If convicted, Allah faces three and one-half to 15 years in prison.

ASTORIA WOMEN ALLEGEDLY KILLED **BOYFRIEND, ENLISTED KIDS** TO BURN HIS BODY

Astoria resident Dawn McIntosh is charged with second-degree murder for allegedly shooting and killing her boyfriend in 2015. Prosecutors say McIntosh allegedly enlisted her 15-year-old daughter and 21-year-old son to help her dispose of the body. She appears in

McIntosh allegedly shot Shron McWhorter, 43, in the chest and torso. She then burned the body and disposed of the alleged murder weapon. Her two children were also allegedly involved with disposing of the body. Prosecutors say her son lifted the body into his mother's Jeep. The body was discovered by law enforcement behind a house in Astoria, where it was engulfed in flames.

"The defendant is accused of a particularly heinous crime in which she fatally shot her boyfriend and then tampered with evidence by, among other things, setting the deceased's body on fire," District Attorney Richard A. Brown said in a statement. "At the same time, it is alleged that she enlisted the aid of her teenage daughter and adult son in an attempt to cover up her involvement in the crime."

WOMAN CHARGED WITH DWI AFTER BOYFRIEND **HIGHWAY DEATH**

Savittrie Beria-Lackhan is charged with allegedly driving while intoxicated after her boyfriend jumped out of her vehicle on the highway and was struck and killed by an oncoming car on the Grand Central Parkway. Beria-Lackhan will appear in K24 for a decision on a motion.

"A verbal dispute quickly turned into a deadly scene of horror when the defendant decided to get behind the wheel of a car after drinking and then became engaged in a verbal dispute with her boyfriend," Queens District Attorney Richard A. Brown said in a statement. "As a result, her companion jumped out of the car and was fatally struck. The defendant should never have been driving in that alleged condition?

Beria-Lackhan, a South Ozone Park resident, and boyfriend Arif Hoosein were driving on the parkway around 3:45 a.m. when Hoosein jumped out and was struck by an incoming vehicle. When responders arrived at the scene, they noticed Beria-Lackhan's alleged slurred speech, watery eyes and a strong odor of alcohol. They later administered an intoxilyzer exam, which allegedly revealed that she had a blood alcohol level of .209 percent, more than the legal limit of .08 percent.

ALLEGED KILLER FLED TO SOUTH CAROLINA

Far Rockaway resident Joaquin Bullock is charged with second-degree murder for he allegedly shooting and killing another man in an August street fight. Bullock appears in AP6 for a conference.

Bullock, 31, was apprehended in South Carolina and charged with murder, kidnapping and criminal possession of a weapon, Queens District Attorney Richard A. Brown said in

"A life was cut short by a senseless act of gun violence. The defendant in this case is alleged to have shot and killed the victim following a dispute in the waning hours of August 18, 2018," Brown said in a statement. "The defendant is further alleged to have fled the jurisdiction and was later apprehended by the Regional Violent Felony Warrant Squad and the Queens Homicide Squad in Spartanburg, South Carolina. He is now back in our jurisdiction and will be prosecuted for this pointless death."

According to the charges, Bullock began arguing with several men on Beach 25th Street and Brookhaven Avenue at around 11:40 p.m. on Saturday, Aug. 18. Video surveillance allegedly shows Bullock punching two of the men, including the victim Dion Smith, 28.

CBS Replacing Head of Struggling Morning Show

CBS News is replacing the top executive at "CBS This Morning," which has struggled to maintain its footing since Charlie Rose was fired a year ago on sexual misconduct charges.

The network announced Friday that executive producer Ryan Kadro will be leaving "CBS This Morning" and the network. He's been with the show since its 2012 launch and has been running it since his predecessor, Chris Licht, left to run Stephen Colbert's "The Late Show" three years ago.

CBS said Kadro's exit had nothing to do with the network's settlement this week of a lawsuit filed by three women concerning Rose's behavior that had faulted management, including Kadro, for not acting to stop him.

No replacement has been named

Kadro, in a note to his staff, said he had been discussing his future with CBS News President David Rhodes since September. His contract expires at the end of the year.

"Through our discussions, I couldn't shake the feeling in my gut that I need a new challenge, and a serious nap," Kadro wrote. "It's the natural course of things."

"CBS This Morning" had generated significant momentum in the lucrative morning market-place earlier in the decade with a newsier approach led by the onair anchor team of Rose, Gayle King and Norah O'Donnell. While it remained third in the ratings to ABC's "Good Morning America" and NBC's "Today" show, its audience grew, and it was competitive with its rivals for the first time in a long time.

After Rose's departure, that momentum halted. All of the network morning news shows are losing audience, but none as quickly as CBS. The show has been averaging just under 3.2 million viewers this year, compared to 3.6 million before Rose's exit in November 2017,

the Nielsen company said.

Rose was replaced by John Dickerson, the former "Face the Nation" host. In October, Bianna Golodryga was added as a fourth anchor.

CBS had said last week that it had settled its portion of a lawsuit filed by two former "CBS This Morning" employees, Katherine Brooks Harris and Yuqing Wei, and a third woman who worked as Rose's assistant, Sydney McNeal, who had accused Rose of unwanted physical contact. The lawsuit said one of the women had warned Kadro of Rose's behavior but that nothing had been done; CBS said Kadro had a different recollection of the discussion.

CBS News said the settlement was unrelated to the change.

Finding a new leader for its morning show and entrusting that person to turn things around isn't the only management issue Rhodes is facing.

He's mulling a closely-watched decision on leadership CBSTHIS MORNING

at "60 Minutes," television news' most popular and influential program. The show's previous executive producer, Jeff Fager, was let go in September after sending a threatening text to another CBS News reporter who was working

on a story about misconduct allegations against Fager.

It's one of the top jobs in television journalism. Bill Owens, a veteran "60 Minutes" executive who is the show's interim leader, and "48 Hours" top executive Susan Zirinsky are thought to be two of the top candidates.

Another important show for the network, the "CBS Evening News," has been hurting in the ratings with Jeff Glor as top anchor.

Janet Jackson, Def Leppard, Nicks Join Rock Hall of Fame

Janet Jackson joins her brother Michael and the Jackson 5 as members of the Rock and Roll Hall of Fame, earning induction on Thursday along with Stevie Nicks and the top fan vote-getter, Def Leppard.

Radiohead, the Cure, Roxy Music and the Zombies will also be ushered in next spring at the 34th induction ceremony. It will be held March 29 at Barclays Center in Brooklyn.

Jackson's induction comes after her third time as nominee and many saw it as overdue, given her prowess as a hitmaker with "All For You," "That's the Way Love Goes," "Nasty," "Together Again" and "What Have You Done For Me Lately."

Her career suffered from the

fallout after the infamous 2004 Super Bowl appearance where her bare breast was briefly exposed by Justin Timberlake; both said it was a mistake.

But she's had a resurgence of late including an acclaimed tour, headlining festival stints, multiple lifetime achievement honors and a No. 1 album on the main Billboard chart.

Jackson became eligible for the rock hall in 2007 and wasn't nominated until 2016.

The Roots' Questlove, in a social media post earlier this year, said her exclusion had been "highly criminal." He cited the influence of her 1986 album "Control," which he said set off the New Jack Swing trend.

"This was no one's kid sister," he wrote.

Jackson said on Thursday:

"Thank you Rock and Roll Hall of Fame. I am truly honored and I am happy to be in there with my brothers."

It will be Nicks' second induction into the rock hall, since she's already there as a member of Fleetwood Mac. She launched a solo career in 1981 with her duet with the late Tom Petty, "Stop Draggin' My Heart Around." Other hits followed, including "Edge of Seventeen," "Stand Back" and "I Will Run to You."

Def Leppard earned more than half a million votes from fans, which are incorporated into more than 1,000 ballots from artists, historians, industry professionals and past winners in deciding who gets honored. The British heavy metal band with a pop sheen were huge sellers in the 1980s on the back of songs

like "Photograph" and "Pour Some Sugar on Me."

Frontman Joe Elliott said he was initially ambivalent toward the honor until Jon Bon Jovi suggested it would change his life.

"When I look at the list of who's in, it's just obvious you'd want to be in that club, isn't it?" he told Billboard earlier this year. "When you think that every band that means anything in the world, starting from the Beatles and the Stones and any artist that influenced them — your Chuck Berrys, your Little Richards, etc., etc. — then of course you want to be in. Why wouldn't you?"

Def Leppard, Nicks and Roxy Music were voted in during their first years as nominees. Other 2019 nominees who didn't make the cut included LL Cool J, Devo, Rage Against the Machine, MC5, John Prine, Todd Rundgren and Kraftwerk.

There's some question about whether Radiohead will shrug its collective shoulder as an inductee. The English band seemed like generic grunge rockers on their initial hit "Creep," but with the album "OK Computer" and beyond have become consistent sonic pioneers. Among its rock hall class, Radiohead has the most impact on the current music scene.

In an interview with Rolling Stone earlier this year, Radiohead's Jonny Greenwood said "I don't care" when asked about the rock hall. Bandmate Ed O'Brien said, "culturally, I don't understand it. I think it might be a quintessentially American thing."

The Cure and frontman Robert Smith resist their initial

label as goth rockers, champions of fans who like black makeup, black clothes and darkly romantic songs. They have a durable catalog of hits, including "Friday I'm in Love," "Boys Don't Cry," "Pictures of You" and "Let's Go to Bed."

Roxy Music came out of the 1970s progressive rock scene and had hits with "Love Is the Drug" and "More Than This." Dapper member Bryan Ferry had a successful solo career and Brian Eno has been an influential producer.

The heyday of British rockers the Zombies' career was the 1960s, with big sellers "She's Not There" and "Time of the Season."

The hall will announce ticket sales for March's ceremony next month. HBO and SiriusXM will carry the event.

Rebuilding Trust To Combat the AntiVaccine Movement

American children and adults should live in a country in which eradicated diseases stay eradicated.

For much of the 20th century, Americans fought battles not only on the war front, but also at home, in the form of deadly diseases. There were many who either died or were permanently disabled from diseases such as measles, polio and influenza. With the development of vaccines, however, we finally have biological weaponry that could (and did) eliminate these enemies of our health.

Measles was considered eradicated in the U.S. in 2000, and the last cases of endemic polio occurred in 1979. This changed in the last few years of the 20th century, and by the early 2000s, new cases

of measles and polio-like illnesses were appearing once again in the American population. As recently as last month, six children were diagnosed with measles in Brooklyn.

The resurgence of these viruses is due to the phenomenon known as the anti-vaccination movement. While there has always been a group of people who have been against the administration of vaccines (for as long as the vaccine has been in existence), the modern movement was galvanized in 1998, when an article by Dr. Andrew Wakefield was published which seemed to prove a link between the MMR (measles, mumps and rubella) vaccine and development of autism in children. His research was later proven to be full of holes and incorrect data, and his article was retracted in 2010. But by that time, the damage to vaccination's reputation had been done.

An increasing number of parents opt to not vaccinate their children. Over the last decade, this has led to higher numbers of unvaccinated human carriers of potentially deadly viruses.

Unvaccinated children and adults are more susceptible to getting these diseases and are also more likely to spread these diseases to other people in their communities.

The problems from having a large population of unvaccinated persons are both obvious (increased numbers of people getting sick)

and subtle (increased strain on our overburdened health care system). A large population of unvaccinated persons can cause widespread havoc in Brooklyn and the whole American population.

We can address this growing problem. Especially since the science behind the autism and vaccination link was proven to not exist, the best approach to combat the misinformation is by providing the true information regarding vaccines.

The truth about vaccines must reach potential and current parents. Physicians and other primary care clinicians can rebuild trust with their patients. One example is to ensure that adequate amounts of time are allocated to answer patients' questions and to address their concerns. Doctors can rebuild trust by listening and communicating with empathy, so parents understand that the doctor only has his or her child's best health interests at heart.

It is important to develop trusting relationships with children's health care providers and parents, so accurate information can be shared effectively with parents. The truth about vaccinations can be used to counteract the effects of the anti-vaccine movement.



7-Year-Old Migrant Girl Held at U.S. Border Dies in Custody

A 7-year-old Guatemalan girl found with her father and dozens of other migrants along a remote stretch of the U.S.-Mexico border suffered seizures and spiked a high fever in immigration custody and later died, federal officials said.

Her death raises questions about how apparent her sickness was. A Border Patrol form completed shortly after she was detained said she showed no signs of sickness. The form, obtained by the Associated Press, said she was not sweating, had no tremors or visible trauma and was mentally alert. "Claims good health," the form reads. The girl's father appeared to have signed the form.

But, hours later, after she was placed on a bus, she started vomiting. She was not breathing when she arrived at a Border Patrol station. Emergency medical technicians revived her, and she was flown to a hospital in El Paso, Texas, where she was found to have swelling in her brain and liver failure, officials said. She later died.

An autopsy was scheduled to determine the cause of the girl's death. The results could take weeks.

An official with Guatemala's foreign ministry identified the girl as Jackeline Caal and her father as 29-year-old Nery Caal. The official requested anonymity because he was not authorized to share information.

The father was driven to El Paso and was at the hospital when she died, officials said. He is not detained.

Jackeline's death comes as increasing numbers of children and families are making the dangerous trek north from Central America and as immigration officials are being increasingly criticized for their treatment of migrants who arrive at the U.S.-Mexico border. Homeland Security's watchdog will review what happened in the girl's case, federal officials said.

The pair were taken into custody at about 9:15 p.m. Dec. 6 in a group of 163 people in remote New Mexico, about 90 miles from the nearest Border Patrol station in Lordsburg. The rugged, mountainous area is mostly deserted, home to ghost towns and abandoned buildings from Old West homesteader days. It's an unforgiving terrain where Geronimo made his last stand and it remains largely isolated with no cell service and few paved roads.

There's a small Border Patrol operating base near where the group was found with food, water and bathrooms, but no medical help.

The migrants were bused from the area to Lordsburg in two groups, including about 50 minors without parents in the first group, officials said. The girl and her father didn't start the 90-mile journey until about 4:30 a.m., when the bus returned.

The father said the girl was vomiting on the bus. When they arrived to the Border Patrol station in Lordsburg at about 6:30 a.m. Dec. 7, she was not breathing, officials said. Emergency medical technicians discovered the girl's fever was 105.7 degrees Fahrenheit, and she was airlifted to the hospital. She died a few hours later.

Homeland Security Secretary Kirstjen Nielsen said on Fox News that the girl's death was heart-wrenching and a sad ex-

ample of the dangers of crossing the border.

"This family chose to cross illegally," Nielsen said. "We'll continue to look into the situation, but, again, I cannot stress enough how dangerous this journey [is] when migrants choose to come here illegally."

Immigration officials said hundreds of people who have been overcome by the harsh desert and sweltering conditions are saved by Border Patrol every year.

When a Border Patrol agent arrests someone, that person gets processed at a facility but usually spends no more than 72 hours in custody before either being transferred to Immigration and Customs Enforcement or, if the person is Mexican, quickly being deported home.

Immigrants, attorneys and activists have long raised issues with the conditions of Border Patrol holding cells. In Tucson, Arizona, an ongoing lawsuit claims holding cells are filthy, extremely cold and lacking basic necessities such as blankets. A judge overseeing that lawsuit has ordered the agency's Tucson Sector, which patrols much of the Arizona-Mexico border, to provide blankets and mats to sleep on and to continually turn over surveillance footage from inside the cells.

Agents in Arizona see groups of more than 100 people, sometimes including infants and toddlers, on a regular basis.

Arresting such groups poses logistical problems for agents, who have to wait on transport vans that are equipped with baby seats to take the migrants to processing facilities, some of which are at least a half-hour north of the border.

The death of the 7-year-old comes after a toddler died in May just after being released from an ICE family detention facility in Texas and as President Donald Trump's administration attempts to ban people from asking for asylum if they cross the border illegally. A federal appeals court has temporarily blocked that ban, but the administration asked the U.S. Supreme Court to reinstate it Tuesday.

Katz' Death Penalty Vote A Red Flag for Criminal Justice Reformers

As a young state assemblymember in March 1995, Melinda Katz voted to reinstate the death penalty. Katz, the current Queens borough president, was one of 94 members of the Democratic-controlled New York State assembly to vote in favor of the measure, which passed both chambers of the state legislature and was signed into law by then-Gov. George Pataki.

More than 23 years later, Katz is seeking the Democratic nomination for Queens County district attorney and touting a progressive platform that includes bail reform and a crackdown on hate crimes, but her early death penalty support does not sit well with criminal justice reformers.

In a statement, Katz told the *Eagle* that she is "100 percent opposed to the death penalty."

Public defenders and criminal justice reform experts, however, say that her death penalty vote suggests she would seek the toughest sentence possible in order to secure plea deals.

"Like a chronic disease, supporting maximally punitive sentencing with no empirical return on public safety is not something that just goes away," said Rory Fleming, a death penalty expert and the founder of Fog Light, a criminal justice reform advocacy organization. "It indicates something important about a person's baseline character."

Katz acknowledged that the

death penalty is disproportionately applied to people of color and said a distorted desire for justice can compel people to support capital punishment.

"In addition, it is clear that when it is applied in other states, research has shown a clear racial bias, which can never be acceptable for any enforcement of laws," Katz said. "But growing up having lost my mother to someone who broke the law, I understand that to many, the desire for justice can become a desire for punishment."

Katz's mother was killed by a drunk driver when Katz was a child. The district attorney hopeful said her view on sentencing and crime deterrents have changed over the past two decades.

"As I've grown and in the 24 years since I was in the assembly, I came to realize that no punishment can ever undo the damage of a crime committed, and a far better path is stronger crime prevention in the first place," she continued. "My position on this changed over two decades ago, and I was grateful to have the opportunity as a Councilmember to vote for a full moratorium for this punishment in 2002."

Regardless, Fleming said, Katz's 1995 death penalty vote still matters today, especially in light of how criminal justice reform advocates have criticized Queens District Attorney Richard A. Brown for his previous stances on justice policies that have disproportionately punished poor people of color.

"Katz cannot say in good faith that her pro-death penalty stance in the 1990s is irrelevant to today," said Fleming. "DA Brown supported the cruel Rockefeller drug laws until their fall in 2004, which is part of why progressives do not support him or his administration."

Legal Aid attorney Finde Gbollie also questioned the extent to which Katz would seek whatever harsh sentence was en vogue during her time in office.

"If you believe that the purpose of the criminal justice system should be rehabilitation then believing in the death penalty is diametrically opposed to that notion and [it shows] you believe the extreme is ultimately the way to resolve issues," Gbollie said. "Everything is framed from that lens - people can't be saved, they can't be redeemed, it's not about rehabilitation it's about punishment. And that's the problem with the criminal justice system now."

The current maximum sentence is life without the possibility for parole, a sentence which Katz said needs "to be evaluated within the law on a case by case basis."

Justice reformers criticize maximum sentencing because it contributes to mass incarceration.

As of 2016, roughly one out of every five inmates in New York, more than 9,800 people, were incarcerated on life sentences or virtual life sentences — prison terms that exceed life expectancy,

according to statistics compiled by the Sentencing Project.

New York has the third highest number of inmates in prison on life sentences in the country after California and Louisiana, the Sentencing Project reports.

To Katz' allies, however, that death penalty support has no bearing on her current DA candidacy or her perspective on criminal justice. Those allies include Assemblymember David Weprin, who has explicitly condemned Katz' death penalty vote in the past.

In 2009, Weprin ran against Katz in the race for city comptroller — a seat ultimately won by current state Sen.-elect John Liu. In a campaign questionnaire given to all comptroller candidates by the *New York Daily News*, Weprin cited the death penalty support as Katz' biggest weakness.

"Weakness: having voted for the death penalty as a member of the NYS Assembly and lacking any finance experience in the public and private sector," Weprin wrote in response to the *News*.

Weprin has since become a strong Katz support. He stood feet away from her when she officially kicked off her campaign for DA at a rally in Forest Hills on Dec. 4.

"I don't know what her position [on the death penalty] is now and I don't think it would change my support for her," Weprin said. "I'm supporting her because I've worked closely with her and I've seen her reaching out to all the communities of Queens."

Weprin said Katz has a "compassionate approach" and that analyzing positions on the death penalty is irrelevant because the New York State Court of Appeals determined that the death penalty was unconstitutional in 2004.

"It's up to the legislature

to make the laws and we don't have the death penalty," he said. [The DA] has to deal with laws as they are."

Other Katz supporters in the assembly also said that they do not consider her previous death penalty support a problem.

"The world has changed in 20 years," Assemblymember Jeffrion Aubrey told the *Eagle* at Katz' campaign kickoff event. "The world doesn't stay the same and neither do we."

Assemblymember Andrew Hevesi, who also attended Katz' rally, did not offer an opinion on her death penalty support.

"That's interesting," Hevesi said. "Td like to know her position on that now."

However, he added, it is does not make a different because capital punishment is anathema to Democratic Party policy and "no one talks about the death penalty any more in the assembly."

stigma-free food access for students in-need.

In 2015, CUNY reported that 38.5 percent of its students come from households that make less than \$20,000 a year.

"Hunger should never be a barrier for those seeking to achieve their dreams of a higher education," Gov. Andrew Cuomo said in an August statement. "New York is proud to be the first state in the nation to require every public campus to have a food pantry, ensuring that our students have all they need on the path to success."

York College continues to collect items to stock the pantry, but it has provided students food items with for the last two months with support from the Greater Queens Chapter of the Links, Inc. and the Red Shoes Club.

York College is located in the heart of Jamaica, which has one of the highest rates of food insecurity in the borough. A study published last month by the Food Bank For New

York City found that cuts to the Supplemental Nutrition Assistance Program (SNAP) are driving a surge in the number of New Yorkers who visit food pantries, especially in Jamaica, Hollis and St. Albans.

From Trump to #MeToo, Publishing Made Headlines in 2018

The publishing world made headlines in 2018, and not always by design. A wave of best-sellers offered damaging accounts of Donald Trump's White House, a million-selling memoir by Michelle Obama had readers longing for the previous administration and a political thriller by former President Bill Clinton had some taking a closer look at a White House scandal from the 1990s. Meanwhile, some of the country's top writers were called out for sexual harassment and a Dystopian novel written in the 1980s seemed ever more timely.

Here are some highlights:

"FIRE AND FURY" — It landed in early January and quickly had the country talking and Trump threatening to sue (a way to boost sales that ranks with an Oprah Winfrey endorsement). Michael Wolff's tale of backbiting and chaos in the Trump administration wasn't so much a revelation, as a confirmation of what millions had suspected. Reporters questioned some of his facts but the book had at least one real consequence: Former senior adviser Steve Bannon, who didn't deny speaking with the author and criticizing both the president and Donald Trump Jr., was forced out as executive chairman of the far-right Breitbart News. His old boss called him "Sloppy Steve."

#METOO — It began in January with a comments thread on the website of *School Library Journal*: Stories of widespread harassment by some prominent writers for children and young adults, with the alleged harassers first unnamed, then named. Within weeks "Maze Runner" author James Dashner had been dropped by his publisher and "13 Reasons Why" novelist Jay Asher by his agent. Sherman Alexie, whom the American Library Association had just awarded a Carnegie Medal for his memoir "You Don't Have To Say You Love Me," declined the prize. And Daniel Handler of "Lemony Snick-

et" fame withdrew as commencement speaker at Wesleyan University. His replacement was well known to the #MeToo movement: Anita Hill, the woman who testified in 1991 that Supreme Court nominee Clarence Thomas had repeatedly harassed her. "Speaking out, despite the hardship," Hill told the students, "can be self-liberating and can empower others."


"A HIGHER LOYALTY" — In a spirit of anger, admiration and curiosity, readers wanted to know why James Comey reopened the FBI investigation into Hillary Clinton's emails less than two weeks before Election Day and what he and Trump had said to each other before Trump fired him in May 2017, just four months into his administration. "This president," Comey wrote, "is unethical, and untethered to truth and institutional values." Only in the Trump era could a memoir by a former FBI director, one little known to the general public before 2016, sell hundreds of thousands of copies. And only in the Trump era would a sitting president refer to a former FBI director as an "untruthful slimeball." ***

PASSAGES — Within eight days last spring, two of the country's most celebrated writers died, Tom Wolfe and Philip Roth. But 2018 also was a year for welcoming new voices. Tara Westover's "Educated," a memoir about growing up in an isolated Mormon home, was a best-seller admired by everyone from book critics to former President Barack Obama. Tommy Orange's novel "There There" was widely acclaimed and the rare work of literary fiction over the past year to succeed commercially. Other notable debuts included Jamel Brinkley's story collection "A Lucky Man" and Lisa Halliday's novel "Asymmetry," which included a character based on a real-life former lover - Philip Roth.

"THE PRESIDENT IS MISSING" — The million-selling collaboration between Clinton and James Patterson was the novel of the sum-

mer and launched a very different conversation from what the authors had intended. "The President is Missing," a near-apocalyptic thriller, is a cautionary tale about preventing cyberattacks. But the book also included a chapter about a president facing impeachment — an experience Clinton is uniquely qualified to draw upon — and Clinton responded defensively to questions about his affair with White House intern Monica Lewinsky. "This was litigated 20 years ago," Clinton told NBC's Craig Melvin. The most notable thing about his answers, wrote New York magazine's Rebecca Traister, was that "Clinton seemed to be shocked that he would be asked about his behavior in light of #MeToo."


"FEAR" — Bob Woodward, a brand name for inside White House politics, seemed to withdraw during the Obama years. His two works on Obama, "The Price of Politics" and "The Last

of the President's Men," made little impact compared to such early blockbusters as the Watergate-era "All the President's Men." And his only book during Obama's second term was a return to the Nixon years: "The Last of the President's Men," about Alexander Butterfield, the White House aide who revealed to the world that Nixon had a taping system in the Oval Office. But Trump is a singular muse for political writers and with "Fear: Inside the Trump White House," Woodward was fully back in the present. "Fear," Woodward's hottest seller in years, read like a more sober version of "Fire and Fury," another tale of an uncontrollable chief executive and a staff that tries both to contain and encourage him. Trump's verdict: "The Woodward book is a Joke."

"BECOMING" — The initial headlines were about Trump, whom Michelle Obama vowed she would never forgive for promoting the "birther" lie that her husband was born in Kenya. But Obama's book quickly became among the best-selling political memoirs ever. Reviewers cited the qualities which millions had admired her for — the warmth and humor of her courtship with the future president, her can-

dor in describing their marital struggles and efforts to have children and the care and insight into how Michelle LaVaughn Robinson — a self-described "girl of the South Side" of Chicago — adapted to being the country's first black first lady.

MARGARET ATWOOD — The Canadian author didn't need to publish any new fiction to make news in 2018. "The Handmaid's Tale," released more than 30 years ago and dramatized in an acclaimed Hulu series, continued to rank with George Orwell's "1984" as a defining dystopian text for the current time. Questions from readers about the imagined country of Gilead, a brutal patriarchy that didn't seem very fictional, were so persistent that Atwood finally changed her mind about writing a sequel and announced that "The Testaments" would come out in 2019.

that even the minimum sentence is unnecessary in this case. The maximum is 15 years.

Charlemagne, who is also a hip-hop music affiliate, was behind the wheel of a double-parked, brand-new white Land Rover that was blocking traffic on Steinway Street in Astoria when police showed up.

Charlemagne was driving with a suspended license, which prompted a search of

the luxury SUV and discovery of the loaded diamondback .380 caliber pistol, according to the criminal complaint.

During a videotaped statement, Charlemagne refused to tell detectives where he found the weapon.

"I made a mistake trying to do something good for someone," said Charlemagne, who has donated his music studio equipment to Rikers Island for the juvenile offenders to use. "I'm not a person looking to do negative things. I try to live best by the people I care about and who care about me."

Charlemagne testified on his own behalf that he recovered the gun from a young person who was attempting to rob his music studio and called an NYPD detective he knew to report his findings.

"There's no way that he [the detective] would let the phone hang up and not tell

you to leave the gun and don't touch it," Holder said. "If [the detective] knew a young black man driving in New York City in a \$200,000 car and knew, for whatever reason, the chances of getting pulled over is a real thing and didn't give you instructions, [that] is not credible."

Charlemagne volunteers with Life Camp Inc., a leading anti-violence group that runs programs, conducts outreach and performs conflict

resolution to prevent young people from getting shot. The judge read from a letter submitted by a Life Camp representative asking for leniency.

"In this letter, it states your direct role is with helping reduce violence, all that's commendable," Holder said, adding that he questioned why Charlemagne didn't use his mediation skills to help turn the alleged robber's life around

"In your story to the jury, you had an actual person you could have helped and you just let him go. It's not a snitching situation," Holder said.

Charlemagne attempted to interject as the judge was speaking to further explain but was barred.

"I don't believe there was a young man at all, but your story was inconsistent with your behavior on paper," said Justice Holder. "I believe you lied on the stand."

Long Island Man Hit With 90-Month Sentence For Distributing Fentanyl

A Long Island man who used his teenage brother to distribute fentanyl throughout parts of Suffolk County was sentenced to 7 1/2 years in prison, the U.S. Attorney's Office for the Eastern District of New York announced on Friday.

Jamal Brown, 26, was in possession of and sold more than 40 grams of fentanyl, along with quantities of cocaine, in Bay Shore and Huntington Station between July 2018 and February 2018, according to court filings. Brown stored the drugs

throughout locations in Bay Shore and Huntington Station.

"Brown preyed on vulnerable addicts to enrich himself, exposing them to significant risk of overdose with fentanyl, a drug that is a leading factor in the opioid crisis plaguing Long Island and the United States," stated United States Attorney Richard P. Donoghue. "To facilitate his illegal drug distribution, Brown even involved his teenage brother."

As part of Brown's drugtrafficking scheme, he used his 17-year-old brother to sell fentanyl and cocaine for him and store the proceeds, which he later gave to Brown. Thanks to a wiretap on Brown's phone, investigators also discovered that Brown wa using an unidentified individual — who had told Brown of his struggles with addiction and of his plan to enter a rehabilitation facility — to transport the drugs and pick up proceeds from the sales.

Brown's drug scheme was unraveled on Feb. 27, 2018, after search warrants executed at Brown's Long Island drug locations resulted in the recovery of more than 76 grams of fentanyl, more than 150 grams of cocaine,

a .32 caliber Smith and Wesson handgun, ammunition and other evidence of drug trafficking, according to court filings. Brown's newborn child was also found inside the Huntington Station location where approximately 10 grams of fentanyl were recovered.

"Drug trafficking is inevitably linked to corruption, crime and addiction," stated DEA Special Agent-in-Charge Ray Donovan. "Jamal Brown turned his younger brother into a drug dealer, exposed his newborn child to fentanyl and encouraged drug use by addicts seeking treatment."

Jamaica Man Charged With Two Murders in Four Weeks

A Jamaica man was arraigned Thursday on multiple murder charges for allegedly killing two men in four weeks in South Richmond Hill.

Richard Davenport, 42, is charged with two counts of second-degree murder and four counts of second-degree criminal possession of a weapon for allegedly killing a man in December 2017 and another in January.

According to the charges, video surveillance from Dec. 19 allegedly captured Davenport riding as a passenger in a Mercedes-Benz that drove by a Cadillac Escalade parked along 125th Street in South Richmond Hill several times. The video allegedly shows Davenport exiting the Mercedes, walking toward the Cadillac and firing several shots into the car, striking and killing Dail Remessar.


Another surveillance video from Jan. 16 allegedly shows Davenport sitting in the same Mercedes before exiting the vehicle, walking toward a man named Omaree Morrison and shooting him several times. Morrison, 19, died as a result of the gunshot wounds.

"This defendant is alleged to be the shooter in the slaying of two men exactly four weeks apart," Brown said. "One man was gunned-down while seated in a vehicle near a playground and the other ambushed as he walked on a residential street after nightfall. My office remains committed to continue the fight of ending gun violence in our community."

Justice Michael Aloise presided over the arraignment and ordered Davenport held without bail. Davenport will return to Aloise's courtroom on Feb. 27, 2019.

If convicted, Davenport faces up to 50 years to life in prison.





Care for the Homeless Observes Annual Homeless Persons' Memorial Day

For 40 years, David Broxton worked in sales, even owning his own store before he developed a drug addiction and became homeless.

Broxton died earlier this year, one of at least 150 New Yorkers who experienced homelessness and died in the past year.

"Even as we pause to remember and grieve for those who passed away while unstably housed, we need to acknowledge that chronic homelessness can rob a person of 30 or even 40 years of life. As a society, we have it within our power to end the modern day homeless crisis," said Care For the Homeless' Executive Director George Nashak. "And it starts with rectifying poor policy choices. Better policies can end homelessness as we know it."

The organization and its members on the Consumer Advisory Board advocate for those policies — including truly affordable housing and the development of more supportive housing — each day and invite others to join them.


After connecting with Care for the Homeless, Broxton joined the organization's

Greased Runway: Underwood Announces Settlement In Kennedy Airport Ground-Handling Kickback Case

New York State has reached a \$12.3 million settlement with an airport ground handling company that made undisclosed payments to executives of key clients at John F. Kennedy Airport, Attorney General Barbara D. Underwood announced on Thursday.

Amid ongoing investigation into the contracting and procurement processes at JFK Airport in Jamaica airport ground handling company Ground Services International (GSI) agreed to pay the sum after making fraudulent kickback payments intended to influence various contracts the company had at JFK Airport and in other airports nationwide.

AG Underwood's investigation, known as "Operation Greased Runway,"

has also revealed that GSI expanded its business and won new contracts with two major companies, British Airways and Terminal One Group Association L.P. (TOGA), while simultaneously making undisclosed payments to the companies' key executives.

Edward Paquette, the former Executive Director of TOGA, was recently convicted of crimes related to the kickback scheme. He was also required to pay

a \$2 million settlement.

"New Yorkers deserve safe airports where businesses play by the rules. Yet these brazen, longstanding pay-to-play tactics undermined the integrity of contracting at JFK — allowing greed to trump fairness," said AG Underwood said in a statement. "Our investigation continues, and we're committed to rooting out corruption wherever it exists."

Longtime GSI President, Jeff Kinsella, secretly agreed to provide an ownership interest in GSI to a senior British Airways executive who had influence over procurement decisions at the airline, while that executive was promoting GSI's services within British Airways, according to the investigation.

From 2009 to 2016, Kinsella made regular payments to the British Airways executive that totaled over \$1.2 million, all the while British Airways expanded its business with GSI substantially. When Kinsella later sold GSI in 2016, the British Airways executive received an additional \$3.6 million from Kinsella. Neither of the payments were disclosed to British Airways, the Port Authority, or any other entity in the airline industry.

GSI also made illegal payments to TOGA Executive

Director Edward Paquette while he served as the "key decision maker with respect to the contract for ground services as JFK's Terminal One," according to the investigation. Paquette has pled guilty to first-degree commercial bribe receiving, a felony.


While secretly making these illegal payments, GSI profited in the millions of dollars from its contracts at Terminal One and Terminal Seven at JFK Airport with British Airways and TOGA respectively.

"Today's announcement exposes a pay to play scheme that enabled Port Authority tenants and vendors to game the system and award business in exchange for payoffs and greed versus integrity and fairness," Michael Nestor, inspector general for the Port Authority of NY & NJ said in a statement. "The Port Authority of NY & NJ Office of Inspector General and the New York State Attorney General will work vigorously to identify and root out corruption and ensure that all tenants and contractors conducting business at our Port Authority facilities do so with the highest degree of honesty, integrity, and fairness."

In addition to the hefty monetary fine, GSI is required to implement and maintain an anti-bribery and corruption policy, and to train employees on that policy annually. The company will also establish an anonymous tip line where employees can report suspected violations of the policy.

Tips on Savoring the Solstice from a Jamaica Bay Park Ranger

What do we think of when we hear that winter has arrived? How does it make us feel?

What if we chose to think of the solstice not as a leaving of warmth, but a coming of light?

While Dec. 21 will be the longest night of the year — more than 14 hours of darkness, here in Queens — every night will get shorter after that, and every day gets longer.

If the arrival of winter brings you a feeling of dread or despair, I hope that I might be able to show you this season from another perspective. And if you already love winter, then rejoice: Dec. 21 can be a celebration.

Cathy Johnson, in her book *The Nocturnal Naturalist*, says "[In winter] we have to look hard for signs of life. But life there is if we take the time to see it."

If you are a nature observer like me, you may sometimes feel frustrated by the lack of apparent wildlife in winter.

Cathy Johnson mentions this as well and she gives us some food for thought.

"In the absence of more easily achieved observations, weather itself becomes the subject," she says.

Water presents itself in more ways in the winter. In addition to rain, we can experience winter water as frost, snow, sleet and freezing rain.

If we like, we can take time to have a more childlike appreciation. We can use all five of our senses to better observe it.

When was the last time you caught a snowflake on your tongue? Who's stopping you? We can even make snow ice cream by mixing a bowl of fresh snow with a can of sweetened condensed milk. It's an instant dessert and it tastes great.

Now, just because we spend more time noticing the weather doesn't mean there isn't wildlife to see if we look closely.

With fewer hours of daylight, and chilly temperatures, we tend to spend more time indoors. We are not alone.

Much of the wildlife of the region is also headed inside their nests and dens. It is a time to live simply and to plan for warmer months. But have we actually been looking to nature for guidance?

Let's start with hibernation. If that's not going inward, then I don't know what is.

While bears may be most famous for hibernation, we're not likely to find them around Queens.

We do, however have a few resident hibernators, including bats, woodchucks, garter snakes and box turtles. We can look to animals who insulate their homes or even themselves. Mice who gather straw and bits of string and wool to make soft, warm nests. Mammals whose fur coats get thicker — and warmer. Birds who fluff up their feathers to protect themselves from wind and chill.

There are people who, like squirrels — and me — stock up on food and necessities for the winter. And there are those like most everyone — and also me — who are generally passive for a few months, trying not to expend precious energy. While

all this turning in and stashing away may mean that winter animals are harder to see, there is another way that we might be able to notice them.

We can listen for them. In a calendar year in Queens., it is possible to observe eight species of owls. Jamaica Bay is no exception and winter time is the absolute best chance we have. Owls are known for being elusive, they are masters of camouflage and most often nocturnal. But when the evening comes, they give themselves away by calling out. Great horned owls

have been heard calling at the Wildlife Refuge and I invite you to take a listen, if you can.

Lastly, we come to perhaps the most spectacular sight: a winter sunset.

While the palate of the landscape is mostly dull, winter sunsets more than make up for that by wildly contrasting with the grays, browns and whites. In fact, sunrise and sunset are some of the only chances we have in winter to see dazzling color.

Our solstice sunset will be at 4:31 p.m. on Friday, Dec. 21 and Jamaica Bay will be

an incredible place to see it, should the weather hold up.

When the sun has set, and the last of the color has faded away, and we walk out into the longest night of the year, I once again turn to Cathy Johnson who said, "If I am willing to pay the price of cold extremities, and a bit of discomfort, I find a wildness in these winter nights."

Happy solstice and welcome, winter.

'Old Fashioned' Robbery Trial Ends With Acquittal

A Queens jury acquitted two men who were facing up to 30 years in prison for a gunpoint robbery of a St. Albans man.

In November 2016, Ronald Horton was steps away from his home when two men armed with guns demanded he hand over his valuables.

Horton picked out Perry Pointer, 21 and Frederick Holloway, 20, in a lineup in December 2017, more than a year later, as the pair who stole his Rolex watch, BlackBerry cell phone, credit cards, car keys and cash.

After a jury heard all the evidence in Queens Supreme Court on Dec. 7, they quickly returned a not guilty verdict for both defendants to Justice Leslie Leach.

"What we have here is an old-fashioned, one-eye witness case," Holloway's defense attorney Randall Unger told the *Eagle* on Dec. 5 outside of court.

Even though Horton pinned the crime on Holloway and Pointer, his descriptions after the incident and to

the jurors did not match, according to trial testimony.

At least one of the alleged robbers was 5 feet, 6 inches tall, the victim said. Pointer and Holloway are both well over 6-feet tall, according to court records.

Pointer, who was out on bail during the pendency of this case, had his bail exonerated and record sealed. His attorney Warren Silverman did not return calls requesting comment.

Despite the acquittal, Holloway remains locked up on Rikers Island for two pending cases — an armed robbery from October 2017 and a June 2017 illegal gun possession, according to court records

Firebug Heads To Prison For Charring Cars in South Ozone Park

A South Ozone Park man was sentenced to up to eight years in prison on Thursday for senselessly setting nine cars ablaze in a three-month tirade.

Evan Person pleaded guilty in November for igniting fires to nine unoccupied cars between December 2017 and February 2018 along 116th Avenue and in front of two homes on 124th Street and 109th Avenue.

"The defendant endangered the welfare of first responders and residents in his community by intentionally setting these vehicles on fire," said Queens District Attorney Richard A. Brown in a statement. "His actions led to the allocation of manpower and resources that could have been spent responding to other pressing matters."

Person, 29, lived in the same area as the fires. He was sentenced by Queens Supreme Court Justice John Zoll to four to eight years in an upstate prison.

The five badly burned vehicles were a 2006 Nissan, a 1998 Mercedes Benz, a 2000 Ford Excursion, a 2009 Nissan, a 2014 Mercedes Benz, a 1998 Honda Civic, a 2003 Mitsubishi and a 2008 Kia and a 2004 Buick.
