Annual Worst Landlord List Features 9 Queens Property Owners And Agents

They own or manage clusters of apartment buildings in Astoria and a handful of sites in Ridgewood. There are slumlords neglecting their duties in Richmond Hill and others ignoring their tenants in Jamaica.

Together, they account for 5,122 open Housing Preservation and Development violations across 1,258 units in Queens and elsewhere in New York City.

The nine Queens landlords included on Public Advocate Letitia James' 100 Worst Landlords List share something else in common: They're hard to reach — especially when shielded by various LLCs, usually one for each derelict building they own or manage.

None of the nine Queens slumlords included on James' list responded to the *Eagle's* requests



A 16-year-old high school junior died on Wednesday afternoon during basketball practice inside his Flushing high school, police

Lenny Pierre was with his teammates at John Bowne High School when he went into cardiac arrest around noon. The Wildcats were preparing for the Queens Jam Christmas Classic tournament game at the school on Saturday against the Bronx's Monroe Campus High School, according to the MaxPreps website.

School staffers immediately called police and when they arrived at the school on Main Street, the 6-foot, 6-inch varsity basketball player who wore the No. 31 jersey, was unconscious and unresponsive.

Pierre, a Jamaica resident, was taken to New York Presbyterian Hospital-Queens where he was pronounced dead.

"This was a tragic loss, and my heart is

with this student's family, team, and school community," said Schools Chancellor Richard A. Carranza. "We will provide additional guidance counselors and support to this school community for as long as it is needed, and we are working with NYPD and agency partners as

they conduct a thorough investigation."

The city's medical examiner will determine Pierre's cause of dead as the investigation is

No one answered the phone at the school when contacted Wednesday afternoon.

Pierre also played junior varsity basketball and participated in indoor and outdoor track and field sports for the school, according to the Public School's Athletic League (PSAL) website.

Mayor Bill de Blasio issued a statement to mourn Pierre's death.

"I am heartbroken to hear of Lenny Pierre's passing. As a parent, and as a father of student athletes, I can only imagine the pain and sorrow being felt by Lenny's family, loved ones and classmates," de Blasio said. "On behalf of 8.6 million New Yorkers, I extend our deepest condolences. We will be with this family now and in the future as we mourn the loss of one of our City's children."

A fire that ripped through an apartment in St. Albans late Wednesday night killed a 16-year-old girl and seriously injured two others inside the home.

Firefighters rushed to the third-floor of a Merrick Boulevard apartment where Lamonies Smith, her 56-year-old mother and 76-year-old neighbor were removed, police said.

All of the women were taken to NYC Health + Hospitals/Queens where 16-year-old Smith was pronounced dead.

"On behalf of the 27th District, I wish to extend my condolences to the family of Lamonies Smith, and pray for her mother's recovery as well as all injured in last night's deadly blaze. My thanks to our bravest @FDNY whose quick response prevented the further loss of life," wrote Councilmember I. Daneek Miller on his Twitter account.

Smith's mother is in critical condition and the neighbor is in serious condition at Jamaica Hospital Medical Center, police said.

The cause of the fire will be determined by the city's Fire Marshal and the city's Medical Examiner will determine the cause of death.

Jobs Outpace Home Production in **Greater New York Metro Area**

The New York Metropolitan area is bouncing back with plenty of jobs post-recession, including some in both Brooklyn and Queens. But there is a lack of housing for this new workforce, according to Carolyn Grossman Meagher of the Department of City Planning.

"New York City is capturing the vast majority of post-recession economic growth," said Meagher, director of regional planning for the DCP, at a Queens Borough Board Briefing on Monday.

"It is supported by not just strong growth in Manhattan, but strong growth in employment in all the five boroughs."

Manhattan brought in approximately 269,000 of those private jobs, but the other boroughs combined brought in approximately 313,000 private jobs, according to Meagher. The most significant gains were from Brooklyn (169,000) and Queens (98,000)

The entire metro region, which includes the Hudson Valley, north New Jersey, Long Island, southwest Connecticut and New York City, brought in approximately 778,495 private jobs between 2008 and 2017, according to the NYC Planning re-

Long Island and northern New Jersey fell close behind the outer boroughs by bringing in an additional 71,000 and 82,000 private jobs, according to the report.

"We are a highly complex region, but as we all know [New York City is] the big gorilla surrounded by much, much smaller areas," said Meagher. "We are also a region of 9 million households ... and New York City is just under 40 percent for housing in the region."

In a summary snapshot of Queens, the borough had 857,157 housing units in 2017, which was approximately 9 percent of all housing for the New York Metro region. From 2010 to 2017, there were 36,985 housing permits and a net housing gain of 22,030.

In 2017, Queens had a population of 2,358,582, according to the snapshot. The borough saw an increase of 127,860 residents from 2010 to 2017.

In comparison, private employment growth for the borough was 98,455, according to the snapshot. Those included office jobs (14,559), institutional jobs (36,245), industrial jobs (10,124) and retail/service jobs (30,724).

People in Queens are now also seeking work outside of Manhattan and Brooklyn, according to Meagher.

"A lot of Queens residents are headed to Long Island, New Jersey and the Hudson Valley for work," said Meagher. "That change in labor force and where we are seeing employment go is creating some geographic imbalances, which have real implications on our transit infrastructure and how we manage that in the future.

New York City and northern New Jersey are adding to housing production, but other parts of the metro area have slowed down in terms of development, according to Meagher.

"New York City is growing along in housing and jobs, but more so in jobs overall," said Meagher. "We are growing jobs faster than we are housing ... and North Jersey is really becoming the location of choice for people who want to work in New York City, but can't live here ... while Long Island is drawing in workers from Queens, which is affecting our commuter numbers.

Guyana Judge To Decide Next Step In Teen's Murder

It's been more than two years since five Guyanese nationals were charged in connection to the murder of an aspiring teen filmmaker from London with family ties in Brooklyn and Queens. Today, the judge presiding over the pretrial hearings will decide if there is sufficient evidence to move the case over to a higher court and go to trial.

In October 2015, Dominic Bernard planned a trip from Epsom, England to Guyana, South America to not only learn about his family's heritage, but to capture it on camera. Bernard dreamed of becoming a filmmaker, his family said.

Bernard, 18, packed up his film equipment, carried \$2,000 in cash and made plans with his godbrother Aaron Hing to pick him up from the airport for the three-week vacation. The teen bid his parents Linda and Andrew goodbye, but did not return home on Nov. 5, 2015, as expected.

'My son's grave was dug and waiting for him — literally — before he left London to go to Guyana," the victim's mother Linda, 54, told the *Eagle* from Guvana. "His murder was planned."

In January 2016, Bernard's decomposing body was found in a shallow grave. He suffered a skull fracture and broken neck, according to BBC News.

Hing, 24, and Staymon George, 25, were charged with Bernard's murder in February 2016. Three others — Krystal Thomas, 22, Sisanie Henry, 41 and Jahmil Sinclair, 20 — were charged with lesser murder-related offenses for helping Hing and George with burying Dominic's camera equipment and were released on bail.

Hing and George allegedly confessed to the crime.

For three years, Bernard's family — which also has ties in Long Island — has been waiting for justice. They traveled from New York and Europe to attend today's court hearing.

"The judge will decide if the matter moves forward, and we hope the individuals charged will be tried for Dominic's murder," said the family in a joint statement.

If convicted of murder by a jury, Hing and George face the death penalty, according to the laws of Guyana.

Unmeltable Chocolate And Bean-to-Bar: A Cocoa Expert Highlights 3 Sweet Trends

'Tis the season to eat chocolate. And for the chocolate industry, there's nothing sweeter, since this is the time of year when it enjoys a spike in sales and, at least for some, rising profits.

Globally, chocolate and its source, cocoa, are in a moment of dynamism and change. In some cases it's for the worse, as the industry faces the realities of climate change. Other changes, however, are for the better, as cocoa producers, chocolate makers, researchers and even retailers offer creative new ways to interact with this beloved food and the people who bring it to us.

I've been researching and writing about all things chocolate for 15 years, from its politics and geography to its history and culture. Here are three fascinating trends I've been following that are reshaping the industry.

Craft Chocolate Explodes

One of the biggest changes has been the rise of craft chocolate. For most of the 20th century, a few major brands like Hershey's, Mars and Nestle dominated the market. That began to change in 1997, when Scharffen Berger opened its doors in Berkeley, California, and became the first new bean-to-bar maker in decades.

To see how much things have changed, look no further than the Northwest Chocolate Festival, held every autumn in Seattle, which recently celebrated its 10th year. When I became education director for the festival in 2010, I knew maybe a dozen craft chocolate makers to invite. In 2013, the last year I held the role, I surveyed the market and was able to locate 37 bean-to-bar makers operating commercially in the U.S.

Today, there are more than 200.

The rise of craft chocolate has meant a true renaissance. These makers often take an artisanal approach, getting to know their materials well — in this case, cocoa and sugar — and shaping them carefully from bean to finished product. The results are lovingly crafted bars, many of them single origin that showcase cocoa's natural flavor range.

Stories and Labels

With this artisanal market shift has come rising consumer demand for education about chocolate.

My own analysis of the craft market shows that consumers now want more than just a piece of chocolate. They expect makers to also share a story, from who grew the beans to the flavor profile of the finished product.

But this surge in craft chocolate makers and stories can also create confusion at the grocery store.

A visit to a typical sweets section these days reveals dozens of new and attractive chocolate bars stretching down the aisle, bearing a dizzying array of labels: fair trade, direct trade, Rainforest Alliance, IMO Fair for Life, bean to bar, raw, handmade, craft and artisan — to name just a few

Is there any real difference among these claims, or are they all simply marketing hype? And what does it really mean to be artisanal?

By and large, labels do one of two things: say something about a chocolate maker's ethics or its process.

Fair trade, for example, sets a price floor for cocoa. In a market where cocoa's price can fluctuate dramatically, this introduces some budget stability for certified producer organizations, because they know in advance the minimum price they will receive. Fair trade certified organizations also receive what is called the social premium — an amount paid over and above the price for the cocoa, which is reinvested into community development projects or, in some cases, distributed as cash payments to grow-

Direct trade, which Taza pioneered for chocolate, approaches things a bit differently, focusing on maintaining close and mutually supportive relationships with producers over the long term.

As for process, and consumer understandings of it, I examined how new chocolate makers use the term "artisan." An artisan once was a person who spent long years as apprentice to a master, training in a craft, and "graduated" only when that master said the trainee was ready.

Opportunities for apprenticeship vanished in the U.S. because the few chocolate companies that dominated the 20th century guarded their manufacturing secrets so closely. But once

Scharffen Berger began marketing its chocolate as artisanal, the number of makers calling themselves "artisan" grew at an astonishing rate.

In consumer surveys I conducted for this research, I found that people associated the term "artisan" with passion for chocolate making, rather than formal training in the craft. Furthermore, my findings suggested that consumers translate passion into good flavor. So, the word "artisan" seems to sell a delicious chocolate eating experience, which may or may not be true.

I also concluded that terms like artisan are meant to do more than sell a product. The term, and the storytelling that accompanies it, is intended to educate consumers about what makes this chocolate different from mass-produced candies.

For consumers eager to get a story with their chocolate, these labels provide plenty of information. My advice is not to try to learn every story but to follow the ones that you find compelling. The more we learn about the people who bring us chocolate, the more mindfully we can enjoy it.

Melting in our Mouths

One of the main reasons chocolate is so enjoyable and compelling to the human palate is because cocoa butter, the natural fat of the bean, melts at just below our body temperature, at around 93 degrees Fahrenheit. This gives it its distinctive mouth-feel, covering our taste buds thickly and evenly.

But it's also a major headache for chocolate makers and retailers

because it means their wares are susceptible to melting into mush in hotter regions and during the summer. And so the industry has been hard at work for decades on creating chocolate that doesn't collapse in the heat.

The effort began in 1937, when Hershey's developed a heat-resistant bar for the U.S. Army, which resulted in over 3 billion Field Ration D units being distributed to solders during World War II.

More recently, in 2015, researchers at Penn State's College of Agricultural Sciences announced their discovery of the gene that determines cocoa butter's melting point. If this gene can be manipulated, it may mean another route to heat-resistant chocolate.

Today, Barry Callebaut, the world's largest chocolate maker, reportedly makes a bar that remains stable at up to 100 degrees Fahrenheit. Nestle, Hershey and Mondelez also have heat-resistant projects that aim to conquer the melt problem while maintaining the mouthfeel.

For the company that solves this challenge, and still keeps chocolate feeling silky smooth, the prize will be enormous: vast new potential markets throughout Africa, the Middle East and Asia.

And for consumers, the result may one day be a planet covered in chocolate — sharp and square, in its most pleasing form, and ready to melt where it ought: in our mouths.

for comment, though people in their offices occasionally spoke up.

"It doesn't make any sense," said Esther, the woman who answered the phone at J. Wasser, where Matt Levi, the city's 11th worst landlord, works. Esther declined to give her last name. "People like to say things about every property management office."

Levi manages 11 buildings on the list, including a six-unit residence at 1645 Summerfield Street in Ridgewood that has 40 open HPD violations. The woman said the list was misleading and was based on negative portrayals of property management companies.

The woman said the Worst Landlord List unfairly targeted Levi and her company.

"He's not actually a landlord. We don't have a landlord. We are the management company and we manage millions of different buildings," the woman said. "He's the person who signs leases, he does rents."

Isaac Azoulay — number 64 on the list — manages 42 units across four buildings, including a residence at 97-51 104th Street in Richmond Hill and another at 108-01 91st Avenue in Ozone Park.

A company called Azoulay & Weiss LLP shares an address with IDBSM Holding Group LLC, a company listed as the owner of one of Azolay's Brooklyn buildings. The Azoulay & Weiss LLP website features a "stop eviction" feature, which links to a contact form.

Yet, seven tenants were evicted from Azoulay's 42 units, according to the Worst Landlords List.

The person who answered the phone at Azoulay & Weiss gave the *Eagle* Azoulay's email address. Azoulay did not respond to request for comment as of press time.

CUNY Associate Law Professor John Whitlow, a tenants' rights advocate, told the Eagle that the list serves as a useful starting point for identifying problem landlords and holding them accountable for their violations. It's up to the local government to follow through on punishing the landlords, he added.

"The list serves a useful purpose in drawing attention to who the bad actors are and hopefully it facilitates tenant organizing across buildings or in portfolios of buildings owned by these landlords," Whitlow said. "Publishing this list is a good step, but the city and state need to do more to make sure that no tenant has to deal with chronic violations."

So far, inclusion on the list has not stopped Eric Silverstein from following in his father Larry's footsteps. Eric was named New York City's number one worst landlord by James. His father received the dishonor in 2015 and 2016.

Eric Silverstein owns Hillside House, a 119-unit building in Jamaica. In June, tenants organized and took Hillside House Management LLC. to housing court.

An employee for Hillside House Management LLC. hung up the phone when asked about the Worst Landlord List title.

A person, who answered the phone at Metropolitan Pacific Properties, which manages several properties

in Astoria, also dismissed a question about the Worst Landlord List.

"I have no idea what you're talking about," the woman said when asked about Debbie Vasquez, a Metropolitan Pacific Properties manager and the third-worst landlord in New York City.

Vasquez's properties account for 1,174 open violations across 9 buildings on 33rd Street and 35th Street in Astoria.

Ursula Niarakis, the city's 73rd worst landlord, did not respond to request for comment either. But tenants at one her Flushing properties have shared their discontent online.

"I have been living @39-06 114th Street since Feb.1,1981 and since I have been residing here it has been quite an expirence (sic) in 35yrs. (sic)," wrote one tenant on apartable.com. "So much has occurred here it is really to (sic) much detail to go into. But it has been something and if I was looking for an apartment I would not look at 39-06 114th Street with all

the infractions that there are. But there is a need for repairs to be done But the owner refuses to put out any monies for repairs. We here deserve to live comfortable and problem free."

Albert Dweck — number 44 on the list — did not respond to request for comment when contacted by the Eagle. Dweck is the CEO at Duke Properties. He is also a professor at the "Real Estate Institute at NYU," according to his bio on the company's website. However, he is not included on the faculty list on the New York University Schack Institute of Real Estate website. The NYU Schack Institute was closed for winter break when contacted by the Eagle Thursday.

Dweck is linked to four Ridgewood buildings, each owned by four different LLCs. The four buildings account for 246 open HPD violations.

A spokeswoman for David Eshagoff — number 78 on the list — said someone from the officer would call the *Eagle* to provide comment. As of press time, no one from the office had called.

Eshagoff's 48-unit building on Winchester Boulevard in Jamaica has 118 open HPD violations.

The person who answered the phone at a business owned by Ursula Niarakis, the 73rd worst landlord in the city, said she would pass on a message to Niarakis.

Niarakis' 70 unit property on 114th Street in Corona has 283 open HPD violations.

No one answered the phone at a number linked to Essen Realty Entreprises, whose manager Maria Sgorous was ranked the 54th worst landlord in the city. Sgorous' two properties on 153rd Street in Murray Hill account for 317 open HPD violations.

Two Queens buildings managed by Ronald Swartz accounted for — ranked as the 38th worst landlord — accounted for 132 open HPD violations. The person who answered the phone at Swartz's law office said he would pass on a message to Swartz.

As of press time, Swartz had not yet contacted the *Eagle*.

With a Boost from Queens, Democrats Take Back the State Senate

For the first time in nearly a decade, Democrats will control the state Senate. State Sen. Michael Gianaris from Astoria chaired the Democratic Senate Campaign Committee, which navigated the party to victory.

Gianaris was also named Deputy Senate Majority Leader.

Four other Queens state senators, including two freshmen, were picked to chair committees or subcommittees in the upcoming legislative session, which begins next month.

State Sen.-elect Jessica Ramos will chair the Labor Committee, where she said she plans to focus on workers' rights, labor organizing and the wage gap.

"Income inequality is the challenge of our time and collective bargaining the people's weapon of choice. Work binds us together, raises families, and builds communities," said Ramos, who defeated the late-State Sen. Jose Peralta in the Democratic primary. incoming Chair of the Senate Labor Committee, I want to make it abundantly clear that our mission is to harness and strengthen worker power. We will lift the floor and we will swell the ranks – protecting our immigrants, working moms, and every New Yorker."

State Sen.-elect John Liu, the other Queens freshman, will chair the New York City Education Subcommittee. Liu is a the former New York City comptroller.

State Sen. Leroy Comrie will chair the Corporations, Authorities and Commissions Committee and State Sen. Joseph Addabbo will chair the Gaming, Racing and Wagering Committee.

The Homelessness Crisis Persists in Queens

As winter sets in and temperatures drop, homeless Queens residents have again started seeking shelter inside Queens courthouses, their presence highlighting New York City's deep homelessness crisis, court staff and union representatives told the *Eagle* last week.

Overall, there were 60,602 people — including 22,284 children — staying in city shelters on Christmas Day, according to the most recent daily census report published by the Department of Homeless Services.

Queens Community Districts 12 and 13 account for a significant amount of the city's homeless population.

On Aug. 31, 3,264 individuals staying in Department of Homeless Services (DHS) shelters reported a most recent zip code inside Queens CD12, according to data provided by DHS. CD12 includes much of Jamaica, Hollis, St. Albans, South Ozone Park and

Point but have faced intense backlash from several Queens council members and community organizations.

Councilmembers Robert Holden, Eric Ulrich and Paul Vallone have all publicly opposed new shelter development in their council districts.

In a July interview, State Sen. Joseph Addabbo, Jr., who represents Ozone Park, told the *Eagle* that he and other residents demand more community input when it comes to siting homeless shelters in residential areas.

"You get the phone call saying, 'Oh, you're getting [a shelter]' and there's no community input. This creates the animosity," Addabbo said. "It's no way to treat a homeless person looking for help and it's no way to treat middle class people trying to make ends meat and own a home."

Community District 13 accounts for the next highest number of homeless New Yorkers utilizing city shelters of Queens district, but the district accounts for less than half the number of homeless individuals as CD12. On Aug. 31, 1,587 individuals had reported most recent zip codes inside CD13.

DHS have attempted to develop shelters in Ozone Park, Glendale and College resides in a Manhattan shelter and works for Picture the Homeless, said she understands the pushback from community members who do not want a shelter near their homes, but she wants to see that not-in-my-backyard energy channeled into a movement for more affordable housing.

"At the end of the day, homeless people don't want to see shelters built, we want to see extremely low-income housing built," Lucas said. "It's ridiculous to build shelters

when people just really need a place to live."

Taxi Drivers Fight for City Support

During the past year, at least eight yellow cab drivers, many of whom lived in Oueens, committed suicide.

Each faced crushing debts related to the decline in the value of taxi medallions since the surge in ride-hailing app vehicles like Uber and Lyft throughout New York City.

In August, the City Council passed a slate of bills to enact

the first for-hire vehicle cap. The legislation limit the number of for-hire vehicles to the current number of cars so that the city can study the impact of the industry.

"Powerful corporations have increasingly taken control of our economy and, in many ways, of our democracy, for their own financial gain. But this moment shows that massive wealth and power does not always prevail," said Deborah Axt, co-executive director of Make the Road New York. "This moment shows that workers, their organizations, and the brave and clear-minded elected officials who have their backs, can still win. And we must continue to win for the working people of this city."

Mayor Bill de Blasio also signed off on the measures.

"Our city is directly confronting a crisis that is driving working New Yorkers into poverty and our streets into gridlock," de Blasio said in an August statement. "The unchecked growth of app-based for-hire vehicle companies has demanded action - and now we have it. More than 100,000 workers and their families will see an immediate benefit from this legislation. And this action will stop the influx of cars contributing to the congestion grinding our streets to a halt."

AOC Arrives

In June, Alexandria Ocasio-Cortez surprised many pundits when she defeated incumbent U.S. Rep. Joseph Crowley in the Democratic primary to represent New York's Congressional District 14, which includes parts of Queens and the Bronx.

Ocasio-Cortez has energized progressives and socialists across the country and has championed a Green New Deal to shift the United States to renewable energy sources and tens of thousands of new jobs.

Crowley remains the influential chair of the Queens Democratic Committee.

DeGrom Wins the 2018 NL Cy Young

Mets ace Jacob DeGrom took home the 2018 National League Cy Young Award after one of the best seasons in Major League Baseball history.

DeGrom finished the city with a 10-9 record and led the league with a 1.70 earned run average. He issued just 46 walks and 10 home runs while striking out 269 batters.

In addition to dominating hitters, DeGrom dominated the Cy Young voting, earning 29 of 30 first place votes.

Are There Greener Wall-to-Wall Carpeting **Options**?

Carpeting is an oftoverlooked culprit when it comes to compromised indoor air quality, but the chemicals used to produce it are typically far from natural. According to the non-profit Environmental Working Group (EWG), most carpeting is made from synthetic fibers derived non-renewable petroleum-based sources and emits harmful volatile organic compounds (VOCs) into the air.

Meanwhile, carpet backing is typically made from synthetic rubber derived from styrene and butadiene, also respiratory irritants. And that new carpet smell we know so well comes from the off-gassing of 4-PCH, a potent VOC byproduct of the synthetic rubber manufacturing process known to cause respiratory problems, eye irritation and rashes. EWG adds that it can also react with other chemicals to produce formaldehyde, a known human carcinogen.

Likewise, the glues and sealants used to install most wall-to-wall carpeting come chock full of more VOCs and in some cases, toxic petroleum-based solvents. To add insult to injury, waterproofing and anti-microbial treatments

now common in everyday carpeting have been linked to cancer, birth defects and hormone disruption.

Last but not least, carpet padding is typically made from scraps of polyurethane recycled from older furniture and mattresses and as such likely contains carcinogenic chemical flame retardants now banned in new furniture.

Well that's all well and good, but what choices do we have? Actually, lots.

Carpeting labeled with the Carpet & Rug Institute's "Green Label Plus" or UL Environment's "Greenguard" emit low amounts of VOCs and as such are safer for you and your family. Wool is the most common eco-friendly choice, but jute and cotton varieties are coming on strong. Stay away from stain fighting, waterproofing or antimicrobial treatments. For carpet padding, go with felt rather than synthetic rubber. And make sure to use low-emitting, non-solvent adhesives and/or fasteners during installation.

No matter what kind of carpeting you end up with, make sure to vacuum it regularly - the American Lung Association recommends at least 3x/ week with a HEPA filterequipped vacuum — to remove dust, allergens and pollutants that you (or your pets) might track in. "Carpets are ... the perfect environment to harbor dust mites, mold and mildew, which are all common allergens," reports EWG.

One way to avoid all of these issues entirely is to forego carpeting altogether and go with tile, wood, cork or natural linoleum flooring with low-VOC sealant. They don't off-gas VOCs or harbor allergens and pollutants, and they're easy to clean while lasting decades longer carpeting anyway. Throw down a few wool area rugs (easily cleaned outside) and you'll be good — and green — to go.

Now what to do with the old carpeting is another question entirely. Carpeting is difficult to recycle as it's made from multiple components with different chemical makeups, so your local curbside recycling hauler is unlikely to take it away for you.

The non-profit Carpet America Recovery Effort (CARE) is working to develop the infrastructure needed to recycle carpet efficiently across the U.S. In the meantime, you can search on Earth911 for a carpet recycler near you.

Letter: How Can You Decide How Much Punishment Is Enough Without Knowing What the Punishment Is For?

I read the article by David Brand regarding the appeal for clemency of Stanley Bellamy. ("He's been in Prison for 33 Years. Is that Enough?", Queens Daily Eagle, Dec. 14, 2018). In an article that took up a full page of newsprint, approximately 1,500 words, the only mention of the crime Mr. Bellamy committed was:

"Bellamy got caught up in crime. In 1985, at age 23, he was charged with murder and sentenced to 62 1/2 years in prison."

Not a single word about the victims, and a mere 23 words used to describe why a man was sentenced to 62 ½ years in prison. What was omitted from the article was what he did to deserve that sentence. Here are the facts:

On Oct. 11, 1985, at approximately 9 p.m., Gary

his 1978 Cutlass Supreme to the defendant's home. In the car with Owens, was Dwayne Morrison, also 20 years old. They picked up the defendant, along with Joseph Bellamy and William Riley. William Riley, Joseph Bellamy and the defendant got into the car and sat in the rear seats. They drove around to several locations and eventually Riley, Joseph Bellamy and the defendant got out of the car and stood outside the vehicle talking, while Owens and Morrison stayed in the car. Suddenly, the defendant put a gun to Morrison's head and threatened to shoot him unless he and Owens did what he told them to do. The defendant ordered Morrison and Owens into the back seat, and Joseph Bellamy joined them, pointing a gun at Owens, while the defendant pointed a gun at Morrison. Riley drove the car. The defendant told Owens and Morrison to turn over all their money and jewelry, threatening to kill them if they did not obey. They complied. Defendant then ripped a medallion off of Owens' neck.

Riley drove around for 25 minutes, while the defendant threatened to kill Owens and Morrison if they found any additional money on them. Eventually, Riley stopped the car under an overpass in a remote area of Cunningham Park and the defendant ordered Owens and Morrison to get out of the car and stand against a wall, telling them he wanted to frisk them to see if they had any additional money or jewelry on them. Owens and Morrison stood against the wall with their hands raised. Joseph Bellamy walked over to Owens and shot him once in the head at close range. Morrison, upon hearing additional shots ran

away. As he ran, he was hit three times in the back and buttocks with bullets. He came upon an ambulance and was taken to the hospital. He survived. Owens died 16 days later from the gunshot to the head. The three defendants drove away in Owens' car and left it in the parking lot in Cunningham Park.

The defendant was tried

The defendant was tried before a jury and convicted of, among other things, Murder 2d degree, Attempted Murder, 2d degree, and two counts of Robbery in the First Degree. He was sentenced to 25 years to life for the murder and, because he had two prior felony convictions (one for robbery, one for a gun), he was sentenced to 12 ½ to 25 years for the attempted murder and for each of the two robbery convictions, all sentences to run consecutively. His two co-defendants received similar sentences.

The arguments for clemency for the defendant may be legitimate, but any fair article concerning clemency should recount some facts about the crime the defendant is in jail for, and give information about his background, in order to put his 62 ½ year sentence into context. At the very least, the article should give the names of his victims and inform the reader of the terror inflicted on them and of how Mr. Owens died

At the end of the article there is a note:

"This article is Part One in a series about criminal sentencing and clemency for people convicted of violent crimes."

I would hope that future articles put in perspective what acts led to the defendant's incarceration. Yes, Stanley Bellamy has been in prison for 33 years — but Gary Owens' family has been without him for the same 33 years, and what lasting impact was there on survivor Dwayne

Morrison?

The reader may well decide that 33 years is enough, but that should be an informed decision based on a full disclosure of the facts.

Legal Aid Campaign Brings Books to Kids in Court

The Legal Aid Society announced on Thursday that it had started a new campaign alongside book publisher Penguin Random House called, "Let Them Read," which will bring books into courtrooms for kids to read while they wait for their cases to be called.

The program will begin in the Brooklyn Adolescent and

Young Adult Diversion Court, which serves teenagers and young adults aged 16-24. The young people will have access to approximately 200 books to read in the courtroom. They are also allowed to keep the books.

"What better way to help stimulate a mind in a positive way than to provide a book," said Hon. Craig S. Walker, Presiding Judge of the Criminal Term Youth Part, Kings County Supreme Court. "It may seem like a small and meaningless gesture to some, but if we want these young people to aspire to do better, we need to provide them with the right tools in order for them to achieve their goals. That starts right there, in the Courtroom. I only hope that this can be a model that other courtrooms might start using in the future."

Legal Aid said it plans

to expand the program to courthouses across the city, including the Queens Criminal Court. Legal Aid also said it hopes to help students forced to miss school to attend school.

"Giving semeone a book

"Giving someone a book is giving them the opportunity to learn something new," said Noor Ahmad, Staff Attorney the Brooklyn Trial Office at The Legal Aid Society. "At any age, but especially during your adolescence, that knowledge has the power to change what you believe is possible not just for yourself, but also for the world to which you are connected. For our clients, this has a unique significance."

The books already donated by Penguin Random House include "Between the World and Me" by Ta-Nehisi Coates, "Just Mercy" by Bryan Stevenson, "Born a Crime" by Trevor Noah, "Decoded" by Jay-Z and "Fresh Off the Boat" by Eddie Huang.

"We at Penguin Random House are so pleased to support the vital work of the Legal Aid Society and this very important pilot," said Madeline McIntosh, Chief Executive Officer, Penguin Random House. "We look forward to providing Legal Aid with books for the collection at Brooklyn's Youth
