DR. ZHI ALAN CHENG FROM ASTOria was arraigned on Thursday on an indictment charging him with sexually abusing a patient at NewYork-Presbyterian Queens hospital, Queens District Attorney Melinda Katz says. Cheng was previously indicted in August 2023, accused of sexually abusing three patients in the hospital and drugging and raping three other women in his Queens home, as well as filming each of the assaults. He had also been indicted in December 2022 for allegedly raping a female acquaintance in his apartment. The latest indictment comes after another victim came forward. In all, more than 60 charges have been filed against Cheng. He faces multiple 25-years-tolife sentences if convicted. "What we have heard from the victims and seen in the videos is the shocking and horrifying exploitation of women at their most vulnerable," said Katz. "Taken together, the evidence details the repeated attacks of a sexual predator who time and again betrayed his sworn professional oath and the trust of women who were unable to defend themselves.

A 33-YEAR-OLD MAN HAS BEEN ARrested for stabbing a man to death in an attack over drugs in Jamaica in 2022, the Daily News reported. Maurice Smith was arrested by U.S Marshals after he was identified as the suspect in the killing of 31-year-old Talil Maddox, who was murdered on Merrick Boulevard in February of 2022. Another man sustained a gunshot wound in the same incident and said that Smith choked him before he was shot. Smith has been charged with the physical attack, but not the shooting. Smith was charged with murder, strangulation, weapon possession and tampering with evidence, although cops did not immediately disclose what the tampering charge was for. His arraignment in Queens Criminal Court was pending Thursday.

AN ASTORIA CONVENIENCE STORE sold a \$1 million Powerball ticket during Wednesday night's drawing, PIX 11 reported. The winning ticket was bought at Avadh Convenience Store in the Western Queens neighborhood. The jackpot for the next drawing is \$600 million.

IN JUPITER, FLORIDA, THE METS tied 0-0 in a spring training matchup with the St. Louis Cardinals, but Mets pitchers combined for 14 strikeouts in the game, Metsmerized reports. José Buttó threw four scoreless innings, and struck out three hitters, Adam Ottavino struck out two when he came in for a 1-2-3 fifth inning. Austin Adams took over in the sixth, striking out the side on just 10 pitches. For the final three frames, Yohan Ramírez and Tyler Jay threw for the Mets, striking out two a piece and keeping the game a scoreless tie.

Court dismisses Floyd Bennett shelter case brought Queens pol

A Brooklyn judge this week tossed out an effort from Queens and South Brooklyn lawmakers to get the city and state to shut down its migrant tent shelter at Floyd Bennett Field.

Judge Peter Sweeney from Kings County Supreme Court, Civil Term issued the ruling to throw out the injunction on Wednesday, saying the court found the petitioner's arguments to be "unavailing" across the board.

The case was filed in September of last year following the announcement from the city and the state that they would be using Floyd Bennett Field - which was once a naval base - to house 2,000 migrant families with children. The challenge to the shelter was brought by Queens Councilmember Joann Ariola, Brooklyn Assemblymember Jaime Williams and a number of community members in both lawmakers' districts.

In his 35-page decision, released publicly on Thursday, Sweeney one by one shot down the petitioner's arguments, including the idea the filers had the right to argue the case at all.

Sweeney ruled that the case was a "political dispute" and not centered around the financial, tax-based reasoning the petitions argued.

"It is clear that the dispute between petitioners and the state and city respondents over the migrant shelter at Floyd Bennett Field is not about the fiscal activities of either entity," court

documents say. "Indeed, no one disputes that the state and city have the authority to spend funds to establish [shelter] for the homeless population."

"The petitioners have failed to meet their threshold burden of establishing they have standing to maintain this proceeding," he con-

Sweeney also argued that the petitioners themselves could not prove that they were harmed by the use of Floyd Bennett Field as a migrant shelter site.

The court called the assertion there would be an impact to essential services or environmental impacts to the site or the petitioner's Continued on page 16

As budget negotiations in Albany head into their final weeks, lawmakers and advocates rallied at the state's capitol to call for the governor and legislature to fund efforts to expand Right to Counsel programming statewide.

Though New York City has struggled to fully implement its Right to Counsel laws in the five boroughs, advocates say that in addition to fully funding the program in the city, the state should make an effort to broaden the tenant protection statewide.

In that vein, both the Assembly and the State Senate committed to a statewide Right to Counsel program and additional funding for legal services providers in their one house budgets this week.

The bill establishing a statewide Right to Counsel program is sponsored in the Senate by State Senator Rachel May and is co-sponsored by Queens State Senators Michael Gianaris, Kristen Gonzalez, Leroy Comrie, John Liu, Jessica Ramos, James Sanders and Toby Ann

The bill would establish a right to free legal representation for tenants facing eviction anywhere in New York. Phased in over five years, the statewide program wouldn't have the same income restriction that the city's program currently has - a household of four needs to earn less than \$60,000 a year to qualify.

The legislation, which would also create an "Office of Civil Representation," also calls for \$500 million in funding per year once the program is fully implemented.

Standing on the steps of the capitol this week, advocates and lawmakers called for \$260 million to be included in the state's budget which is due April 1 - to fund the first year of

Wanda Martinez, a tenant leader at Catholic Migration Services and a Queens resident, led the rally in Albany on Wednesday.

"As a long-time Queens tenant, I can attest to the fact that housing insecurity has become a major issue for many of us," Martinez said. "The lucky ones are able to stay in their homes because of the protections that Right to Counsel offers. Our statewide Right to Counsel legislation would further protect and enforce our rights in New York City.'

The city's Right to Counsel law first went into effect in 2017. It was initially limited to 25 New York City zip codes, including five in Queens.

But just as the city was gearing up to expand the program citywide, the pandemic began.

With a moratorium on evictions, the law wasn't put to much use in 2020 or 2021.

However, in late 2022, when the program

was officially expanded citywide and the moratorium on evictions was lifted, the program started to show signs of struggle.

In addition to the influx of cases filed post-moratorium - both new cases and cases that were paused during the pandemic - staffing shortages in public defender firms have put a strain on the program, which has largely been unable to meet demand.

Several times in 2022, public defender firms halted intake for the program.

In January 2022, when the program was expanded citywide, around 65 percent of tenants facing eviction proceedings had an attorney within the first week of proceedings, according to data collected by the Right to Counsel NYC

Nearly every month after in the first year of the program, that number dropped. By December 2022, around 35 percent of tenants had representation within the first week of their case, Right to Counsel NYC Coalition data shows.

Throughout the past two years, civil legal services providers called on the Office of Court Administration to slow the calendering of cases so that all tenants who qualify could be connected with an attorney. However, that request was repeatedly denied.

Only recently has the number of tenants connected to a lawyer within the first week of their proceedings begun to go up.

In September 2023, around 18 percent of tenants had a lawyer during their first week of eviction proceedings – an all-time low since the citywide implementation of Right to Counsel. By December 2023, that number had risen to around 53 percent, according to the Right to Counsel Coalition.

But advocates have blamed the program's struggles on inadequate funding from the city and have said that despite the city's inability to connect tenants with attorneys, whenever they do, the program works.

In cases where tenants were represented by an attorney, cases ended without an eviction around 84 percent of the time, the coalition says.

Consistently, around 95 percent of landlords have legal representation during eviction proceedings.

'What we found in New York City is when tenants have attorneys, they don't get kicked out," said Manhattan Assemblymember Linda Rosenthal. "They have a discussion with the landlord's attorney and there's an agreement, there's a stipulation - 'Okay, we will take your rent in smaller amounts, but you are a good tenant, we will not kick you out.' There's no opportunity for that outside New York City."

Walgreens sued for price gouging baby formula, now must donate to NYers

Attorney General Letitia James announced a resolution involving Walgreens on Wednesday after an investigation into the company's pricing of baby formula during the 2022 shortage.

The settlement includes a donation of 9,564 cans of baby formula, valued at \$200,000 wholesale, and a \$50,000 penalty to address allegations of price gouging.

During a nationwide shortage exacerbated by supply-chain issues and a major recall by formula manufacturer Abbott Laboratories, Walgreens was found to have significantly increased the prices of at least 20 infant formula

The AG's investigation was initiated after consumer complaints about the high costs of essential baby formula.

"Baby formula is the main source of nutrients and absolutely essential for thousands of our most vulnerable residents, our infants,' James said. "During the formula shortage, families were panicked and struggling about how to feed their babies. For Walgreens to take advantage of this crisis and jack up formula prices is not only illegal but downright shameful."

As part of the settlement, Walgreens has agreed to donate the baby formula to the Met Council in Queens, FeedMore WNY and the Buffalo Prenatal Perinatal Network in Erie

These organizations are tasked with distributing the formula to families in need

across New York.

"The thousands of baby formula cans secured by my office will go directly to help New York families who need it most," James

added. "Today's agreement should also send a clear message that my office will not tolerate

Symposium on structural racism in New York hosted by State Bar Association

The New York State Bar Association and Albany Law School are set to host a symposium focused on the historical impact of structural racism in New York later this month.

Scheduled for March 20 at Albany Law School, the event marks a collaborative effort between the bar association's Task Force on Racism, Social Equity and the Law and the Government Law Center at the school. It aims to shed light on the discriminatory laws and policies that have perpetuated disparities across various facets of life, including education, healthcare, employment and access to voting

Richard Lewis, president of the New York

State Bar Association, emphasized the importance of this initiative, noting, "Sixty years after the Civil Rights Act was passed, we are committed to addressing and eliminating discriminatory practices that hinder equal access to fundamental rights and opportunities."

The symposium will feature discussions on the enduring effects of structural racism on wealth equity in relation to housing, health, and education within the state.

The event will also highlight the recommendations from the New York State Bar Association's Task Force on Racism, Social Equity and the Law made in a recent report regarding racism and its effects in the state's legal community. Kapil Longani, senior vice chancellor for legal affairs and general counsel at the State

University of New York, will deliver the keynote address, underscoring the significance of legal and educational institutions in combating systemic injustices.

Participants will include a broad range of experts and leaders, including Lewis; Cinnamon Carlarne, president and dean of Albany Law School; and Julia Iyasere, senior vice president of health justice and equity at New York Presbyterian.

Also featured will be Judge Leslie E. Stein. director of the Government Law Center at Albany Law School, and Clotelle L. Drakeford, from The Legal Aid Society of Westchester County.

Concluding remarks will be delivered by T. Andrew Brown, a past president of the New York State Bar Association.

any company that attempts to price gouge our state's consumers.'

The case against Walgreens stemmed from a broader effort by James to enforce New York's price gouging laws, which prohibit excessive price increases on essential goods during abnormal market disruptions.

This settlement follows similar actions taken by the AG's office, including a \$100,000 settlement with Quality King Distributors Inc. for Lysol price increases during the COVID-19 pandemic and the delivery of 1.2 million eggs to food pantries from a settlement with egg producers.

Eviction filings highest among private managers of NYCHA buildings

Private sector managers running city-owned public housing developments dramatically accelerated the number of eviction proceedings brought against tenants for non-payment of rent last year, appearing to outpace those filed against residents of developments still run by the housing authority.

Both NYCHA and the private entities managing public housing properties under a federal program known as Rental Assistance Demonstration (RAD) halted pursuing evictions in spring 2020, when the pandemic struck, and didn't resume until the COVID-triggered rent moratorium expired in January 2022.

Over that time period, NYCHA had suspended 31,000 pending eviction cases.

In 2022 both NYCHA and the private management companies resumed initiating eviction proceedings against residents, starting with a limited number of filings against tenants who owed significant back rent. But last year both NYCHA and the RAD management firms began to file more proceedings, with the private sector companies appearing to be more aggressive.

The management firms, which currently oversee about 18,400 public housing units under RAD, initiated more than 3,000 eviction proceedings against tenants from January through September of last year, records released this week by the housing authority show.

NYCHA, by comparison, manages about 166,000 units yet initiated 2,300 cases during all 12 months of last year, a review of records obtained by THE CITY found.

That puts the rate of eviction proceedings in RAD complexes at that time at about one initiated case per six apartments — compared to NY-CHA's rate of about one initiated case for every 72 apartments.

'Living Under a Cloud'

To be clear, nearly all of these eviction notices resulted in tenants agreeing to financial settlements to address at least some of what they owed without actually being physically evicted. In fact, there have only been 34 actual evictions in RAD households and 110 in NYCHA-run developments since the pandemic rent moratorium ended, records show

Nevertheless the mere receipt of an eviction notice for many tenants — after months during the pandemic when they were told they did not have to pay - has caused much anxiety in both NY-CHA and RAD housing developments.

The person is constantly living under a cloud of being evicted or you have to go back to NY-CHA and NYCHA says you have to go back to management," said Councilmember Chris Banks, D-Brooklyn, chair of the public housing committee. "The fact that they have to live under this cloud that they could be evicted ... this to me is a major issue that's affecting a lot of the tenants in a serious way."

Banks questioned NYCHA officials about this post-pandemic resumption of evictions during a budget hearing Tuesday. Speaking with THE CITY, Banks said some tenants living in RAD developments have told him, "Management has

been very aggressive when it comes to getting tenants to come into compliance. And some of them are dragging them into court. Much more aggressive than NYCHA..'

The issue of evictions over non-payment has taken on new significance given that so many of NYCHA and RAD tenants did not resume their monthly payments when the moratorium ended in January 2022.


Since then, NYCHA's rent arrears have grown to more than \$480 million across 70,000 households. The authority is now struggling with a collection rate of around 60%, far less than the 95% collection rate they experienced pre-pandemic. (NYCHA does not have figures on how much tenants living in RAD developments owe).

NYCHA CEO Lisa Bova-Hiatt has repeatedly emphasized that the authority tries to avoid evictions and has only sent eviction notices to tenants who have accumulated large unpaid back rent over longer periods of time.

On Wednesday in response to questions from THE CITY, her press secretary Michael Horgan stated, "NYCHA's goal is to keep residents housed and to resolve tenant issues - whether related to nonpayment of rent or lease violations not to evict.'

And because the housing authority still owns all the properties managed by the RAD developers, NYCHA requires those managers to take the same eviction-as-a-last resort strategy "in order to support tenants who may be at risk," he added.

Since the rent moratorium ended, building managers and developers who now manage a cou-

The records make clear that the private-sector actors started out slowly, filing 986 proceedings in all of 2022 that resulted in the evictions of just 10 households. Last year, however, the rate of filings increased, with 3,098 eviction proceedings filed by RAD managers just through September. During that time 24 RAD households were evicted.

Forgiving Millions

No RAD developments have experienced as many eviction proceedings as Linden Houses and the adjacent Penn-Wortman Houses in East New York, Brooklyn, records show. In the first nine months of 2023, 1,648 eviction proceeding cases have been filed by the management company, C&C Apartment Management LLC, an affiliate of L+M Development Partners, a major income-restricted housing builder in New York City.

Before a proceeding is filed, both NYCHA and the management company work to resolve the matter without going to court. At Linden, hundreds of these "pre-eviction outreach" interactions resulted in no court cases, and even with the cases that went to court not a single one resulted in an actual eviction, the data show.

A spokesperson for Stanley Avenue Preservation — a partnership that includes L+M, Dantes Partners, SMJ, and Douglaston Development, that's performing \$430 million in renovations on the two developments — issued a statement in response to THE CITY's questions about how they've juggled the delicate job of trying to collect rent owed without putting people in the street.

They started by forgiving \$1.4 million in rent arrears when the moratorium ended in 2022, but since then many tenants have continued to fall behind. They described the hundreds of cases initiated last year as "non-payment cases, not evictions," and noted the zero eviction result.

We continue to work closely with our on-site staff and local elected officials to do all we can to help our residents remain in their homes as we undertake a critically needed overhaul of Linden Houses," the statement read. "Evicting a tenant is never our preferred outcome, and we work closely with our residents and an on-site social service provider to help residents pay their rent, which helps support ongoing operations at the property."

Another nearby Brooklyn development, Boulevard Houses, had a similar experience. Though Hudson Companies, the private sector firm managing the development, filed 390 eviction proceedings between January and September of last year, only two evictions have resulted in tenants being kicked out.

A spokesperson for Boulevard Together, Hudson's partnership with NYCHA, noted that the developer forgave \$3.7 million in rent arrears from Boulevard tenants. Hudson, which is completing \$600 million in renovations to Boulevard, also works with the nonprofit housing group, CAM-BA, to provide tenants with financial literacy training.

We will continue to work closely with NY-CHA, the residents, and local elected officials as we near the completion of much-needed renovations for this community," a spokesperson for Boulevard Together said in response to THE CITY's questions.

Should Governments Ban TikTok? Cybersecurity Expert Explains Pros, Cons

The U.S. House of Representatives voted 352-65 on March 13, 2024, to require TikTok's parent company, China-based ByteDance, to sell the app or face a nationwide ban on TikTok. President Joe Biden said on March 8 that he would sign the legislation if it reached his desk.

The popular video social media app had 149 million users in the U.S. as of January 2024. Many of them contacted Congress to protest the possibility of a ban.

The bill's fate in the Senate is unclear. It's also unclear whether any resulting legislation would survive a court challenge.

On May 17, 2023, Montana Gov. Greg Gianforte signed legislation banning TikTok in the state, the first total ban by a U.S. state government. The law would impose fines of \$10,000 per day on any app store that offers TikTok and on the app-maker itself if it operates in the state. Individual users would not be subject to penalties. The law was scheduled to go into effect Jan. 1, 2024, but a federal judge blocked it pending a trial to determine whether the state overstepped its authority and whether the law violates the First Amendment.

The federal government, along with many state and foreign governments and some companies, has already banned TikTok on work-provided phones. This type of ban can be effective for protecting data related to government work.

But a full national ban of the app is another matter, which raises a number of questions: What data privacy risk does TikTok pose? What could the Chinese government do with data collected by the app? Is its content recommendation algorithm dangerous? Is it legal for a government to impose a total ban on the app? And is it even possible to ban an app?

Vacuuming up data

As a cybersecurity researcher, I've noted that every few years, a newly popular mobile app raises issues of security, privacy and data access.

Apps collect data for several reasons. Sometimes the data is



used to improve the app for users. However, most apps collect data that the companies use in part to fund their operations. This revenue typically comes from targeting users with ads based on the data they collect. The questions this use of data raises are: Does the app need all this data? What does it do with the data? And how does it protect the data from others?

So what makes TikTok different from the likes of Pokemon-GO, Facebook or even your phone itself? TikTok's privacy policy, which few people read, is a good place to start. Overall, the company is not particularly transparent about its practices. The document is too long to list here all the data it collects, which should be a warning.

There are a few items of interest in TikTok's privacy policy besides the information you give them when you create an account — name, age, user name, password, language, email, phone number, social media account information and profile image — that are concerning. This information includes location data, data from your clipboard, contact information, website tracking, plus all data you post and messages you send through the app. The company claims that current versions of the app do not collect GPS information from U.S. users.

If most apps collect data, why are governments worried about TikTok? First, they worry about the Chinese government accessing data from TikTok's 150 million users in the U.S. There is also a concern about the algorithms used by TikTok to show content.

Data in the Chinese government's hands

If the data does end up in the hands of the Chinese government, the question is how could it use the data to its benefit. The government could share it with other companies in China to help them profit, which is no different than U.S. companies sharing marketing data.





The Chinese government is known for playing the long game, and data is power, so if it is collecting data, it could take years to learn how it benefits China.

One potential threat is the Chinese government using the data to spy on people, particularly people who have access to valuable information. The Justice Department is investigating TikTok's parent company, ByteDance, for using the app to monitor U.S. journalists. The Chinese government has an extensive history of hacking U.S. government agencies and corporations, and much of that hacking has been facilitated by social engineering — the practice of using data about people to trick them into revealing more information.

The second issue that the U.S. government has raised is algorithm bias or algorithm manipulation. TikTok and most social media apps have algorithms designed to learn a user's interests and then try to adjust the content so the user will continue to use the app. TikTok has not shared its algorithm, so it's not clear how the app chooses a user's content.

The algorithm could be biased in a way that influences a population to believe certain things. There are numerous allegations that TiKTok's algorithm is biased and can reinforce negative thoughts among younger users, and be used to affect public opinion. It could be that the algorithm's manipulative behavior is unintentional, but there is concern that the Chinese government has been using or could use the algorithm to influence people.

Can a government ban an app?

The pending Montana law aims to use fines to coerce companies into enforcing its ban. It's not clear if companies will comply, and it's unlikely that this would deter users from finding workarounds.

Meanwhile, if the federal government comes to the conclusion that TikTok should be banned, is it even possible to ban it for all of its 149 million existing U.S. users? Any such ban would likely start with blocking the distribution of the app through Apple's and Google's app stores. This might keep many users off the platform, but there are other ways to download and install apps for people who are determined to use them.

A more drastic method would be to force Apple and Google to change their phones to prevent TikTok from running. While I'm not a lawyer, I think this effort would fail due to legal challenges, which include First Amendment concerns. The bottom line is that an absolute ban will be tough to enforce.

There are also questions about how effective a ban would be even if it were possible. By some estimates, the Chinese government has already collected personal information on at least 80% of the U.S. population via various means. So a ban might limit the damage going forward to some degree, but the Chinese government has already collected a significant amount of data. The Chinese government — along with anyone else with money — also has access to the large market for personal data, which fuels calls for stronger data privacy rules.

Are you at risk?

So as an average user, should you worry? Again, it is unclear what data ByteDance is collecting and if it can harm an individual. I believe the most significant risks are to people in power, whether it is political power or within a company. Their data and information could be used to gain access to other data or potentially compromise the organizations they are associated with.

The aspect of TikTok I find most concerning is the algorithm that decides what videos users see and how it can affect vulnerable groups, particularly young people. Independent of a ban, families should have conversations about TikTok and other social media platforms and how they can be detrimental to mental health. These conversations should focus on how to determine if the app is leading you down an unhealthy path.

Council Speaker Proposes Deed Protections For New York Homeowners, Far-Flung Heirs

Council Speaker Adrienne Adams in her State of the City speech on Wednesday announced efforts to protect homeowners from predatory real estate speculation.

Forthcoming proposed legislation will seek to inform homeowners and those who inherit property of the fair market value of their homes and help them protect their assets through a new assistance program. Details of the efforts have yet to be hammered out.

The planned measures come in response to an investigative series from THE CITY detailing how real estate speculators target properties in New York's gentrifying, historically Black and Latino neighborhoods, typically owned by homeowners who died without wills. The speculators find property that legally belongs to a patchwork of far-flung heirs who may have no idea of the worth of their fractional shares of the property they inherited.

shares of the property they inherited.

Speculators may low-ball heirs for their shares and then, under state law, can go to court to demand a forced sale of the house, which in turn may push out family members who still live there. Or, speculators can attempt to acquire the full property through multiple fractional shares — allowing them to evict longtime tenants and flip the property for many times what they paid.

Such practices can siphon off considerable generational wealth from Black and Latino families and have contributed to New Yorkers of color leaving the city.

Protecting Assets

One piece of legislation Speaker Adams envisions would require housing speculators to disclose the fair market value of properties to owners, in an effort to prevent unsuspecting heirs from accepting lowballed offers.

balled offers.

THE CITY's reporting showed that real estate investors often approach distant heirs with offers to buy the heirs' shares of property, but heirs don't always know that those offers could be for far less

than their market value. Some of the heirs who agreed to sell their holdings told THE CITY they had no idea they were getting a raw deal, and said they felt cheated to learn the speculators flipped properties for several times what they had paid.

The Council has yet to detail how this

The Council has yet to detail how this disclosure would work, including when in the process the fair market value would be determined and by what method.

Property owners already receive some disclosures, but these can be misleading. The "total assessed value," which is used to calculate property taxes, appears on a

state form included in deed transfer paperwork. But that figure is typically much lower than what the property would sell for

Another bill would require the city Department of Consumer and Worker Protection to develop a program to help New Yorkers manage an inherited property and protect their assets. This program would assist people who inherit property in making the decision about whether or not to sell and offer guidance in navigating tenant agreements, property taxes and other processes.

In addition to the legislation, the Council plans to host district-based events offering free legal services to older homeowners to help them prepare wills and work on other aspects of real estate planning. These events will be held in partnership with community organizations and local law schools, specifically focusing on neighborhoods speculators target — typically gentrifying areas with historically Black and Latino populations.

"We want to plan for the successful wealth of our lineage," said Tuulikki Robertson, director of operations for The Black Institute, which has been engaged with the Council in planning these forthcoming events. "There are predators out there and it's important to get your will done."

Prosecutors say they're open to delaying Donald Trump's March 25 hush-money trial for a month

Prosecutors said Thursday they are open to delaying the start of Donald Trump's New York hush-money criminal trial by a month "in an abundance of caution" to give the former president's lawyers time to review evidence they only recently obtained from a previous federal investigation into the matter

The Manhattan district attorney's office said in a court filing that it does not oppose adjourning the trial for 30 days, but said it would fight the defense's demand for a longer delay. Judge Juan Manuel Merchan did not immediately rule.

Jury selection is scheduled for March 25. The hush-monev case is one of four criminal indictments against Trump, the presumptive Republican presidential nominee.

Trump's legal team said it has received tens of thousands of pages of evidence from the U.S. attorney's office in Manhattan in the last two weeks, including records about ex-Trump lawyer Michael Cohen that are "exculpatory and favorable to the defense." Prosecutors contend the newly turned over material is "largelv irrelevant to the subject matter of this case."

Trump's lawyers want a 90-day delay at minimum, but they've also asked Merchan to dismiss the case entirely, alleging the last-minute disclosures amounted to prosecutorial misconduct and violated rules governing the sharing of evidence. That process, called discovery, is routine in criminal cases and is intended to help ensure a fair trial.

Short trial delays because of evidence issues aren't unusual, but any delay in a case involving Trump would be significant, with trial dates in his other criminal cases up in the air and Election Day less than eight months away.

The defense has also sought to delay the trial until after the Supreme Court rules on Trump's presidential immunity claims, which his lawvers say could apply to some of the allegations and evidence in the hush-money case. The Supreme Court is scheduled to hear oral arguments April 25.

Since March 4, Trump's lawvers have received at least 84,000 pages of records from the U.S. attorney's office, including a batch of 31,000 pages on Wednesday, according to a court filing.

records to hide the true nature of payments to his former lawyer and fixer Michael Cohen, who helped Trump bury negative stories during his 2016 presidential campaign. Among other things, Cohen paid porn actor Stormy Daniels \$130,000 to suppress her claims of an extramarital sexual encounter with Trump years

Trump pleaded not guilty last year to 34 felony counts of falsifying business records. He has denied having a sexual encounter with Daniels, and his lawyers argue the payments to Cohen were legitimate legal expenses and not part of any cover-up.

Trump has repeatedly sought to delay the start of his criminal trials.

'We want delays," Trump said to reporters at a pretrial hearing in the New York case on Feb. 15. "Obviously I'm running for election. How can you run for election if you're sitting in a courthouse in Manhattan all day long?"

The deluge of evidence that spurred Trump's lawyers to request a delay pertains to a federal investigation into the hush-money matter that sent Cohen to prison.

After a decade of working for Trump, Cohen broke with his boss in 2018 and soon pleaded guilty campaign finance violations related to the hush-money payments, making false statements on a bank loan application, evading taxes related to his investments in the taxi industry and lying to Congress. The contributions were in the form of payouts to women who said they had extramarital sexual encounters with Trump, who denied them.

Cohen served about a year in prison before being released to home confinement because of the COVID-19 pandemic. He became an outspoken Trump foe and is poised to be a key prosecution witness in the hush-money trial. Trump and his lawyers, meanwhile, have portrayed Cohen as completely untrustworthy.

While federal prosecutors said in their case against Cohen that the hush-money payments were done to benefit Trump, and occurred with his knowledge, they stopped short at the time of accusing Trump of directly committing a crime.

The Justice Department's Office of Legal Counsel, which provides legal advice and guidance to executive branch agencies, has maintained that a sitting president cannot be indicted. The U.S. attorney in Manhattan didn't revive the investigation once

Nets lack 'toughness' in loss to Magic

Fall to 1-3 on road trip with porous effort in Orlando

Interim Nets coach Kevin Ollie questioned his team's resolve, toughness and focus following yet another disappointing performance in Orlando.

Brooklyn trailed by 17 points after 12 minutes and never seriously challenged thereafter, suffering a 114-106 loss to the Magic Wednesday night in front of 18,846 fans at the Kia Center.

"We have to show a physicality, a toughness, and we just didn't do it tonight," Ollie noted. "We had spurts, got back in the game, but you can't get down by 15 and 18

in the first quarter, especially on the road."

With two days off following their rousing win in Cleveland on Sunday, the Nets (26-40) were eager to avenge their 108-81 loss in Orlando on Feb. 27, when the Southeast Division-leading Magic (38-28) were without leading scorer Paolo Banchero due to an illness.

Ollie's unit hardly resembled a team desperate for a victory with a spot in the Eastern Conference's play-in tournament still within reach.

Instead, Brooklyn fell behind 33-16 after the opening quarter and trailed by as many as 19 points en route to its third loss in four games on this six-game road trip, which will continue Saturday night in In-

"That's a physical team," Ollie added. "They just did a really good job of taking the physicality to us, and we just cannot allow a team to do that, especially a team that

Banchero burned the Nets for 21 points

and nine assists, distributing the ball quite ably and opening scoring lanes for his teammates, six of whom also scored in double figures.

The 6-foot-10 power forward missed one shot the entire night, going 6-of-6 from the floor and 8-of-9 at the charity stripe. He also grabbed three boards en route to finishing with a game-high plus-18 differen-

The Nets did pull within eight points early in the fourth quarter, but Orlando responded with a 19-8 burst, sparked by a high, arching 3-pointer from Joe Ingles that bounded off the rim, scraped the top of the backboard and fell through the twine.

They just hit some tough shots, some lucky shots," said Cam Thomas, who led Brooklyn with 21 points and eight rebounds. "But you just have to live with shots like that. It's an 11-point lead at that

Albany housing inaction boomerangs on increasingly pricey city

With the state legislature deadlocked with the governor and mayor on what to do about the city's housing crisis, the consequences for renters and the economy is becoming clearer.

Rents on new leases in Manhattan and Brooklyn unexpectedly rose in February and are on track to set new records this summer as demand for apartments exceeds supply,

Construction of new apartments, especially in large buildings, has plunged following the expiration of the 421-a tax break for new rental buildings in New York City.

And construction employment in the city is dropping and remains well below pre-pandemic levels, a sign of how the lack of new projects is hurting the economy.

All this comes on the heels of the key Census Bureau tally, the Housing and Vacancy Survey, which showed just 1.4% of apartments were available for rent during the count last year.

Mayor Eric Adams' deputy mayor in charge of housing and economic development, Maria Torres-Springer, says that the need for state cooperation as well as federal support is increasingly urgent.

"These new reports together with the latest findings of the Housing and Vacancy Survey all point in one direction: The necessary actions that city, state and federal partners have to take in order to bend the curve on the housing crisis," said Torres-Springer, who is Adams' point person on negotiations with the legislature and Gov. Kathy Hochul.

Last year, Hochul and Adams announced with great fanfare proposals to boost housing construction, which had fallen well below what is needed to keep pace with demand in both the city and the state. But the legislature failed to pass any housing measures amid a deadlock between real estate interests and tenant groups over tax breaks and new protections for renters.

The mayor began a campaign earlier this year for his proposals, which all require action from Albany. They include a new tax break for newly constructed rental buildings, flexibility to convert more office buildings to residential use, greater allowed density for residential buildings and legalizing basement apartments and other so-called accessory dwelling units.

The governor reiterated her support for that agenda. This week, the state Senate's budget proposal included some elements of the Adams/Hochul vision, including a possible tax break for new rental units and conversions and permission from the state to allow higher density residential construction in the city. The Senate also proposed a "good cause" anti-eviction measure that would cap rent increases statewide — a persistent demand of tenant groups.

The Assembly did not include any specific housing measures in its budget proposal, in keeping with its practice of only dealing with financial issues in its so-called one-house budget.

New data shows the results of the Albany standoff.

Rents in Manhattan set a record for February, with the median new lease rising to \$4,230, according to the monthly Elliman Report released Wednesday. Brooklyn saw the third increase in four months with a median rent of \$3,329. While there is no comparable monthly data for the other boroughs, rents have risen throughout the city in the past two years.

The Manhattan number is only slightly below the record of \$4,400 set in August, and Brooklyn is also down only modestly from the record \$3,850.

Experts had expected rents to stabilize after a sharp run-up that began when the Federal Reserve began raising interest rates in early 2023, sending mortgage rates higher and New Yorkers who had been thinking about buying back into the rent-

al market

But with the city still adding jobs and the Fed delaying interest rate cuts until later this year, the likelihood is that new rent records will be set this summer, said Jonathan Miller, who has authored the Elliman report since 2008. Demand will be especially high for studio and one-bedrooms, which are the favored option for those who can't buy due to high mortgage rates.

"We have noticed there has been an uptick in customer inventories and properties are moving quicker," said Hal Gavzie, executive vice president of residential leasing at Elliman. "If renters who can't buy renew their leases this spring, that will keep rents increasing."

'Worse Every Year'

The major problem remains that there are not enough apartments for rent.

"There is clear evidence that we are not building enough housing," said Miller. "The problem is getting worse every year. It is New York City's best interest to create housing for its workers and June 2022, new construction of apartments has plunged, according to data on how many new foundations are begun that is compiled by the Real Estate Board of New York.

The 421-a abatement, which forgives property taxes worth about \$1.8 billion a year, provided a tax exemption for up to three decades and had required a third of the apartments be set aside at lower rents. It is designed to counter a property tax system that taxes rental units at several times the rate of homeowners, coops and condos.

Builders last year filed only 285 applications for foundations for multi-family buildings that would produce 9,909 apartments. In 2022, new foundation applications envisioned 45,593 new apartments, following a surge of filings before the tax abatement law expired.

The reason for the big decline is that most of the new projects are small. Only 28 applications last year were for projects with more than 100 units, a 78% plunge from 2022. New filings so far in 2024 have continued at a pace of about 30 a month, mostly for small projects.

Meanwhile, construction jobs are declining. The city counted only 139,000 construction jobs in December, according to revised data issued last week, a loss of about 4,000 last year. The city boasted 161,000 jobs in December 2019 before the pandemic.

The failure to agree on a 421-a replacement is what is causing the weakness in employment, said Carlo Scissura, president of the New York Building Congress.

"If the Senate, Assembly and governor would agree on a 421-a deal, you would see an immediate increase in jobs," he said.

In addition to state action, Deputy Mayor Torres-Springer says, it will be crucial for the City Council to approve Adams' 'City of Yes' housing zoning plan that would make it easier to build, and for the U.S. Senate to approve a House-passed measure that would expand the Low-Income Housing Tax Credit, a widely used subsidy for affordable apartments.

But the focus for the next few weeks will be on Albany and whether a deal can be reached as part of budget negotiations due to be completed by April 1.

Torres-Springer says she is optimistic about reaching a deal because of the provisions the state Senate included in its one-house bill and hints from the Assembly that its members are willing to tackle the issue.

"Hopefully lawmakers are hearing from all corners that we need to get to a housing package this year," she added. "There is a lot at stake."

As tensions flare in parent councils, NYC sees a surge in misconduct complaints

Fierce debates and in-fighting within New York City's parent education councils are hardly

But as tensions escalated during the pandemic, the Education Department created its first formal process to investigate complaints of harassment and discrimination among these parent leaders and issue sanctions.

That process, after getting off to a slow start, is now facing its first major test amid a surge of misconduct allegations against parents on these

A total of 36 grievances have been filed this school year against parents elected to the city's Community Education Councils, according to the Education Department. That's up from five such complaints last year.

Debates in the councils have simmered for years over proposals to strip selective admissions criteria in an effort to racially integrate schools. Conflicts exploded during the pandemic, both locally and across the country, over school closures and masking requirements. And sharp divides have continued this year over rhetoric about LGBTO youth and the Israel-Hamas war.

"I think what we're seeing now is a national political fight that has found its way into education," said Tracy Jordan, the president of Community Education Council 22 in southern Brooklyn, who recently faced accusations of antisemitism from a local City Council member and some parents over a decision to hold a meeting on a Friday night. (Jordan said she cleared the meeting time in advance with all the members of the council, including Jewish members, and that it was a special meeting that didn't have a public comment portion, so no one was excluded from speaking.)

Jordan doesn't know for sure if any complaints have been filed against her, but said even the threat of them can "cause concern."

The spike in grievances, called D-210 complaints, is also a sign that parent leaders are finally making use of the disciplinary process, which was rolled out in December 2021, at the height of the pandemic, and met with deeply divided reactions. Some parents at the time shared personal accounts of racism, harassment, and doxxing at the hands of fellow parent leaders, and they argued it was long past time for city officials to take a stronger role in enforcing behavior norms.

But other parents, including members of PLACE NYC, or Parent Leaders for Accelerated Curriculum and Education, a group that supports selective school admissions, argued that the regulation is overly broad, could have a chilling effect

partment too much power to regulate independent parent leaders.

The resolution ultimately passed, but the process has taken years to get up and running.

City has yet to share outcomes of investigations

When the Education Department receives a complaint, an "equity compliance officer" is supposed to investigate, and within 60 days must turn over their findings to a council of parent leaders elected by their fellow CEC members. That council must then issue recommendations to schools Chancellor David Banks.

The Education Department only hired the equity compliance officer in February 2023, more than a year after the position was created.

Education Department officials said parent leaders recently elected representatives from their home boroughs to the council responsible for reviewing the investigations, though a spokesperson declined to name its members.

Many parents didn't know about the grievance process or trust that it would yield any results, said NeQuan McLean, the president of District 16's CEC in Bedford Stuyvesant, Brooklyn, and head of the Education Council Consortium, a group of parent leaders who pushed for the reg-

"Now that those elements are in place, it

ination complaints increased," he said. "The fact that people are filing complaints demonstrates that the regulation and civil rights protections were needed.

But how the disciplinary process will play out in practice largely remains to be seen.

Potential disciplinary outcomes range from an order from the chancellor to stop the behavior in question to immediate removal if the behavior is criminal, poses a danger to students, or "is contrary to the best interest of the New York City school district." For lower level offenses, sanctioned council members get an opportunity to reconcile with their colleagues.

An Education Department spokesperson declined to share whether any of the probes have led

Camille Casaretti, a member of the Citywide Council on High Schools, said the process "takes too long," adding that she knows of complaints made during the CEC elections last spring that are

Meanwhile, some parents are losing their pa-

At a February meeting of the Panel for Educational Policy, multiple parents implored Education Department officials to remove members of the CEC on Manhattan's District 2 who made comments in a private group text chat that denied the existence of transgender kids and referred in maker, according to The 74. Maud Maron, one of the CEC 2 members in the private chat, declined to answer questions about whether she is the target of any complaints, but told Chalkbeat that "defending the rights of girls and women is not an-

Separately, some students and parents at Stuyvesant High School are pushing for Maron to be removed from the School Leadership Team.

Banks, who makes the final call on discipline for elected parent leaders, called the comments "despicable" and "not in line with our values."

"One of the things I will tell you in the two years I have been chancellor that has been the greatest disappointment to me is to see on a daily basis an example of parents behaving badly," Banks said. "I've tried to give this some time to allow adults to be adults. But when you realize they refuse to do that ... we are going to begin to take

Tensions continue to flare in CECs

The conflict in CEC 2 isn't the only one to draw significant attention this year.

CEC 14 in Williamsburg, Brooklyn, has been locked in a dispute over whether to resume in-person meetings, following a backlash to CEC President Tajh Sutton's support for a student walkout calling for a ceasefire in the Gaza Strip.

Sutton and other CEC members say they've received violent threats, including a package containing feces mailed to the council's office, and don't feel safe meeting in person. Critics have accused CEC members of blocking pro-Israel speakers from participating in online meetings an allegation the CEC members deny.

Sutton said she's filed D-210 complaints, and she knows she's the target of multiple complaints. She was initially supportive of the disciplinary process, but doesn't believe it's working as intended. She faulted the Education Department for watering down language in the original proposal that referenced specific forms of discrimination, including against transgender people. She said it also took too long to get the process in motion, which caused some parents to lose trust in the process.

They're going to have to contend with the fact that this regulation written by parent leaders under attack at the time is now being weaponized against parent leaders under attack," she said.

Education Department spokesperson Chyann Tull said "parent input has been considered at every stage of developing this process, which helps us ensure an inclusive and respectful environment for all members of our school communities."

It's not just the high-profile conflicts garnering media attention that are spurring D-210 complaints. Parent leaders and Education Department officials said the grievances are coming from a wide range of districts.

"In other councils, yes we have D-210 complaints that have been filed, many of which over the last several months," said Deputy Chancellor Kenita Lloyd in a February meeting. "That process is ongoing.

In District 22, CEC president Jordan said she's still managing the fallout from media coverage of her Friday night meeting flap with local City Council member Inna Vernikov, a vocal supporter of Israel who recently made headlines for bringing a gun to a pro-Palestine student ral-

"It was really disappointing and deflating," Jordan said of the experience. "When you're accused of something it's a blemish and doesn't go away easily." The whole process has made her question whether getting involved in her CEC

She said she supports the idea of a code of conduct for parent leaders, but worries that the Education Department hasn't done enough to train CEC members on what the code entails and what accountability would look like.

Still, she hopes that the Education Department can distinguish between frivolous complaints and ones that target clearly out-of-bounds behavior.

"At the end of the day, we should be open-minded," she said. "But when we start causing harm, that is a problem."

Drama at NYC performing arts school over loss of its celebrated theater program

The curtain is expected to close next month on a long-running acting program at a Manhattan performing arts school serving grades 6-12, due to a funding shortfall, the program's education and artistic director told parents this week.

But students from the Professional Performing Arts School in Hell's Kitchen want the show to go on and launched a GoFundMe campaign that raised more than \$20,000 in less than 24 hours.

They're hoping they can tap famous alumni, who include Alicia Keys, Britney Spears, Claire Danes, and Jesse Eisenberg. Already, Jeremy Allen White from "The Bear" shared the GoFundMe on his Instagram account (after texting a teacher there to make sure it was legitimate, a parent said).

For 13 years, the Waterwell drama program has worked with the Professional Performing Arts School, often called PPAS, offering conservatory-style acting classes led by professional actors: High school students take drama for two hours a day, five days a week; for middle school, musical theater classes run 1½ hours each day. (Waterwell's co-founder is Arian Moayed, from "Succession.")

Earlier this week, Waterwell's education and artistic director, Heather Lanza, emailed PPAS parents and students, letting them know the program would wrap up April 12 and urged families to advocate on the program's behalf.

She blamed the program's early departure on citywide budget cuts, but the Education Department disputed that, saying that Waterwell was charging more from the get-go than the school could afford

"We love the students dearly, and this has been unbelievably painful," Lanza told Chalkbeat. "We deeply believe in this training model."

Some of the students stay in the program for seven years and have gone on to Broadway or other professional roles. Whether the students want to be professional actors or not, learning through theater helps them develop into "empathetic human beings" and helps them tap into "the power of storytelling," Lanza said.

Lanza told Chalkbeat that the organization's budget was short by \$102,000. Based on what the school told her in a meeting last week, she said, the funding shortfall was a product of the overall cuts in the city and were tied to a midyear adjustment to the school's budget for the current school year. The principal told families this week that the

school needed about \$80,000 to save the program, parents said.

Education Department officials disputed the claim that budget cuts were to blame for the program's gap, saying that the program's work order was above what the school could afford, and this was communicated to Waterwell in December.

The school did lose money because of an enrollment dip. But that cut only amounted to about \$20,000, according to a teachers union database. The school's current roster is about 520 students, according to public data, down about 20 students from the year before.

"A rigorous theater arts program continues to be a priority for PPAS," Education Department spokeswoman Jenna Lyle said in a statement. "The school will host end of year performances, and dedicated staff will continue to support students in their drama education through the end of standard academic year program, which ends on April 30, while the school sources a new partner for the next academic year."

The school is committed to ensuring the theater program will remain strong even if Waterwell leaves next month. Teachers are willing to do "double time" and "step in and fill the gap if we can't raise the money that Waterwell needs," said Shawn Dell, the school's PTA president.

"PPAS is one of a kind. It's a unicorn. There's nothing like it," Dell said. "LaGuardia has DOE teachers that are seeking tenure. Our teachers are seeking Broadway. That's why we love it."

Students crushed by news, but elated Jeremy Allen White took notice

"This program brings so much joy to a lot of people," Tennyson Artigliere, the seventh grader who launched the GoFundMe campaign, said on her way to dance class after the school day ended. "It really brings us so much joy to be able to do what we love to do."

Tennyson launched the campaign after texting with friends in her group chat about how to take action.

They also immediately changed the group chat name from "PPAS peeps" to "S peeps," saying that the removal of the theater program "took the 'PPA' out of PPAS." Now it was just "the school," the students joked.

Before the school day had started, she had tagged White, the "Bear" star, on Instagram, and when she got her phone back at the end of the day, she was ecstatic to see that he had shared the Go-FundMe link in his Instagram story.

White wrote: "This is where I went to high school. It's an incredible program with some incredible teachers. Please help IF YOU ARE ABLE. I have donated."

His support felt meaningful. "These are the people that are going to be the future of entertainment," Tennyson said of her classmates, "the next celebrities."

Marcus Artigliere, Tennyson's dad, felt frustrated that parents learned about the cuts only from the theater program and not the principal, who is in her first year at the school. But he beamed about his daughter's drive to launch the fundraising campaign.

"As a parent, I'm really proud of her collective action," said Artigliere, an education professor at Hunter College. "It's a public school. We shouldn't have to fundraise ... but there is a lot of beauty in being scrappy and seeing how the kids are taking off."

Current and prospective PPAS families worry about school's future

David Glick's daughter travels about $1\frac{1}{2}$ hours from Staten Island to PPAS for this program, he said.

"I don't have my daughter do a crazy commute to just do academics. She could go 10 minutes away for that," he said of his seventh grader. "She's got this amazing voice and is talented. She was thrilled when she got in, but she also has anxiety and ADHD, and it's been really nice for her to have these small classes."

The news about the program has also reached prospective PPAS families.

Sarah Muir, a parent of an eighth grader at Louis Armstrong Middle School in Queens, was delighted to learn last week that her son was accepted into PPAS, and the family is weighing it against an offer at the famed LaGuardia performing arts high school.

"It is distressing and concerning to have gone through the lengthy and arduous application process now to find that the school he will be attending may be radically different from the one he applied to," Muir said. "The school's core mission and identity as a performing arts school depends on this training."

NYC thinks Census Bureau estimates missed tens of thousands of asylum seekers

Three New York City boroughs lost almost 80,000 residents from people moving away last year, according to population estimates released Thursday, but city officials think those numbers are a vast undercount that doesn't capture the influx of asylum seekers who came to the city.

The city rented out entire hotels to house some of the tens of thousands of migrants who came to New York City last year and also put cots in schools and temporarily housed people in tents, a cruise ship terminal and a former police academy huilding

As many as 50,000 people were overlooked in the city's shelters, according to city officials, who plan to challenge the 2023 population estimates with the U.S. Census Bureau.

"We wanted to flag it," said Casey Berkovitz, press secretary for New York's Department of City Planning. "Once you account for this underestimate ... the year marked a return to prepandemic levels."

The three counties representing the boroughs of Brooklyn, Queens and the Bronx in New York City lost 28,300 people, 26,300 people and 25,300 people respectively last year, according to the estimates. Even though births outpaced deaths and people from abroad moved into these counties, these factors couldn't overcome an outflow of residents, though it was substantially smaller than in

Only Los Angeles County had a larger population loss last year — 56,000 fewer residents in 2023, the largest decline in the U.S.

In the most popular destinations for immigrants — counties in South Florida and counties that are home to Houston, Los Angeles, Chicago and San Jose — international migration grew by double digits year-over-year.

The estimates don't distinguish between legal and illegal immigration, so it's impossible to know if any of the growth came from unlawful border crossings. Arrests for illegal crossings hit a record high in December but fell by half in January.

In Miami-Dade County, there were almost 54,500 new residents from outside the U.S., the highest in the nation last year and an almost 40% increase over the previous year. The international migration offset the departure of more than 47,000 residents who left Miami-Dade County for other U.S. counties.

Among metro areas, which combine counties

having social and economic connections, the Dallas metro area had the biggest growth last year — more than 152,000 residents — and surpassed 8 million residents for the first time. That growth was followed by metro Houston, with almost an additional 140,000 residents, and metro Atlanta, with an increase of more than 68,000 people.

Metro Atlanta jumped two spots from last year to become the sixth most populous metro area, with 6.3 million residents. It is surpassed only by metro New York, Los Angeles, Chicago, Dallas and Houston.

Polk County, Florida, was the county more people moved to last year than any other county in the U.S., according to the estimates.

More than 29,300 people moved last year to the county located between Tampa and Orlando, two metro areas where housing has grown increasingly pricey and the county is considered a cheaper alternative. In short order, Polk County has come to have fewer orange groves along Interstate 4 and more subdivisions for local service workers as well as distribution warehouses for on-demand deliveries for residents in both metropolitan areas.

Almost all the growth in Polk County — 88% — consisted of people moving from another part of the U.S. rather than from abroad, according to the 2023 population estimates.

"Subdivision growth has been springing up and it happens in such a manner that you don't always notice it. But when you are stuck in traffic, that's when you really pay attention that it's going on," Matt Joyner, a seventh-generation Polk County resident, said about the influx of new residents

Only four other counties — Harris and Montgomery counties in metro Houston; Collin County in metro Dallas; and Maricopa County, home to Phoenix — grew by more people, thanks to their higher numbers of natural increase, or births outnumbering deaths.

Harris County, which is home to Houston, grew by almost 54,000 people, the most of any county last year, with about two-thirds of the growth coming from births outpacing deaths. That natural increase of almost 34,700 people was the highest in the nation.

With more than 62,000 acres of citrus groves, Polk County is one of the leading producers of oranges in Florida. The state's citrus industry in recent years has been squeezed between a fast-spreading bacteria that has attacked the health of trees all over the state and relentless growth that

has spilled over as its metro areas have expanded.

Despite that, Polk County has held onto its citrus heritage. Most of the growth has been concentrated in the northeastern part of the county, just a few miles from Walt Disney World in metro Orlando. But many of the citrus growers there who sold their land to subdivision builders have just moved to the southern part of the county, where citrus groves are still plentiful, said Joyner, CEO

of Florida Citrus Mutual, a growers' advocacy group.

New residents to Polk County have something picturesque to see if they drive around the county's groves right now — white flowers on citrus trees and a sweet aroma in the air.

"Everywhere you go right now, the groves are snow white and the smell is sweet," Joyner said. "It reminds you of the old days."

Brooklyn judge throws out case against Floyd Bennett Field shelter

Continued from page 1 neighborhoods "speculative."

"Petitioners have failed to offer any support for the proposition that the placement of a maximum of 2,000 migrant asylum seekers at Floyd Bennett Field will have any measurable impact upon the provision of vital services to the surrounding areas or could otherwise interfere with the evacuation plan for the Rockaways."

Ariola and the other petitioners also argued that the use of the site as a migrant shelter was adverse to the legally allowed uses of Floyd Bennett Field, another argument shot down by the court

In his decision, Sweeney said they had no standing to raise claims that the migrant shelter would negatively affect the environment around Floyd Bennett or that the shelter violates zoning laws

Williams, a Democrat, and Ariola, a Republican, both expressed their displeasure with the ruling on Wednesday.

"We are extremely disappointed to learn of Judge Sweeney's decision to dismiss our case in the Floyd Bennett Field lawsuit," said Ariola. "We will continue to do what we can to push for an immediate closure of the tent complex at Floyd Bennett Field."

Williams went as far as to call the ruling a "disgrace."

"I am appalled by Judge Sweeney's decision to dismiss our case, and disgusted to learn that he did so without notifying either party or the public," said Williams.

"We would love to know why he feels it is prudent to place 2,000 human beings in a flood zone in the middle of a National Recreation Area," she added. "This is a disgrace and an insult to every tax paying citizen whom resides in the area around Floyd Bennett Field, and a disservice to the people who are being forced to live in this compound."

Ariola further told the Eagle that there may be more litigation against the shelter to come.

"We still need to reconvene with our counsel and discuss on our path forward," said Ariola. "An appeal is not out of the question, but we have not yet decided on how we want to proceed."

City Hall, on the other hand, applauded the ruling, which will allow them to maintain the tent shelter at Floyd Bennett Field as the migrant crisis continues.

"New York City continues to lead the nation in handling this national humanitarian crisis,

with more than 60 percent of the nearly 183,000 migrants that have come through our intake system since the spring of 2022 taking the next step in their journey," a spokesperson said.

"But, as we have said repeatedly, with 218 emergency sites and hundreds of new arrivals coming to New York City every day, we are simply out of good options," they added. "Floyd Bennett Field has been one tool in our very limited toolbox for sheltering hundreds of migrant families with children every night, and this ruling ensures they will not have to re-

locate. We continue to advocate for additional support from our state and federal partners and ask our elected partners to join us."

The case was first brought in September, and went through some fluctuations before it was finally ruled on.

Initially, the petitioners brought the case in Staten Island's courts, then upon request of the city's lawyers, the case was moved to federal court in October.

The attorneys said that the injunction cited federal law, while the petitioners called the move a delaying tactic.

The case eventually made it to Brooklyn, where Floyd Bennett Field resides, a move the petitioners said was to get the best outcome for the city.

"What we've seen from the start of our suit has been a series of delaying tactics from city and state lawyers," Ariola said on Thursday. "They bounced us from court to court, buying time and burning through tax dollars until they finally landed in a place where they would have the greatest advantage."

The governor's office did not respond to the Eagle's request for a response to the ruling on Thursday.

Beyond the lawsuit, the shelter has seen a few other moments of controversy.

When the shelter first opened in November, several of the first families to arrive almost immediately got back onto the bus that had taken them to the remote location and requested to be taken to a shelter elsewhere.

Additionally, THE CITY reported that in December, several families staying at the shelter attempted to leave after a strong storm appeared to shake the tent structure holding the nearly 2,000 migrants.

About a month later, all families staying at the shelter were evacuated ahead of a powerful January storm.

BEHIND THE BENCH

Civil Court Judge Sandra Muñoz went from in front of the bench to behind it

Lifelong Queens resident Sandra Muñoz was elected last November to Civil Court – now the active community member is adjusting to being behind the bench.

Muñoz, who has lived the last five decades in Elmhurst, is currently seated in Brooklyn Family Court, where she is needed, she said.

She was elected to the 2nd Municipal District, which covers a large portion of Western and Central Queens, including neighborhoods like Sunnyside, Woodside, Jackson Heights, Corona, Elmhurst, East Elmhurst, Maspeth, Rego Park and Forest Hills.

She was approved by the New York City Bar Association and given the blessing of the Queens Democratic Party.

"Being nominated was amazing," she said. Muñoz ran unopposed but she said that it "didn't stop me from going out in the community meeting the people."

"I was out there campaigning so that the communities that don't know me and the people that don't know me, would get to know me," she said

Prior to her election, Muñoz was a practicing attorney who worked in family and matrimonial law.

She was a member of the borough's 18-B panel, or a panel of attorneys who are assigned to work with indigent or children clients. Muñoz

is also a former president of the Latino Lawyers Association of Queens.

She also spent time with community groups, as well as her local community board.

Now, she is getting accustomed to the new role after her years on the other side of the bench.

"I have a new appreciation for the bench," she said. "As a practicing attorney, you really don't know what's going on from a judge's perspective."

Although, she says she is getting comfortable in judge's robes.

"It's a new role so it has its challenges but honestly, I feel like it was very smooth," she said. "It was very smooth sitting in a courtroom that I'm very familiar with."

Muñoz says she is now able to use the mentality she had when working for the community.

"I just want to be there for them," she said.
"I want to be able to help my community and ever since I was a little kid, I was like that, I was always helping out."

"Now, as a judge, I want to make sure is that everyone is heard," she added. "Everyone has a fair opportunity to present their case, and that whatever decisions I render are impartial and just."

Though she hasn't been on the bench long, Muñoz said she has no doubt about where she sees herself in the future.

"I want to continue to do this work for as long as I can do it," she said.
