QUEENS DISTRICT ATTORNEY MElinda Katz said that a 16-year-old has been indicted for first-degree assault and first-degree robbery for shoving a 68-year-old woman down the steps of a Briarwood church on April 7, leaving the seriously injured victim on the sidewalk and then stealing her purse and car. He was also indicted for a separate incident for allegedly stealing another woman's car days earlier. The defendant, who remains unidentified, was arraigned on on a 12-count indictment charging him with two counts of robbery in the first degree, two counts of robbery in the second degree, assault in the first and second degrees, four counts of grand larceny in the fourth degree and two counts of criminal possession of stolen property in the fourth degree. Supreme Court Justice Bruna DiBiase ordered the defendant, who faces up to 25 years in prison if convicted, to return to court on May 15. "An assault on an elderly woman walking into church on a Sunday morning is unconscionable," said Katz. "After allegedly pushing the woman down the stairs, the defendant robbed her and stole the woman's car. We are grateful that the victim is recovering and that we were able to secure serious charges against him from the grand jury."


A MAN WAS KILLED IN A GARAGE fire in Jamaica on Thursday morning, ABC reports. under investigation.

ney Raymond Tierney said that Corona residents Valerie Owusu, 28, and Emmanuel Addae, 28, were each sentenced to 25 years to life in prison after a jury found them each guilty of murder for the 2021 beating death of Owusu's 5-year-old son, King Owusu. The evidence at trial established that between March 30 and April 1, 2021 Owusu and Addae brutally beat King with multiple instruments inside of their apartment in Lefrak City. The couple watched King's physical condition deteriorate for approximately three days until King lost consciousness. During that time, both Owusu and Addae did not call 911, take King to the doctor, or provide any medcare to the child. On April 1, 2021, Owusu and Addae brought King to a family member's home in Brentwood where succumbed to his injuries. The Suffolk County Police Department was called to the Brentwood home after another family discovered that the boy was deceased. The child was taken to Southside Hospital where he was pronounced dead.

Democratic judicial candidate in Queens seemingly called for Biden's execution online

Julie Milner, an attorney running for a spot on Queens' Civil Court bench, is a prolific

Sometimes taking to the social media site X - formerly known as Twitter - a dozen or more times in a single day, Milner often posts her daily Wordle score, wishes congratulations to those finding success or sends her sympathies to those going through hard times. She retweets stories from news outlets about local cultural or weather events, and posts pictures from the campaign trail.

But Milner's social media account also appears to show a judicial candidate prone to

spreading conspiracy theories, and one who shares opinions on a number of political topics despite judicial ethics rules that prohibit similar comments.

A deep dive into her feed on X unveils that Milner, who is running as a Democrat, has previously latched on to issues championed by the far-right. She has tweeted seemingly in support of bans on LGBTQ+ books - which she called "filthy, pornographic smut" - in school libraries and has questioned the efficacy and safety of the COVID-19 vaccine.

Milner has also retweeted posts from a number of accounts associated with former President Donald Trump's MAGA movement. Many of those accounts appear to espouse racist, transphobic and antisemitic rhetoric.

On at least two occasions, Milner herself appeared to call for the execution of President

"Impeach, remove, indict, execute," Milner tweeted twice in January 2023 in response to posts about Biden's alleged improper handling of classified documents.

In an email, Milner declined to comment on specific tweets brought to her attention by the Eagle, including the tweet about Biden's exe-

'I am a Common Sense Democrat and not part of the MAGA movement," Milner said. "I follow a wide range of accounts on Twitter and Continued on page 2

As the city gets the ability to shutter illegal cannabis shops across the five boroughs, Western Queens electeds targeted a single one in Jackson Heights this week.

On Wednesday, officials and parents spoke in front of Hazeland, an illegal smoke shop on 82nd Street in Jackson Heights, which is perched directly across from a Pre-K to 12

Officials spoke out against the shop, which like many others targeted by community members across the city, is unregulated and allegedly illegally markets toward kids, while flaunting state weed regulations.

"It is unacceptable to our community to have these unlicensed weed shops spreading and spreading throughout our neighborhood throughout our city, and we have had enough of it," said City Councilmember Shekar Krishnan. "They are a public health hazard, and they are actually undermining the licensing scheme that the state government has already set up. They are undermining licensed businesses. Democratic judicial candidate spreads conspiracies, far-right talking points online

prior to my candidacy have engaged in public discourse, which is the foundation of democracy."

Indeed, Milner's tweets reflect a wide range of positions that aren't easily categorized into one political ideology.

While she's retweeted a post from right-wing media personality Mark Levin – in which Levin linked to a story suggesting that financial support for the recent pro-Palistinian protests on college campuses comes from George Soros, the billionaire who far-right figures often use a stand-in for a conspiracy theory that wealthy Jews are behind a plot to implement a new world order – she's also posted positive messages about a number of local Democratic lawmakers.

When moderate Democrat Tom Suozzi was elected to Congress earlier this year, defeating Republican candidate Mazi Pilip, Milner tweeted, "Democracy won after all."

But a week prior to Suozzi's election, Milner retweeted a post from Republican Congressmember Elise Stefanik, in which the staunch Trump ally said that Biden was "unfit to be President of the United States."

During the height of the pandemic, Milner fired off a number of tweets that echoed, at the time, positions taken by right-wing Republicans in regard to the vaccine.

"No one can prove that vaccines didn't cause or exacerbate autism," Milner said in a July 2022 tweet. "Ask parents of children on the spectrum when the symptoms started. Right after the vaccine."

In April 2021, Milner retweeted a story from NBC New York about a pause on the Johnson & Johnson vaccine due to rare complications. In response, Milner said, "Does anyone believe the vaccine is being pulled for 'rare' complications? Wake up."

Her April tweet was followed by an emoji of sheep, which is often used to derogatorily refer to a group of people who are docile and easily influenced by those in power.

Milner has also tweeted seemingly in support of a number of conspiracy theories, some of which have been pushed by right-wing leaders.

In three separate tweets, Milner claimed that the "Oswald narrative," or the widely held belief that John F. Kennedy was fatally shot by Lee Harvey Oswald, was a lie.

In a tweet from January of this year, Milner appeared to claim that a group of Proud Boys, who have been described by the Southern Poverty Law Center as an "alt-right fight club," riding on a New York City subway were actually federal agents.

The conspiracy theory echoes those of a number of far-right figures, who have previously claimed the federal government has been behind a number of "false flag" operations organized to confuse the public.

Milner, a civil rights attorney, is running for one of two vacant Civil Court seats in the borough as a Democrat.

In the Democratic primary in June, she'll face off against attorneys Sharifa Nasser-Cuellar and Amish Doshi, both of whom are backed by the Queens County Democratic Party. Also on the ballot will be Glenda Hernandez.

Both Milner and Hernandez's campaigns are associated with Hiram Monserrate, the former state senator who was expelled from the legislative body after he was convicted of misdemeanor assault charges involving an incident with his then-girlfriend. He later served time in federal prison because of corruption charges related to

his time in the City Council.

Monserrate, who has successfully backed around a half dozen judicial candidates in their bids against Queens County Democratic Party candidates in the past several years, declined to

comment for this story through a spokesperson.

Milner appears to have pitched herself to voters as the anti-establishment candidate in the race for Civil Court, according to her social media account.

"These judicial seats for far too long have been used as party favors for political hacks," Milner said in a March 2 tweet. "These seats belong to We the People and we're taking them back."

But Milner also appears to have campaigned on a number of political issues, despite the fact that the state's judicial ethics rules mostly forbid candidates from taking positions on nearly all political topics.

In her emailed statement to the Eagle, Milner said that since announcing her candidacy she has "curtailed my speech to conform to the ethical rules."

"It is vital that our judges come to the bench with an open heart and free mind so that each case is ruled upon solely on the law and its applicability to the facts," Milner told the Eagle.

According to the state's judicial ethics guide, judicial candidates may not make a pledge or promise to "[i]mply a predisposition to decide particular classes of cases in a particular way."

Also according to the judicial ethics guide, the Commission on Judicial Conduct – the watchdog group that investigates complaints against judges – has previously admonished a judge for "statements which, when viewed in their entirety, conveyed bias because they 'single[d] out a particular class of litigants for special treatment."

In a March 1 tweet, Milner said that "we need to...make sure to elect judges who are sympathetic to homeowners and small landlords."

She signed off that tweet using the hashtag "Julie4Judge."

Similarly, she's tweeted a number of times using the "BackTheBlue" hashtag, which is used to signal support for police officers.

"Judges have to come in ready to read the law, ready to take the evidence in and make a ruling based on that," said Antonio Alfonso, the political director of the Queens County Democratic Party, whose candidates are running against Milner. "They should not be coming into Civil Court already assuming that one side over the other is going to win, just because of X [reason]."

Milner is seemingly aware of the ethics rules governing judicial candidates, having tweeted about them several times.

"I'm running against the machine," Milner said in a Feb. 17 tweet, around half a month before she tweeted about electing judges who will be sympathetic to small landlords. "That's why I locked down my account and curtailed my political speech. Judicial candidates' ethical rules are tricky."

As campus protesters blast 'brutal and spineless tactics,' City Hall touts 'precision policing'

New York City Mayor Eric Adams and top police officials continued to blame "outside agitators" for the campus protests against the war in Gaza that have swept the nation.

At a press briefing Wednesday morning, officials confirmed they'd arrested nearly 300 people in back-to-back crackdowns on protests at Columbia University and the City College of New York overnight.

Police officials said they are also keeping tabs on the remaining protest encampments around the city. As of Wednesday, college pro-Palestinian demonstrators calling for divestment from Israel were still camped out at NYU and the Fashion Institute of Technology, while demonstrators at Fordham Univserity's Lincoln Center Campus began their own encampment Wednesday morning.

By the evening, the NYPD had cleared the Fordham encampment as well, cops said. That became the fifth mass arrest of college students in New York City, since protesters at Columbia started camping out, calling for their university to divest from companies profiting off the war in Gaza on April 17.

All told, more than 500 demonstrators have been arrested at encampments at Columbia, NYU, and CCNY over the past two weeks.

At the press briefing earlier in the day, Adams reiterated a claim he and his top officials have made on national television appearances over the past several days: that the demonstrations have been fomented by "outside agitators."


"There is a movement to radicalize young people and I'm not going to wait until it's done and all of a sudden acknowledge the existence of it," Adams said. "I'm not going to allow that to happen as mayor of the city of New York."

Pressed multiple times during the press briefing to identify those "outside agitators," officials declined to provide specifics.

"We're in the process of sorting through all of the data that were covered last night," said Rebecca Weiner, the department's deputy commissioner of iIntelligence and counterterrorism who's also listed as an adjunct professor at Columbia's School of International and Public Affairs.

Weiner said it was too early to say how many of the 300 people arrested across two campuses Tuesday evening were directly affiliated with either institution. "So sifting through the names of everybody and whether they are affiliated with school or not, that takes time and we want to make sure that we're giving you accurate information."

Later, Fabien Levy, a deputy mayor for Adams, told reporters that Lisa Fithian, a prominent longtime activist not affiliated with Columbia, had

been there to back up city hall's claim of outside agitators.

NYPD officials also brought in a chain and lock to the press conference, as well as to television appearances throughout the morning, as an example of something students would not have brought to school.

A reporter for the New York Times pointed out on Twitter that Columbia's own public safety department was advertising the same locks on its website.

'An Incredible Scene'

More details emerged from the crackdown that occurred on the City College of New York campus where NYPD used pepper spray and body-slammed some people during arrests. All told police arrested 173 people, officials con-

firmed Wednesday morning.

In a statement released by the released on X from the CUNY Gaza Solidarity Encampment, students described an array of injuries they'd suffered during the crackdown: an undergraduate student broke their ankle, two more suffered broken teeth, others were pepper sprayed at close range.

"We will not be intimidated by the brutal and spineless tactics," the statement read. A spokesperson for the NYPD declined to comment on the students' statement.

Columbia student organizers wrote that several students were taken to the hospital, while others were kicked in the face during the arrests.

A FDNY spokesperson confirmed one person from Columbia and two demonstrators from City College were taken to the hospital with minor injuries during the course of the evening.

One Columbia student organizer wrote on X that the NYPD had removed some students' hijabs while they were in detention, something the NYPD has had to pay millions for in past settlements. The student organizer who tweeted the account couldn't be reached for additional comment right away, and the NYPD didn't immediately return a request for comment.

At Wednesday's press briefing Mayor Eric Adams praised the NYPD's mass arrests.

"Through the NYPD's precision policing. We showed that the operation was organized, calm, and there were no injuries or violent clashes," he said. "National independent journalists acknowledged what the police department did yesterday and they were on the ground to see and I want to be clear that we will continue to continue to use this level of professionalism."

But at both raids, however, NYPD officials, as well as Columbia campus security, restricted access to reporters, erecting barriers around both campuses and, making it nearly impossible for those not already on site to observe arrests.

At Columbia, campus, student journalists and a CITY reporter were forced into adjoining buildings and blocked in for several hours, unable to observe officers entering Hamilton Hall, or the arrests of students who'd linked arms to try and block the entryway to the hall. Video of the start of the arrests recorded by FreedomNews.TV showed one protester rolling violently down the stairs.

At City College, where the reporters were also cordoned off, top NYPD officials posted their own video of themselves raising an American flag, proclaiming it "an incredible scene and proud moment."

'Left Us No Choice'

As campus protests against the war in Gaza that's killed more than 34,000 Palestinians swept the nation, pressure has mounted on universities to clamp down on them. Some Jewish students have said the ongoing demonstrations have made them feel unsafe on campus and Columbia and City College both largely closed their campuses and moved to online classes.

Though Columbia President Minouche Shafik had expressed reluctance to deploy the NYPD on students for a second time, the administration said Tuesday, the occupation of Hamilton Hall, which occurred early that morning, forced the university's hand.

"The events on campus last night have left us no choice," a Columbia administrator wrote in a letter to NYPD officials requesting their help clearing the building, which was later shared on X by police officials. The letter also requested NYPD presence on campus through May 17 to assure no additional encampments sprout up.

In a similar letter also shared by the NYPD, officials from City College also requested backup from police saying "protesters have refused to comply with our directives to remove unauthorized structures and/or flags, banners, posters and the like."

Noah Grady, a CUNY spokesperson, said they called the NYPD for backup after demonstrators attempted to break into one campus building, and successfully broke into an administrative building, vandalizing it and breaking glass.

"Students have a right to demonstrate peacefully and exercise their First Amendment rights. Tuesday night's actions were taken in response to specific and repeated acts of violence and vandalism, not in response to peaceful protest," he said. "CUNY will continue working to keep our community free from violence, intimidation and harassment."

Columbia University has a long history of student-lead occupations. After a violent police crackdown on Vietnam War protests, "fall-out dogged Columbia for years," according to the University's own account of the era decades later.

In a statement Wednesday from President Minouche Shafik, she acknowledged "it is going to take a long time to heal."

"I hope we can use the weeks ahead to restore calm, allow students to complete their academic work, and honor their achievements at Commencement."

Power Outages Linked to Heat and Storms are Rising, NYC Study Shows

Many Americans think of power outages as infrequent inconveniences, but that's quickly changing. Nationwide, major power outages have increased tenfold since 1980, largely because of an aging electrical grid and damage sustained from severe storms as the planet warms.

At the same time, electricity demand is rising as the population grows and an increasing number of people use electricity to cool and heat their homes, cook their meals and power their cars. A growing number of Americans also rely on electric-ity-powered medical equipment, such as oxygen concentrators to help with breathing, lifts for movement and infusion pumps to deliver medications and fluids to their

For older adults and others with health conditions, a loss of power may be more than an inconvenience. It can be life-threat-

We study environmental health, including the effects of extreme heat and storms on people. In a new study, we analyzed data from New York City and the surrounding area to understand how severe weather drives power outages and who is most at risk, particularly in urban areas.

Low-income communities often at highest risk

How quickly power returns in a community is often shaped by history.

Discriminatory practices such as redlining and zoning, which prevented nonwhite residents from obtaining mortgages or owning homes in certain areas, left marginalized groups living in more disaster-prone areas with poorer quality infrastructure. Studies show that both factors make these communities more likely to experience prolonged power outages.

Current policies can also exacerbate outages for these populations. For example, many electric utilities prioritize power restoration to regions with community assets, such as mass transit, hospitals, police or fire stations, and sewage and water stations, as well as regions with larger popu-

Though these guidelines appear neutral, they can inadvertently prolong outages for less populated areas and areas lacking resources, including these key assets. For example, following Tropical Storm Ida in September 2021, Con Edison outlined areas with important community assets as priorities for restoring power. Manhattan had power back within hours, while many low-income and largely nonwhite parts of Queens, the Bronx and Brooklyn waited for days.


Emerging evidence from studies on power outages in Texas, Florida, the Southeast and a national study, along with our new research in New York, shows that outages especially burden communities that don't have adequate funding.

Complex weather and battery-life thresholds

Across New York state, we found that 40% of all outages from 2017-2020 followed severe weather — heat, cold, wind, rainstorms, snowstorms or lightning — within eight hours. While each type of severe weather alone could lead to prolonged outages, in combination they resulted in much longer outages.

Statewide, for example, strong winds alone led to outages lasting 12 hours on av-









erage, and heavy precipitation resulted in nerable communities faced more weathoutages lasting six hours on average. But when wind and precipitation happened simultaneously, the outages lasted closer to 17 hours on average.

A six- to eight-hour power-restoration threshold is particularly important for peo-ple who rely on electricity to power medical equipment. Many of these medical devices have backup batteries with capacities that do not exceed eight hours. That's one reason researchers considered eight hours to be a critical power restoration window

We also looked at whether socially vul-





er-driven outages than other communities. In short, the answer was yes, though the effects varied in different parts of the state and by the type of weather event.

In New York City, we found that heat, precipitation- and wind-driven outages oc-curred more frequently in socially vulnerable communities, including in Harlem, Upper Manhattan, the South Bronx and eastern Queens. This matters because socially vulnerable neighborhoods have higher poverty rates and lower-quality housing. Community members may lack access to health care or suffer from underlying health conditions.

On average, the duration of precipitation-driven outages was longest in areas of the city with the highest social vulnerability. In neighborhoods with vulnerability scores in the top 25% — meaning the most vulnerable neighborhoods — outages lasted 12.4 hours on average, compared with 7.7 hours in those neighborhoods in the bottom 25%.

In rural parts of the state, outages related to downpours or snowstorms were also longest in areas with high social vulnera-

Outages are quick to follow heat spikes

As temperatures rise over the summer, it's important for communities to consider the dangers that outages can present for disabled persons, older adults and others with health conditions, particularly in socially vulnerable communities.

Extreme heat is one of the most dangerous meteorological phenomena. It causes nearly 400 premature deaths a year in New York City, according to city estimates.

With the granular data we obtained from the state Department of Public Service, we could zoom in on how fast outages began following extreme weather.

Across the state, outages began quickly within six hours of extremely hot temperatures spiking – likely as more people turned on their air conditioners. This means the outages likely occur while it is still hot, exposing individuals to extreme heat, without power for air conditioners or fans.

Coupled with higher outdoor tem-

peratures and the prevalence of underlying health conditions, socially vulnerable communities face heightened exposure to heat-driven outages and greater risk from

How cities can reduce risks as temperatures rise

This outage trend will likely continue as climate change intensifies, bringing more frequent extreme weather to an aging grid in which many parts are nearing or

surpassing their life spans.

There are steps communities and power providers can take to reduce people's exposure to power outages and the health harms that can accompany them.

In the short term, cities can develop targeted plans for these communities to ensure that residents have ways to cool off during heat waves. That includes providing ample cooling centers, swimming pools and public parks with shade trees. It can also include transportation support for older adults and others with mobility is-

In the long term, reducing these risks means updating the power grid, weatherizing buildings, planting trees to reduce urban heat island effects and investing in distributed energy resources, such as solar power and batteries for energy storage.

We believe this work should prioritize communities that most need these updates, following the lead of New York state's Weatherization Assistance Program, which aims to improve energy efficiency for low-income households.

Judge in landmark antitrust case grills Google, Justice during closing arguments

The judge overseeing a pivotal antitrust trial focused on whether Google is stifling competition and innovation repeatedly indicated Thursday that he believes it would be difficult for a formidable rival search engine to emerge.

U.S. District Judge Amit Mehta went back and forth with Google's lead litigator, John Schmidtlein, during the first day of the trial's closing arguments, questioning whether another company could amass the money and data needed to develop a search engine that could eventually compete against Google.

"It seems to be very, very unlikely, if not impossible, under the current market conditions," Mehta said. He added that it appeared odd to him that there is a marketplace where Google is making billions of dollars in profit yet nobody "is trying to enter into the market to cut into that profit."

Google reaped an operating profit of nearly \$96 billion last year, mostly by selling digital ads — a market that it also dominates largely because it controls about 90% of the U.S. internet search market.

The judge also questioned how common it is for users to move away from the default search engines pre-installed on their smart devices. The default search option is a key question in the trial. Federal prosecutors allege that Google protects its franchise by shelling out more than \$20 billion annually to ensure its search engine automatically answers queries on Apple's iPhone and web browsers such as Safari and Mozilla's Firefox.

Lawyers for the Department of Justice contend the money that Google spends on default search contracts with most of the money going to Apple — now exceeds its annual investments in improving the quality of its results.

At one point the judge pointed to an example mentioned at trial that 80% of desktop users who use Microsoft's Edge, also use that company's search engine, Bing, and questioned why that wasn't evidence of the "stickiness" of defaults because only 20% switched over to Google in the Edge browser.

Google has long argued

that the reason it has been so successful is because it has engineered the best technology, negating the need to engage in sinister tactics.

"Google is winning because it's better," Schmidtlein said. "Everybody who marched into this courtroom said Google was better."

Schmidtlein told the judge that Apple was the one that had the option of getting out of the Google default agreements and had studied using other options like Bing as its default but stuck with Google.

"They chose Google," Schmidtlein said.

Mozilla also tried switching to Yahoo as the default search engine on its Firefox browser before switching back to Google in 2017, largely because of its users' preferences.

Mehta also questioned the Justice Department over what was unusual about Google's five-year contracts with Apple, saying that it was natural that a company that has already had a contract would be in a better position to bid again on the same contract because they are more knowledgeable about the company.

"What you've just described is true of any contract," Mehta said.

The judge followed with questions about whether competitors were making enough investments to compete with

"You can talk about competition but the competitor bears some responsibility for competing," Mehta said.

Lawyers for both the Department of Justice and Google are presenting closing arguments in Washington, D.C., Thursday and Friday to conclude the biggest antitrust case in a quarter century.

After the closing arguments in the Justice Department's antitrust case against Google wrap up this week, Mehta is expected to issue his ruling in the late summer or early autumn. If he decides Google broke the law, another trial will determine how to rein in its market power.

The case against Google mirrors the one brought against Microsoft in the 1990s in many ways, including the existential threat it poses to a renowned tech giant whose products are relied on by billions of people.

Liberty Part Of WNBA **Business Boom**

New York ticket sales up 30% from 2023 on StubHub

The New York Liberty averaged 7,777 fans per game at Downtown's Barclays Center last season.

Those numbers, albeit impressive, are on their way up in 2024.

New York, which welcomed 5,326 fans for their home dates in 2022, not only brought in a "Super Team" to chase the first WNBA championship in franchise history in 2023, they also reached the Finals for the first time since 2002.

With the return of reigning league Most Valuable Player Breanna Stewart, former MVP Jonquel Jones, forward Betnijah Laney-Hamilton and a backcourt of Sabrina Ionescu and Courtney Vandersloot, the Liberty are poised to again challenge back-to-back champion Las Vegas.

And plenty of Brooklynites want to see if they can do it.

According to the Associated Press, sales for upcoming WNBA games are up 93% compared to this same time last pre-

The Liberty are behind only the rival Aces in this ongoing uptick in sales.

New York's sales for this much-antic-

ipated campaign, which will kick off in Washington on May 14, are up 30% on StubHub, known as the world's largest ticket resale platform.

Last year, New York had 17,143 fans show up for Game 3 of the Finals and 16,581 came to see the season end in heart-

breaking fashion in Game 4.

The Liberty faithful will have their first chance to see their team reboot the chase for Title I on the corner of Atlantic and Flatbush on May 18, when first overall pick and NCAA phenom Caitlin Clark and the Indiana Fever come to Brooklyn.

Clark was a big factor in StubHub reporting that it had record sales for last month's NCAA Tournament.

Fans won't get to see the Aces here until Sept. 8, but Vegas helped draw 11,615 fans here in its final regular-season visit last Aug. 28.

That was deemed a sellout crowd since the upper bowl of Barclays was closed.

But the Finals proved that the Liberty could sell out the entire building, which holds 17,732 without standing room, or at least come close.

That's something the organization is doubtless eager to do at some point this year, even if it means waiting until the Finals in October.

Left fielder Jake Mastillo's first homer of the year, a two-run blast in the eighth, gave the Sharks (23-18) a 3-0 cushion before relievers PJ Moritz, Evan Panjwani and Jack VanDoran nailed down LIU's sixth straight win and eighth in the past nine contests.

The Sharks will look to match their longest winning streak of the campaign Friday afternoon at 3 p.m. in the opener of a threegame series with Northeast Conference ri-

New-to-New York stores are helping turn around the retail apocalypse

SoHo, long one of the premier shopping areas in the city, is being transformed by invaders grabbing storefronts.

There is Orior, a furniture maker from Northern Ireland. Galia Lahav, a haute couture and bridal fashion brand from Israel. TOTEME, a Swedish apparel company, as well as Thuma, a San Francisco mattress company, have established New York beachheads as well.

As a result, retail occupancy in SoHo is now 84%, higher than before the pandemic.

"There is an international hunger and curiosity about the neighborhood," said Erin Piscopink, executive director of the SoHo Broadway Initiative business improvement district.

But it is not just SoHo. First-time-in-New York retailers are driving a revival of the city's retail scene in other desirable neighborhoods like Flatiron, Nolita and the Upper West Side. What these areas have in common is that they have both residential and commercial areas and in some cases cachet that is lacking in the major central business districts like Midtown and Downtown, which the new entrants are so far avoiding.

Overall Manhattan statistics show improvement in the retail real estate market. The real estate firm CBRE counts 185 vacant ground-floor spaces in the 16 areas it tracks, down from 195 at the end of last year. The brokerage firm JLL puts the vacancy rate at 15.4%, a sharp decline from 28% in 2021 and lower than the 21% figure for 2019.

Between 2020 and 2023, new-to-New York stores leased 1.56 million square feet of space, or 15% of all deals, according to a recent report from CBRE. Last year the invaders signed up for 455,000 square feet, or 18% of the total.

"We have been hearing so much talk of the retail apocalypse," said Hironori Imaizumi, author of the CBRE report. "But when we looked in SoHo and Flatiron we saw so many new apparel and food and beverage brands opening up."

The Center for an Urban Future's annual State of the Chains report, released in December, notes that the companies expanding in the city were primarily those that had arrived in recent years, including Playa Bowls, Nuts Factory, and Orangetheory Fitness, to name three.

And SoHo continues to be the No. 1 option.

"We were approached by an organization that represents businesses from Scandinavia that are bringing a group of retailers to visit places like SoHo to see how they can enter the city," Piscopink said. They are due to arrive at the end of the month.

While a large number of vacancies along Sixth Avenue in Flatiron has drawn a lot of atten-

tion, most of those are south of 20th Street. The area north of 20th Street has become a destination for first-timers

Over the past six months, 31 businesses have opened in the area covered by the Flatiron Nomad business improvement district and another 10 are to do so in the coming months, said James Mettham. Of those, 26 are new to the city.

For example, Othership is a sauna and ice bath that will open on 20th Street in June.

"Flatiron is a vibrant and central neighborhood that is known for its mix of residential and commercial spaces and is well connected by mass transit," said Robbie Bent, co-founder and chief executive.

The story is similar for Suzanne Cupps, who has been cooking in New York since 2005 and spent the past several years scouring Manhattan for a place to open her first restaurant.

She looked near Rockefeller Center, Gramercy Park and Tribeca, needing to find a spot that had been a restaurant since it is too expensive to convert other kinds of space into one. She settled on a 2,500-square-foot spot on 28th Street between 5th Avenue and Broadway for Lola's, which is named for her Filipino grandmother and features locally sourced food with Asian and Southern influences.

"The area is close to public transportation and has exploded since COVID with really great hotels and new businesses," she said.

Since the interest is concentrated on a few key areas, newcomers are finding themselves competing for a limited number of available spots in the most desirable neighborhoods.

"More tenants will be forced to compromise in each submarket," said Matt Chmielecki, a senior vice president and retail broker at CBRE. "If you can't find something on Spring or Prince you won't give up on SoHo entirely. You will look on Greene and Wooster."

Rents are rising in these areas as well. The average rent on Prince Street in the first quarter rose to \$1,073 per square foot compared with a Manhattan average \$688, according to CBRE.

However, these newcomers show no signs of extending their searches to the main business districts in Midtown and Downtown, which suffer from the lack of a residential base, office vacancy rates of 20% and back-to-office occupancy still below pre-pandemic levels. In addition, Midtown is seeing key tenants defecting to the Hudson Yards area on the far West Side.

"It will be a challenge for those areas to lure the new entrants," said Imaizumi.

This Brooklyn high school psychology teacher wants her students to channel pessimism into action

It might seem odd that a high school psychology teacher would be selected for a National Geographic teacher fellowship in the Arctic, but for Caitlyn Homol, last summer's "paradigm-shifting experience" inspired her to develop a new interdisciplinary unit.

As the International Baccalaureate, or IB, Teaching and Learning Coordinator and IB Psychology teacher at Brooklyn Prospect High School, Homol is teaming up with her school's Environmental Systems and Societies course to explore "the relationship between motivation, action, and climate attitudes that culminates in a beach cleanup and reflection."

While on the 17-day expedition, Homol saw polar bears on land since there wasn't enough sheet ice for their traditional hunting patterns. She saw marine debris on the shores of islands hundreds of miles north of inhabited towns. She and others started to feel pessimistic "about our collective chances of being able to preserve the sights we were seeing for future generations."

That led Homol to get involved with visiting scientists from the Rozalia Project as they collected data on microplastics in the waters. She ended up filling in at the last minute for one of Rozalia's Maine expeditions right as school was starting, helping them meet their 20,000-pound cleanup goal for summer 2023. That experience, she said, "brought me so much hope and energy for what we can do when we work together to do hard things."

Homol, who has spent four of her nine-year teaching career at Brooklyn Prospect, recently won a national teaching award from the American Psychological Association.

Teaching psychology, Homol believes, gives students a strong background in social science research, and she encourages her students to seek out research opportunities when they go to college.

"I also think this course has so many natural connections with students' own experiences," she said. "There's a unique chance for them to develop new self-knowledge while also expanding their perspectives of other people's experiences."

This interview has been lightly edited for length and clarity.

How and when did you decide to become a teacher?

I attended Ohio State University as a first-generation student who had also been very transient in middle and high school, bouncing between schools up and down the East Coast and the South. I'd been a successful student but missed more than a couple of foundational courses I needed to be successful in my initial declared major, which was biomedical engineering. I was confused and humiliated by the struggles I faced in my chemistry and calculus classes, and after ending up on academic probation my first quarter, I lied to most people about how school was going because I was terrified of letting them down.

As a condition of exiting probation, I chose to take an education psychology course about study

strategies at the Dennis Learning Center. It was transformative and helped reduce the fear I felt that I did not belong in college. I ended up working there for three years of undergrad as a learning specialist, where I facilitated workshops and met 1:1 with other students at OSU to interpret research to find meaningful study strategies.

That's what led me to consider teaching, and Teach for America was an alternative certification program I was familiar with.

What's your favorite lesson to teach and why?

I deeply appreciate my colleague, Khanh Le, who adapted an exercise she came across in her developmental psych program for our students. It asks students to take a fictional family of seven of different genders and ages and arrange them into hypothetical homes with room counts ranging from 1-7, in arrangements that are both ideal and least ideal.

Our students, who have a variety of cultural backgrounds, are often surprised to find that they have nearly unanimous agreement with each other in their room arrangements. We discuss the findings of the original study, which suggest that some values driving those arrangements are unique to the West and others are universal — and the consensus we have in our own answers is a proof of acculturation, or assimilation to U.S./New York culture. I love this lesson because it ties together research, relatability, and strikes a balance between appreciating difference and finding commonality with others around the world.

Are there particular things that students are seeing or experiencing in their lives related to the course that come up in the classroom?

The first thing that has positively shifted the tone of conversations we have in class is the decreasing stigma of mental health concerns.

At our school, we teach the "Abnormal Psychology" option offered in the IB Psychology course, and students are tremendously open and excited to share their experiences with each other. I would have been so embarrassed to talk about my mental health at that age, but kids are supportive and continue the conversation with questions or their own contributions.

The second development I've seen is less positive: I've noticed that students carry more pessimism these days. More students feel that nothing matters, and that there is nothing that can be done to improve the circumstances of themselves or their communities. This is a comprehensible reaction to climate developments, the inertia of systems and institutions to change, and an eroding pretense that a college education is a ticket to financial stability. I also think social media algorithms proliferate a lot of cynical (if not outright incorrect) interpretations of psychological and sociological knowledge.

I think as educators of young people, part of our role is to inspire students and to teach pathways to change. Of course, we have a duty to portray the world realistically in our classrooms. Many things are actually dire. But I think we also must take care to invite students to construct generative interpretations and applications of knowledge and research. Otherwise, we are left with the status quo and that pessimistic vision does become our fate.

We also have to let them feel the impact of taking action with others, *doing* things rather than just talking about them. This is tricky for adults too, but my summer experiences underscored how meaningful optimism comes from collective work and creation.

Tell us about your own experience with school and how it affects your work today.

I was incredibly blessed to have consistently caring, effective, and diverse teachers for all 13 years of my public schooling. I especially credit the many Black women who taught me at Arlington Elementary School in Jacksonville, Fla., who saw my potential and imparted to me a sense of duty to make the most of my education.

It has been easy to draw from the example they and my other amazing educators set as I show up for students today. But the thing that has most shaped my overall career trajectory has been the challenges I faced as a student who wanted access to specialized programming.

I happened to find out about the International Baccalaureate program in my district through idle conversation with my school librarian, rather than through my school counselor or district-wide advertisement. I had to submit an application, attend an interview or take a test, and take a bus an hour each way to get to school. Years later, I found myself in rural Alabama: I navigated several hurdles to take online AP classes that were made available upon request through Alabama's ACCESS plan for distance learning. There were so many hurdles to being able to participate in both programs, and because of it, I have chosen to work at schools that give a broader range of students access to the IB program by default.

What's the best advice you've ever received, and how have you put it into practice?

A mentor once told me, "Let someone else tell you no," when I was debating sending in an application for a job opportunity years ago. For schol-





arships, school program ideas, jobs, or awards, spending less time being my own gatekeeper has opened up fantastic experiences.

Most recently, I pitched an ambitious idea to the Rozalia Project, which included setting aside spots on a July expedition on their sailboat for a teacher and a recent high school graduate — she said yes! Making this initial ask has also let us start envisioning a recurring beach cleanup program and a full Prospect Schools expedition a couple years out from now. We have other details to work out, but if I had let my own 'no' get in the way, I would have never fathomed how excited they would be to develop this partnership.

Council challenges Adams official in charge of new interagency forms

The City Council grilled a top Adams administration official on Wednesday over a new policy that requires any lawmaker to fill out a form to meet with the mayor and his commissioners, saying it encourages micro-managing and jams up

Tiffany Raspberry, the director of intergovernmental and external affairs for Mayor Eric Adams, testified about the "elected official engagement request form," which was introduced last month.

While Council members criticized the change, Raspberry said it's aimed at efficiency and equity.

The form is not intended to stand in the way of elected officials picking up the phone to reach out to a commissioner, borough commissioner, or anyone else in the administration," she said.

Some lawmakers may have friends or connections at agencies and within the mayor's office but others don't, so the form can help level the playing field, she added.

"There are many newly-elected officials who may not have those contacts," she said.

Since it was introduced in early April, as first reported by THE CITY, the intergovernmental office received 182 requests, including 51 from the City Council, according to Raspberry. The average turnaround for a response was 24 to 48 hours, she said — noting that no request has been reject-

"I do not envision a scenario where a request will be denied," she told Councilmember Lincoln Restler, a Democrat from Brooklyn and a major critic of the administration.

He said that the form is a "maddening approach to governing the city" as opposed to an effective way to talk to officials - especially if Mayor Adams has to review each request. The fear from him and other Council members is that the mayor will pick and choose who can meet with agency and administration officials based on whoCouncil Challenges Adams' Official in Charge of New Interagency Forms he likes.

The mayor told reporters last month that he

would — and had time to — review every request

Raspberry said the mayor has access to every submission but ultimately it's her office that responds to requests.

'Rome Is Burning'

The Council's criticism of the new form policy comes amid increased tensions between the legislative body and the mayor's office.

Some lawmakers compared it to extra paperwork required by police officers under a newly-passed bill that Adams initially vetoed, but was then overridden in the Council.

The form is now required for nearly all interactions between city, state, and federal lawmakers and top officials from the mayor to local precinct commanders.

If a lawmaker wants to discuss an uptick in crime in their district, or request a tour of a new building, it is all filtered through the form. Elected officials said they previously would reach out to city agencies directly, but are now being told to fill out a form.

Councilmember Bob Holden, a Democrat from Queens, agreed with Public Advocate Jumaane Williams — a frequent foe — in his criticism of the form.

'We have quality of life issues," he said. "The last thing we need is to talk to somebody to fill out paperwork on an ongoing issue.3


But Republican Council members Vicki Paladino and Inna Vernikov, who represent Queens and Brooklyn, respectively, sided with the administration and took the hearing as an opportunity to protest their colleagues' push for more paperwork for police officers.

"While Rome is burning, we're concerned about filling out papers," Paladino said at the hearing. "These papers take exactly two minutes to fill. I agree with the format, I'm not going against the format because if the police have to fill out paperwork, so do we."

But other former elected officials and staffers testified against the form, including former City Council member and Manhattan borough president Ruth Messinger. She said she felt "sorry for the administration's efforts to present this as logi-, because it's not logical."

"What matters in this very large city, and what helps it to be human, is relationships," she said. "I think there is no one who knows that better than the mayor whose style prioritizes relationships.

As city gets power to close smoke shops, Queens officials call one out

undermining the workers in those businesses, and they are doing so at the expense of our community."

The officials say that enforcement against Hazeland thus far has mirrored that of the enforcement taken unsuccessfully by the Sheriff's Department in the past. Though sheriff's deputies have busted the story and locked its doors, its owners have come back the next day and opened up for business as if nothing had happened.

But now, through the recently passed state budget, the city is expected to gain the power to padlock doors for good, and issue criminal consequences should an owner or employee of an illegal shop attempt to get back inside.

"We have gotten a commitment that [the sheriff] is coming back, and we need them to come back," said Assemblymember Catalina Cruz. "We need them to shut this shop and any other shop in the neighborhood permanently."

Stacey Gauthier, the principal of the Renaissance Charter School located diagonally across the street from Hazeland, said she is worried for the safety of her students when stores like Hazeland open up.

"What's it going to take? Is it going to take for a child to get sick, a child to die? Because we do not know what they are ingesting," she said. "These shops do not follow the rules. I'm not anti-cannabis. I think New York State is trying to go about it the right way to make it legal. But my understanding is that even legal shops should not be so close to the school, and this is an illegal shop."

"We are extremely, extremely concerned about this," she added.

Lawmakers said that they were confident that the legal changes passed through the state budget would begin to have an effect in neigh-

borhoods like Jackson Heights.

"On 4/20 we very appropriately passed the budget that included the provision to shut down these illegal shops," said Assemblymember Jessica González-Rojas, a proponent of pot's legalization in the state in 2021.

"When we passed the Marijuana Regulation Taxation Act a few years ago, this was to ensure that people most impacted by the War on Drugs were at the front of the line, and there was a difficult and robust process to ensure that anyone that wants to open a legal shop went through a number of hoops to ensure that they were going to follow the law," she added. "And let me

tell you, when these guys like Hazeland and so many others throughout the neighborhoods in the district, when they open up their shop, they jump ahead, they break the law."

The new law will see the city "deputize" the NYPD to join the sheriff and other city and state agencies in shutting down illegal shops.

Mayor Eric Adams had previously said he could shutter all the shops in 30 days if a law of this kind went into effect – he has since amended that statement to say that the city could make a "substantial dent" in that same timeframe.

The mayor also acknowledged that he was worried that stores may still find loopholes to

open up in some form again even after they are shut by the city.

"Now we have the tools, we have the authority and we're going to start kicking into place," Adams said on Tuesday. "On the 31st day, don't be standing in front of City Hall and say 'Hey, I saw a shop,' because they're going to continue to open and we will continue to close it."

Much of the vocal push back on illegal weed shops, although largely ubiquitous from officials and community members, has more recently come from moderate Democrats and conservatives, rather than progressives like Cruz, González-Rojas and Krishnan, who all rallied together this week.

"The fact of the matter is, our agencies need to be focused on issues like these," Krishnan said to the Eagle. "The reality is when it comes to illegal weed shops in our neighborhood, unlicensed weed shops are a true public safety and public health hazard. For this mayor who claims to be about improving public safety, this is the issue that the city agencies should be focused on."

When announcing the new laws, both the mayor and Governor Kathy Hochul tried to reassure New Yorkers that increased cannabis enforcement would not lead to the same Drug War-era tactics that disproportionately affected Black and brown communities.

The officials on Thursday didn't express any reluctance to give more power to the mayor and NYPD when it comes to policing illegal cannabis sellers.

"I think for this particular purpose, it is the way we have to do it," said Cruz. "There's going to be coordination between [the Office of Cannabis Management] and local law enforcement, whether it's a sheriff or NYPD, and I think that's the way that it should have always worked."

"We have done our job," she added. "Now it's your turn – sheriff and governor, and each of your agencies, to do yours."

Court Officer Robert Mair has heard your jury duty excuses

If you have got called into jury duty at Queens Civil Court in the last few years, chances are you were greeted by Court Officer Robert Mair.

Mair, a Manhattan native who has spent the last 16 years as a court officer at the Queens County Clerk's Office, specifically deals with members of the public coming in to serve a turn of jury duty.

When a member of the community comes into court Mair helps coordinate and corral jurors from the central jury and into the various selection rooms and courtrooms they are needed in.

"Our job is to make sure that that works nice and smoothly," he said. "We're kind of like the liaison between the courtroom and the central jury room...I'm up here just to make sure everything goes nice and smoothly, and everyone gets through this service unscathed."

While in college, Mair decided to take civil service tests and eventually became a court officer.

"I like helping people," he said. "I was used to dealing with the public."

In his 16 years now, Mair has encountered all types of potential jurors.

"It's very interesting because you have such

a range of emotions when people come in," he said. "There's people that are happy to do this civic duty, and there are those that come in and they just do not want to be there."

Although Mair understands that being called to jury duty can be stressful and inconvenient situation for some, who may be missing a day of work or needed to figure out childcare. Regardless, he treats everyone the same.

"You try to greet them in a way where they feel a little bit more comfortable about the process, regardless of how they feel coming in," he said. "You want them to have a good experience because you want the public to come and do this, it's a needed process. So, we try to help shape their opinion of it and it starts from once they walk in."

Mair says he does this by patiently answering questions, assuaging worries and guiding people through the process, while injecting humor when he can.

"I'm not over here doing comedy acts, but if you can kind of just get a person to just smile a little bit, it goes a long way and it helps the process a lot," he said.

No matter what though, he said that people do come in eager, stressed and often angry about being in court, so an easy hand is necessary.

Of course, there are also a fair amount of people who come in with their excuses, not so
