A QUEENS WOMAN WAS ARRESTED on Tuesday on suspicion she hit an elderly man at a Long Island rehab facility, the Daily News reports. Lisa Napier, a 41-year-old from Queens, was arrested Tuesday morning in Woodmere, Nassau County for attacking the 71-year-old man. The legal guardian of the elderly man who has a cognitive disorder, under the care of the Woodmere Rehab Center, discovered bruises on the man's body late last week. When the guardian questioned the facility about the bruising, she was told the elderly man "fell out of bed multiple times," prompting her to place a camera in his room. Footage later showed Napier "striking the victim multiple times with a closed fist in his face and lower body." While multiple local outlets have described Napier as an employee at the facility, a Nassau County police spokesperson declined to comment on their relationship. Napier has been charged with second-degree assault and related charges.

STACEY PETROWER, M.P.A., HAS been appointed as the new President of NewYork-Presbyterian Queens, QNS reports. According to Valdez's campaign, the DSA-backed candidate raised \$142,333 in public matching funds for her Assembly bid, double what Carmona - who was recently endorsed by Queens Borough President Donovan Richards – has raised. "I've been so moved by the support of hundreds of working class New Yorkers powering our campaign," said Valdez. "The district is hungry for new leadership, and our message resonates. That has translated into the significant fundraising and volunteer support we've received."

The family of 19-year-old Win Rozario on Wednesday condemned the NYPD, the mayor and the handling of a March trip to the family's Ozone Park home by a pair of officers who shot and killed the teen a few minutes after arriving.

The Queens Bangladeshi family, alongside advocates and elected officials, stood on the steps of City Hall this week and called for the firing of NYPD officers Salvatore Alongi and Matthew Cianfrocco. They also blasted the NYPD for its handling of the shooting in the davs that followed, and the mayor for his response to the killing of the teen.

"[They] killed my son in a minute - be-

fore they came, everything was calm," said Rozario's mother, Notan Ava Costa, through a translator. "They came and created chaos and murdered him in front of me.'

Ava Costa was present at the shooting and watched as her son was shot five times by police. The press conference marked the first time the Rozario family had spoken publicly since

the shooting on March 27 and since the troubling body camera footage of the incident was released to the public last week.

"You can imagine the pain I have and how much I miss Win," the teenager's mother said. "Win was just a child. He was a teenager with his whole life ahead of him."

Ava Costa and Win's father, Francis Rozario,

spoke of their son as a kid who had a firm idea of right and wrong, who did well at school and who one day aspired to join the U.S. military.

"He was very smart and meritorious, very organized," said Francis Rozario also through a translator. "He always wanted to do what was right, but he did not care about getting credit for it."

In addition to losing their family member, the Rozarios said they suffered further humiliation at the hands of the NYPD following the shooting.

Ava Costa and Rozario's brother, 17-yearold Utsho Rozario, were brought to a police precinct and "interrogated" by police after the Continued on page 16

A class action lawsuit was brought this week against the state's Department of Corrections and Community Supervision for their alleged continued use of solitary confinement on incarcerated people with disabilities, a practice that was banned in the Empire State for around two years.

The lawsuit, brought the Legal Aid Society, Disability Rights Advocates and Winston & Strawn against DOCCs and the New York State Office of Mental Health, claims that the state has continued to hold incarcerated New Yorkers in solitary confinement, despite the prohibition on the practice under the Humane Alternatives to Long-Term Solitary Confinement Act, or HALT Solitary Act.

The law, which went into effect in March 2022, prohibits prison and jail officials from putting detainees or incarcerated individuals with disabilities into the restrictive cells. It also prevents the use of solitary confinement on those 21 years or younger, 55 years or older, anyone who is pregnant or anyone in the first See story on page 2

# **DOCCS violated ban on solitary confinement law, suit claims**

8 weeks of the postpartum recovery period. The law also, generally, puts a number of restrictions on the use of solitary confinement in New York's jails in prisons.

But according to the lawsuit, the state has made little effort to actually implement the law and has flagrantly violated at least one of its core tenants.

In any given month since the law's enactment, DOCCS has held dozens of people with disabilities in its solitary confinement units, according to the suit, which cited DOCCS' own data.

But the state agency has also allegedly refused to acknowledge certain disabilities that would make someone ineligible for solitary confinement.

The result – those with disabilities have been subjected to a practice that is proven to cause damage to a person's health, the lawsuit said.

"HALT was intended to prevent the deep damage that people with disabilities often suffer when they are subjected to solitary confinement," said Stefen R. Short, counsel for the Prisoners' Rights Project at The Legal Aid Society.

"DOCCS and OMH have unlawfully refused to recognize a number of disabilities as exempt under HALT, leading to even more incarcerated New Yorkers languishing in solitary confinement to their own detriment," Short added. "This class action lawsuit seeks to hold both DOCCS and OMH accountable for ignoring duly enacted law and for putting the most vulnerable people in their care in harm's way."

Josh Rosenthal, a supervising attorney at Disability Rights Advocates, said it was "long past time for the State to end the use of solitary confinement for people with disabilities."

"New York's passage of the HALT Act represented an historic and important step in preventing the harms that solitary causes for incarcerated people with disabilities," Rosenthal said. "But words are not enough, and DOCCS and OMH must comply with state law and stop this vicious practice once and for all."

The lawsuit, which was filed in Brooklyn

Supreme Court, cites a number of stories from plaintiffs on the case.

Among them was Maurice Anthony, a 42-year-old man who has been incarcerated by DOCCS since 2014 and who is legally blind.

According to the lawsuit, Anthony has been held in solitary confinement in violation of the HALT Act virtually the entire time the law has been in effect.

Housed at the Mid-State Correctional Facility from October 2021 through May 2023, the lawsuit claims that DOCCS held Anthony in a cell between 19 and 20 hours a day, Monday through Friday. During the weekends, he was allegedly held in a cell for 22 to 23 hours a day. Beyond the ban on holding those with disabilities in solitary, the HALT Act also prevents

DOCCS from holding people in the isolating cells for as long as Anthony was allegedly held. Under the law, incarcerated individuals cannot be held in segregated confinement units for

more than 15 consecutive days, or 20 days in total during any 60-day period. Nonetheless, the lawsuit claims that Antho-

ny was held in a Residential Rehabilitation Unit even after he was transferred to Upstate Correctional Facility from May 2023 until January 2024. The housing unit was created after the passage of the HALT Act to serve as an alternative to solitary, however the Legal Aid Society claims that the units are used as de facto solitary confinement cells by DOCCS.

"As a result of the extreme isolation of being held in solitary confinement conditions, Mr. Anthony has experienced claustrophobia, blackouts, hopelessness, and extreme frustration," the lawsuit reads.

"He finds the routine torturous and it makes him feel like he just needs to sleep all the time," the lawsuit continues. "Mr. Anthony has compared solitary confinement to being caught 'in a trunk' or a 'casket' where 'you can't get out.' He has blacked out several times while being held in solitary confinement."

### Two arrested in Ridgewood for re-selling stolen goods

Two Queens boutique owners were arraigned last week for allegedly stealing goods and displaying and reselling them at their Ridgewood store.

Queens District Attorney Melinda Katz said that 56-year-old Juan Nunez of Lindenwood, and 42-year-old Moranta Anibelka of Glendale, were arraigned on May 3 on a charge of criminal possession of stolen property in the second degree.

Katz said that items from Macy's, Victoria's Secret, Lululemon and other major retailers were openly displayed and re-sold at less than half their retail value inside the McKlain Collection Boutique in Ridgewood.

According to the charges, in March and April, members of the Organized Theft Squad, under the NYPD's Financial Crimes Task Force, and the Queens District Attorney's Major Economic Crimes Bureau conducted an investigation into the sale of stolen merchandise from various brand-name retailers, which ultimately led them to the location operated by Nunez and Anibelka.

On May 3, based on the intelligence gathered, law enforcement officials searched the boutique located at 813 Seneca Ave. that resulted in the recovery of over \$500,000 worth of items.

The DA said that officers found 5,035 items including clothing, fragrances, cosmetics and other merchandise belonging to Macy's, valued at approximately \$333,000; 600 items including men's and women's clothing from Lululemon, valued at approximately \$71,000; 2,123 items including undergarments and pajamas from Victoria's Secret, valued at approximately \$59,000; 521 clothing items from Abercrombie & Fitch, valued at approximately \$25,000; and 460 clothing items from American Eagle, val-

ued at approximately \$17,000.

The stolen goods were identified by retail investigators as originating from stores in New York, Delaware, Maryland and Virginia, as well as other states, and were generally sold for cash at approximately 50 percent below their retail value.

Many of the original price tags were allegedly still clearly visible at the time of the raid.

Tools used for the removal of security tags were also seen at the location, though there were no security tag sensors at the location.

"Organized retail crime is fueled by fencing operations that siphon money from legitimate retailers for their own financial gain," said Katz. "The merchandise recovered as part of this raid was allegedly stolen from retail stores across the country by sophisticated teams of thieves who divert profits into their own pockets. Organized retail theft affects everyone through increased prices for consumers, lower sales, and fewer jobs."

NYPD Commissioner Edward Caban highlighted what the threat he believes retail theft brings to New York City.

"Organized retail theft imposes a considerable economic burden on entire communities, including local businesses and the hardworking New Yorkers who patronize them," said Caban.

Nunez and Anibelka face up to 15 years in prison if convicted. Queens Criminal Court Judge Julietta Lozano ordered the defendants to return to court July 3. Jacobk@queenspublicmedia.com

### Hundreds pack Clinton Hill town hall about 'frustrating, disastrous' migrant mega shelter

More than 200 Clinton Hill residents crammed into a standing room only meeting Monday night to raise their concerns about a compound of sprawling migrant shelters where an estimated 4,000 people now live in a two-block radius.

Over the past two years, New York City officials have opened more than 200 emergency migrant shelters in hotels, warehouses, tents, and vacant office buildings, but few at as large a scale and as close to a residential neighborhood as the Hall Street complex, with three main shelters spanning several industrial warehouses.

The quiet opening of another shelter for hundreds more migrants across the street from the complex in April makes the area the "largest concentration of migrants outside of Randall's Island," NYPD Assistant Chief Scott Henderson, who oversees Brooklyn North, told the crowd.

Issues at the Hall Street shelter have been bubbling for months, THE CITY previously reported, with complaints about excess trash, loitering, panhandling and a surge in street homelessness under the nearby Brooklyn-Queens Expressway of people kicked out of the shelter. At the same time, many neighbors have mobilized to help the new arrivals, with mutual aid groups providing regular food and clothing distributions, sourcing winter clothing in the coldest months and helping people fill out their asylum applications.

Residents who view the shelters as a quality-of-life concern and others concerned with the quality of life of the shelter residents largely agreed on the idea that the two back-to-back facilities are simply too large for one neighborhood, with devastating impacts on the surrounding community and migrants themselves.

"Our neighborhood cannot bear this, but they can't bear this either," said 74-year-old Mary Chang, who has lived for 25 years on Hall Street. "It's not the migrants. It's the paradigm. We need a new paradigm. Nobody deserves to live in a room with 300 cots. This is not a humanitarian effort."

#### 'Ground Zero of the City's Mismanagement'

Much of the local ire has been directed at local Councilmember Crystal Hudson and her perceived absence on the issue. "Missing" signs went up around the neighborhood with her face on it ahead of Monday's town hall, hosted by former Democratic district leader Renee Collymore at the Brown Memorial Baptiste Church.

Hudson didn't show at the town hall, though she wrote an open letter to Mayor Eric Adams Monday, pointing to clothing and supply drives she'd been involved with, resource fairs and \$200,000 allocated from her limited discretionary funds to fund additional trash pickups. But she asked Adams to organize and attend a town hall with all relevant city agencies within 30 days, saying she'd filled out one of the mayor's

newly mandated request forms a month ago with the request.

She said she didn't attend the town hall because she had another tenant association meeting that evening where a fire had recently taken place.

Hudson said she'd been in correspondence with city officials who said that Clinton Hill would be added to schedule of mayoral town hall meetings in various neighborhoods, but didn't commit to hosting a meeting about the Hall Street shelter specifically.

"My office and my neighbors have been asking for your assistance for the better part of a year to no avail. I have a team of six. You have a team of nearly 1,300," Hudson wrote to Adams. "While some measures may be out of your control and in the hands of our partners in Washington, D.C. and Albany, you can and must do better by my constituents — new and long-time residents alike." Amaris Cockfield, a spokesperson for the

mayor, declined to say whether the city would follow through with a town hall meeting with Clinton Hill residents. "We appreciate the councilmember's partner-

ship in this very important work to house and care

for over 65,000 migrants still in our system," she said in a statement. "We manage hundreds of people who continue to arrive in our city every day, we are doing so more efficiently and in a more cost-effective manner by looking toward longterm planning and management to stabilize and protect our shelter system."

Henderson and other NYPD leaders were the only city officials present Monday night. The public Health and Hospitals Corporation, which oversees the Hall Street site, had previously committed to quarterly meetings with residents and creating an email inbox to field complaints. But Hudson said after that H+H has since directed people to fill a centralized request form.

Residents at the town hall vowed to fight the mayor from extending the 18-month, \$45-million shelter contract, beyond next March when it expires. A carveout in the contract allows the city to extend the lease with developer RXR for as long as eight years, the CITY previously reported.

"Our fight has to be about getting the mayor to end this lease because he did it without any oversight, and demand the city create smaller, rightsize shelters across the five boroughs," said Hall Credit: Ben Fractenberg/THE CITY Street resident Alia McKee. "We are at ground zero of the city's mismanagement of the migrant

crisis and we need to demand better," she said to passionate claps of audience members. Before the start of the migrant crisis two years ago, local laws barred the Department of Homeless Services from building new dormitory-style shelters with more than 200 beds, one of many long-standing norms that went out the window

as more than 195,000 migrants made their way across the southern border and to New York City over the past two years. Kristina, who declined to give her last name, said she'd been involved with mutual-aid efforts over several months and implored her neighbors to regard their thousands of new neighbors with

compassion. "I hope that everyone here can understand that as frustrating and as disastrous as the situation is, it is important to remember that the people who are in our neighborhood today have suffered enormously," she said.

# **Seview and comment** Boomers Have a Drug Problem, But Not The Kind That You Might Think

Baby boomers — that's anyone born in the U.S. between 1946 and 1964 — are 20% of the population, more than 70 million Americans. Decades ago, many in that generation experimented with drugs that were both recreational and illegal. Although boomers may not be using those same drugs today, many are taking medications, often several of them. And even if those drugs are legal, there are still risks of interactions and side effects.

The taking of multiple medications is called polypharmacy, typically four or more at the same time. That includes prescriptions from doctors, over-the-counter medicines, supplements and herbs. Sometimes, polypharmacy can be dangerous.

I am a geriatrician, one of only 7,500 in the U.S. That's not nearly enough to accommodate the surging number of elderly boomers who will need medical care over the next two to three decades — or help in dealing with the potential problems of multiple drug use.

### Reactions to medications can change over time

We geriatricians know that polypharmacy isn't always bad; multiple medications may be necessary. If you've had a heart attack, you might be on four medications or more — beta-blockers, ACE inhibitors, statins and aspirin, for instance. And that's appropriate.

But about half of older adults take at least one medication that's not necessary or no longer needed. Doctors need to periodically reevaluate to make sure each medication is still right for the patient and still the correct dose. During treatment, the patient's weight may fluctuate, either up or down. Even if it stays the same, body composition might change; that occurs as people age. As a result, one may react differently to a drug. That can happen even with a medication a person has been on for years.

Polypharmacy often means higher health care costs and more drug interactions. Patients are more likely to miss medications or stop taking them altogether. Sometimes, physical activity diminishes; falls, cognitive impairment, malnourishment and urinary incontinence increase; there may be less ability to do daily tasks.



Some boomers are on multiple medications. Combinations of those drugs could have serious side effects,

Those on five or more medications have a much higher incidence of having an ADE — an adverse drug event — compared to those using fewer meds. Making matters worse, the symptoms of polypharmacy are sometimes masked and taken as signs of aging.

#### Check the list

Studies have suggested solutions, with better coordination among care providers being one. Making the pharmacist an integral part of routine care is another. The increasing use of electronic patient records helps. So do smartphone apps, sometimes an easier way for patients and providers to connect. But so far, there's no magic pill, and as researchers and clinicians investigate improvements, much of the burden remains on patients and their families.

There are steps you can take to stay safe, however. Regularly clean out the medicine cabinet and get rid of expired medicines or those you're no longer taking. Either throw them away or ask your

doctor or pharmacist about the best way to dispose of them. When seeing the doctor, bring in the meds you take and review each one in detail. Make certain you need to continue taking them all and verify the right dose.

You can also check the PIMs list, also known as the Beer's List. Published by the American Geriatric Society, it's an index of medications potentially harmful to the elderly. Some are linked to increased risks of side effects, and not a few are sold over-the-counter without prescription.

That includes medicines containing antihistamines like diphenhydramine, or Benadryl. In the elderly population, Benadryl carries an increased risk of dizziness, confusion and urinary retention. Medicines that are part of the NSAID family (nonsteroidal anti-inflammatory drugs) are also on the list. In some elderly patients, they can cause high blood pressure or kidney failure. Commonly used medicines in the NSAID family are those containing ibuprofen or naproxen.

Just because a medicine is on the Beer's List doesn't mean your doctor was wrong to prescribe it, or that you should stop using it. Instead, use the medication with caution and discuss with your doctor to make sure you need it. Determine with your doctor the lowest useful dose, monitor for side effects, and speak up if you have any. As a geriatrician, I see patients in an

As a geriatrician, I see patients in an outpatient setting, either as their primary care provider or as a specialist consultant. We review medications at every visit: the list, the dose and how often the patient is taking it. A true and accurate medication list is the critical first step in geriatric care.

This is especially important during care transitions, such as when a patient is coming out of the hospital or nursing home. Particularly at that time, we find out if the patient is using the medication as prescribed, or taking it more frequently or less or not at all. Which leads to my final piece of advice: If you've strayed with your meds, one way or another, know that we doctors don't judge or punish patients. Just tell us the truth. That's all we want to hear. Then we can move forward together to find the best regimen for you.

### Sky Falls in on Liberty In Chicago

#### New York thumped 101-53 in preseason opener

It's on to Connecticut for the New York Liberty after their preseason opened with a resounding thud in Chicago.

The WNBA's Eastern Conference "Superteam" and championship runner-up got dominated from start to finish in the Windy City, suffering a 101-53 beating from the Sky in front of 3,132 fans at Wintrust Arena.

"We have to go back to the drawing board and get ready for Connecticut," Liberty head coach Sandy Brondello admitted after her unit trailed by as many as 50 in its first action since dropping a heartbreaking Game 4 to back-to-back champion Las Vegas in Brooklyn last October.

"They have to look at themselves," she added. "At the same time, we have to make sure we stay together. We didn't weather the storm."

New York's decorated starting five, consisting of reigning Most Valuable Player Breanna Stewart, former MVP Jonquel Jones, All-Star Sabrina Ionescu, future Hall of Famer Courtney Vandersloot and Betnijah Laney-Hamilton, looked more like not-ready-for-prime-time players.

like not-ready-for-prime-time players. "They have a lot of pride too," Brondello insisted. "They will (respond). It's just disappointing that we didn't come out and play the way they should. But give credit to Chicago. ... People are underesti-

#### mating them."

The Liberty's Fab Five combined for just 25 points on 10-of-33 shooting while the Sky (1-0) raced out to a 24-11 lead after the opening quarter and never looked back.

Marina Mabrey poured in 20 points and Dana Evans added 19 for Chicago, which built a 49-28 cushion by halftime before Brondello put her aspiring rookies and reserves to the test.

First-round pick Marquesha Davis had four points, three rebounds, one steal and a pair of turnovers in 15 minutes off the bench in her professional debut after a standout career at the University of Mississippi.

sippi. "I would say what I learned is to be aggressive. Do the things you're good at," said Davis, who had her former collegiate coach, Yolett McPhee-McCuin, in attendance.

"I think it feels great. Just knowing that she still supports me after Ole Miss," Davis added.

Second-round picks Esmery Martinez and Jessika Carter also had four points apiece, as did training-camp invitee Jaylyn Sherrod, who caught Brondello's eye for her tenacity upon entering the contest.

her tenacity upon entering the contest. "She did a great job, coming off the bench, got a couple of steals for us even though we were down by a lot," Brondello said. "She played to her strengths."

The starters couldn't say the same.

Ionescu, arguably the best 3-point shooter in women's professional basketball, drained two of New York's three 3-pointers on her way to eight points while the rest of the Liberty went 1-for-12 from long range.

Stewart, coming off her second league MVP honor, only managed five points and missed all three of her attempts from beyond the arc in 21 lackluster minutes.

At least Sherrod seemed to understand the importance of a strong first impression as she is trying to make the regular-season roster.

"Just to be aggressive and fearless. That's kind of my M.O. We're gonna mess up. We're rookies," she admitted. "When you're a rookie, it's just about maximizing your opportunities."

Fortunately for the Liberty (0-1), they'll get another chance at a dress rehearsal before their May 14 opener in Washington, D.C. New York, which knocked Connecticut out in four games during last year's Eastern Conference finals, will take on the Sun Thursday night at 7 p.m. at Mohegan Sun Arena.

"We're veterans," Brondello said of her seasoned squad. "They'll respond in the right way."



### City ordered to fix broken pledge to make half of taxis wheelchair-accessible

A Manhattan federal judge scolded the city Tuesday for trying to pump the brakes - again on a long-ago legal settlement that was supposed to have made half of all yellow taxis wheelchair-accessible by 2020.

Hailed a decade ago by United States District Court Judge George Daniels as "one of the most significant acts of inclusion since Jackie Robinson joined the Dodgers," the landmark 2013 deal between advocates for New Yorkers with disabilities and the Taxi & Limousine Commission missed its initial deadline in 2020, along with a 2023 extension


Daniels on Tuesday pressed lawyers for the

city to come up with a formula within two weeks that will detail how the 50% goal will be met.

"This is what you promised to do," Daniels said, recalling how both sides agreed more than a decade ago that a settlement was "the practical way to go."

Michelle Goldberg-Cahn, of the city's Law Department, conceded in court that the city is struggling to meet the 50% mark out of the city's 13,587 medallion cabs.

"It's very impractical to meet the obligation, almost to the point of impossible," Goldberg-Cahn said, citing industry upheaval since the time of the original settlement, including the collapse of medallion values, rise of app-based ride-hailing services such as Uber and Lyft, and a pandemic that

sank ridership.

According to the TLC, 4,406 yellow taxis were fully accessible as of the start of 2024, about 32% of the fleet, with 3,753 in service. Including for-hire vehicles, there are now more than 9,000 wheelchair-accessible vehicles.

In a Lower Manhattan courtroom with several wheelchair users in attendance, the judge at times expressed bewilderment at the city's attempt to be relieved from the settlement's requirements.

They agreed to this twice — in 2014 and in 2021," Daniels said.

Kathy Collins, a quadruple amputee and wheelchair user who travels by taxi and for-hire vehicles, said the initial pledge under former Mayor Mike Bloomberg to make half the yellow taxi fleet accessible was monumental.

"I was like, 'Wow, this is great," she told THE CITY. "But here we are still fighting and that's absurd.'

The hearing followed a February court filing in which advocates accused the TLC of breaching the December 2013 agreement, which was celebrated as "the first of its kind in the country."

At the time of the settlement, just 231 wheelchair-accessible yellow taxis were registered with TLC — not even 2% of the fleet.

Taxi & Limousine Commission officials noted how the entire fleet of for-hire vehicles - including medallion taxis and those from app-based ride-hailing services - has grown substantially in recent years.

"Factoring in our entire fleet, we now have almost three times the number of accessible vehicles we did five years ago," David Do, the TLC commissioner, said in a statement. "We will be working to provide Judge Daniels with the information he requested to make an informed decision."

The TLC on Wednesday will hold a public hearing to discuss a proposal that would eliminate vehicle retirement dates for wheelchair-accessible taxis that pass regularly scheduled inspections, al-

lowing more to stay in service longer.

Collins, who is among the plaintiffs in the case, said the continued legal squabbling is troubling for wheelchair users who take taxis.

You made a deal, you've got to live up to it," she said. "I'm sorry."

### **N.Y. Equal Rights Amendment thrown** off November ballot by upstate judge

New York's Equal Rights Amendment, which would enshrine the right to an abortion in the state, has been ordered off the November ballot after a judge ruled that lawmakers didn't follow the appropriate procedure in passing it.

Two years ago, the state's Democratic Party moved fast to respond to the U.S. Supreme Court's decision in Dobbs v. Jackson Women's Health Organization, which allowed states to curtail abortion rights. That speed may ultimately have doomed their efforts.

Gov. Kathy Hochul called an extraordinary session of legislature, and a week after the Supreme Court ruling, state lawmakers passed the proposed constitutional amendment on July 1, 2022

The amendment would enshrine not only the right to an abortion, but also protections against discrimination related to gender or gender identity. It is also a key part of Democrats' strategy to win back Congress. The party hoped to use the hot-button issues to drive turnout among prochoice voters and to pick up several seats lost to Republicans in 2022.

After it passed the legislature a second time last year, as required, the measure had been set to go before New York voters in November - and had been expected to pass and be enshrined into the state constitution.

But in the rush, Democrats got caught in a procedural misstep in the lawsuit, originally filed in Livingston County Supreme Court.

On Tuesday, Supreme Court Justice Daniel J. Doyle sided with plaintiff Assemblymember Marjorie Byrnes (R-Western N.Y.), declaring the amendment "null and void" and ordering its removal from the ballot.

The issue centers on the timing of a review by Attorney General Letitia James. The state constitution says that when the legislature introduces a

the proposal should go to the attorney general, who will "render an opinion in writing" on how it would affect other provisions of the constitution. Lawmakers can only vote on the bill after they receive that opinion, according to Doyle's interpretation.

In this case, James did issue an opinion greenlighting the proposal — but it came five days after the legislature passed the amendment.

The ruling is "an important check on the legislature," said Christian Browne, an attorney for the plaintiffs.

'This isn't the express line. You have to introduce the amendment, wait for the opinion to come

resolution proposing a constitutional amendment, down," he said. "The constitution is supreme, not the legislature. The legislature has to follow the rules. If they follow the rules, they can pass whatever they'd like."

> The chair of the state's Republican Party, Ed Cox, congratulated Byrnes - and slammed Hochul and the Democrats.

> "In their rush to pass this amendment, the legislature never held a single hearing on the proposal, never consulted with outside constitutional experts, and falsely asserted this amendment was necessary to protect abortion rights in the state," he said in a statement Tuesday.

> Hochul condemned the ruling. "Our decades-long fight to protect equality and reproduc-

tive freedom will not be thrown off track by one extremist judge and I look forward to casting my ballot for the Equal Rights Amendment in November," she said in a statement.

Pro-amendment advocates decried the ruling as unfair, especially since constitutional amendments in past instances have appeared on the ballot without the attorney general issuing an opinion before the first legislative vote. Those include a 1996 amendment to increase monetary jurisdiction of certain New York courts and a 2022 amendment easing a voter registration requirement.

"More than a dozen constitutional amendments have proceeded in this exact manner in the last 50 years — and all made it on the ballot, said Andrew Taverrite of New Yorkers for Equal Rights, a coalition that has backed the amendment. "This ruling is nothing but a baseless attack by the anti-abortion minority, and we are confident it will be overturned on appeal."

Browne said that he expects the defendants to appeal the decision, and to request an expedited timeline to receive a decision before voters head to the polls.

#### Boy Scouts of America is rebranding. Here's why they will be named Scouting America

After more than a century, Boy Scouts of America is rebranding as Scouting America, another major shakeup for an organization that once proudly resisted change.

Founded 114 years ago, the Texas-based organization has recently been mired in turmoil over a flood of sexual abuse claims and bankruptcy. Now, the organization is leaning into a more inclusive message as girls have been joining throughout its ranks.

"It sends this really strong message to everyone in America that they can come to this program, they can bring their authentic self, they can be who they are and they will be welcomed here," said Roger Krone, who took over last fall as president and chief executive officer.

The change was announced Tuesday at the Boy Scout's national meeting in Florida but won't take effect until February 2025.

Here's a look at what led up to the change and why it matters:

The new name puts a focus on inclusivity. Krone told The Associated Press that they wanted a name going forward that made clear that all children and teens are "very, very welcome."

He added that when people question why the organization needs a new name, he points to historically low membership numbers.

Like other organizations, the scouts lost members during the pandemic, when participation was difficult. The high point over the past decade was in 2018, when there were more than 2 million members. Currently, the organization serves just over 1 million young people, including more than 176,000 girls and teens. Membership peaked in 1972 at almost 5 million.

Krone said that although the name is changing, the core of the organization is staying the same. "Our mission remains unchanged: we are committed to teaching young people" to be prepared for life, he said in a written statement.

The organization began allowing in gay members in 2013 and ended a blanket ban on gay adult leaders in 2015. In 2017, it made the historic announcement that girls would be accepted as Cub Scouts as of 2018 and two years later, into the flagship Boy Scout program — renamed Scouts BSA. Over 6,000 girls have now achieved the vaunted Eagle Scout rank.

There were nearly 1,000 teens and young women in the inaugural class of female Eagle Scouts in 2021.

Before it was announced in 2017 that girls would be allowed throughout the ranks, the Boy Scouts announced that they would allow transgender boys to enroll in their boys-only programs.

The organization said this week that all young people, including transgender children, are welcomed as part of their membership policy.

When it sought bankruptcy protection in 2020, the Boy Scouts of America had been named in about 275 lawsuits, and told insurers it was aware of another 1,400 claims.

Last year a federal judge upheld the \$2.4 billion bankruptcy plan allowing the organization to keep operating while compensating more than 80,000 men who filed claims saying they were sexually abused as children and teen scouts.

Rebranding can risk alienating supporters who think the change is unnecessary, said David Aaker, vice chair of the national branding and marketing firm Prophet. But he described the Boy Scouts' rebranding as savvy, saying it kickstarts a new conversation about the organization while not being so drastic that it strays too far from its original scouting mission.

"It's a one-time chance to tell a new story," said Aaker, who also is a professor emeritus at the University of California-Berkeley Haas business school.

The National Organization for Women had urged the Boy Scouts to open membership to girls throughout its ranks. Bear Atwood, vice president of NOW, said the name change "signals that not only are girls allowed to join, but they are welcome to join."

Reaction online Tuesday ranged from those excited and supportive to those decrying that "boy" no longer appears in the name. "Wokeness destroys everything it touches," wrote state Rep. Andrew Clyde, a Georgia Republican, on the social platform X.

The Boy Scouts of America won't officially become Scouting America until Feb. 8, 2025, the organization's 115th birthday. But Krone said he expects people will start immediately using the name.



## Harvey Weinstein sent back to Rikers after **THE CITY exposed VIP treatment**

It's curtains for Harvey Weinstein's stay in a private hospital room.

The disgraced media mogul, 72, was moved back to the West Facility on Rikers Island hours after THE CITY reported he was being kept in a private room inside Bellevue Hospital's Intensive Care Unit on a floor away from all other detainees.

"Your article was pretty much the reason," Weinstein's longtime spokesperson, Juda Engelmayer, told THE CITY Monday night.

Almost all city detainees with serious medical issues are kept inside the Department of Correction's medical unit on the 19th floor of the Manhattan public hospital.

But Weinstein was given his own phone, bathroom, and television - a perk few, if any, other city detainees are afforded. He spent his days talking to his legal team and watching CNN and other television programs.

He had been moved to the Bellevue almost immediately after he was brought to Rikers Island on April 27, when an state appeals court tossed his 2020 rape conviction.


At the time, Weinstein complained he was experiencing chest pain, according to a jail source, who noted the producer was also asking for a Pepsi.

His legal team says he's dealing with a host of other serious medical conditions like constant chest and abdominal pain.

"He's a sick man," Weinstein attorney Donna Rotunno told THE CITY on Monday. "Harvey has multiple health issues and he's never gotten the level of care that he received prior to going into custody.

But after a series of tests medical staff at Bellevue concluded there was nothing serious enough to require hospital care, according to the Rikers source.

"The decision to discharge Mr. Weinstein from Bellevue Hospital and return him to Rikers Island was made by medical staff from New York City Health + Hospitals who are more than qualified to make these medical decisions," said Engelmayer.

#### **Back and Forth**

Most high-profile detainees held at Rikers are currently kept in s West Facility. That jail was opened in 1991 to house people with contagious diseases. Now it is largely empty and detainees placed there, like former Trump Organization CFO Allen Weisselberg, are typically given their own cells - away from other people locked up.

Weinstein was originally put in that area but was unhappy being on Rikers at all, according to the jail sources.

Frank Dwyer, DOC's chief spokesperson, confirmed Weinstein was moved back to Rikers Monday night. He declined to comment further or explain why he was housed in the Bellevue ICU for days

"Individuals in custody may require extended medical care which would necessitate staying at NYC Health + Hospitals/Bellevue," DOC spokesperson Annais Morales told THE CITY Monday.

Jeanette Merrill, a spokesperson for the city's Correctional Health Services, which oversees medical care for incarcerated people, said Monday that she can't "discuss the care of any specific patient due to privacy laws.'


There is a forensic health general medicine unit at Bellevue," she added. "However, if a patient requires a higher level of care, they can be treated in another medical unit in the hospital."

Weinstein was previously incarcerated at the Mohawk Correctional Facility, about 100 miles northwest of Albany. He was transferred to city custody after New York's highest court vacated his conviction, ruling that a trial judge unfairly allowed jurors to see and hear evidence that was not directly related to the charges.


The decision tossed his 23-year prison sentence and called for a retrial.

Weinstein remains behind bars because of a 2022 conviction for another rape in Los Angeles. The state of California sentenced him to 16 years in that case

## Rozario family calls for firing of NYPD officers who killed teen

killing. They were also kept out of their home for two days following Rozario's death. "After my brother was killed, the NYPD

treated me and my mother like we were criminals," said Utsho. The 17-year-old said that both he and his

mom were immediately taken to the 102nd Precinct. Utsho, who was wearing shorts and a sweatshirt, said that he wasn't allowed to change despite the chilly weather.

Utsho also said they were not able to retrieve his parents' medication or their family cat until they got back into their home 48 hours later, where Queens based advocacy group DRUM helped them clean up the blood left at the scene. They didn't seem worried about us at all,"

he said. Body camera footage released on Friday by the state attorney general showed the entire interaction, which lasted less than three minutes.

On March 27, Alongi and Cianfrocco approached the Rozarios' Ozone Park home after they reportedly got a call from the teen himself seeking help amid a mental health episode.

After speaking briefly with Utsho they went upstairs to the apartment, where Win was there with Ava Costa. Win then went and retrieved a pair of yellow scissors from a drawer and moved in the direction of the police, but was stopped by his mother.

Alongi almost immediately pulled out his Taser, while Cianfrocco pulled out his gun.

Alongi then fired his Taser, striking Rozario. Despite the discharge of the Taser, Ava Costa continued to hold onto her son.

"Let go of him, and back up," the police shout. "Let go of him, miss"

Utsho, who was standing to the left of police, said, "Please don't shoot my mother," a phrase he continued to beg from the officers throughout the remainder of the incident.

Though at one point, his mother was able to take the scissors out of Rozario's hands, the teen eventually grabbed them again and was almost immediately shot at least four times by the officers, the bullets flying over the heads of Ava Costa and Utsho.

Advocates and elected officials who joined the Rozario family said Rozario's death "completely avoidable," and blasted Alongi and Cianfrocco for missing several opportunities to deescalate the situation.

Utsho, who answered the door for the police, had some of the most damning comments directed at the NYPD and Adams

"I'm really angry and disgusted that the people that's supposed to serve and protect us are the ones that's killing us," he said. "The police were so aggressive and reckless that they could have killed my mom, and me too, in our own house." Utsho joined the calls and said the officers

should be suspended and fired for killing his brother, and admonished Adams' response, which included a misspelling of Win's first name.

'He has to make further comments," he said. "He needs to suspend them without pay and fire them. As a New Yorker, I'm calling out to all New Yorkers to get together. Don't let these corrupt cops and NYPD get away with killing my brother. Don't let those corrupt cops kill more people."

A handful of city councilmembers - none of which represent Queens – also called for Adams to fire the officers involved and for the city's police to be pulled off of mental health response calls.

"This is Mayor Adams's NYPD," said Councilmember Shahana Hanif. "We know that Win's murder is just another example of why the police should not be the default responders when there is a need for health centered inter-

> vention. Chair of the Committee on Criminal Justice Sandy Nurse echoed those sentiments.

"This is what is the result of constant defunding, constant disinvestment of our mental health ecosystem,' she said. "For two and a half years, we have seen funding for mental health programs not materialized. We're not investing in the mobile crisis team. We're not investing

"If you watched that video, from the second the door opened, the attitude was wrong," she added. "They weren't listening, they weren't feeling the room. That was not a situation to escalate in, and it should never be a scenario that when you call for help, you end up dead.'

City Hall said that Adams would not comment further on the killing, and directed the Eagle to his previous statements on the matter.

## Queens atty to lead court system's civic engagement work

A prominent Queens attorney has been picked by New York's court leaders to serve as the state's first-ever civic engagement coordinator

Zenith Taylor, who currently serves as a court attorney referee in Queens County Supreme Court, Civil Term and who is soon to be appointed the president of the Queens County Bar Association, was named as the courts' first statewide civic engagement coordinator on Wednesday. She officially takes office on Thursday.

Taylor, who also previously served as the president of both the Catholic Lawyers Guild of Queens County and the Queens County 's Bar Association, will be charged with leading the development and implementation of the court system's civic engagement programs, which have been given renewed attention under Chief Judge Rowan Wilson.

The chief judge made civic education the focus of his Law Day address earlier this month. It also was a central feature of his State of the Judiciary address given earlier this year.

Recent studies point to an alarming lack of civic literacy among Americans," Wilson said in a statement this week. "As chief judge, expanding the New York State Courts'

community outreach and civic education initiatives is among my top-most priorities.

"[Taylor] is a talented attorney who, believing deeply in this mission, has worked with bar associations and other groups to create and deliver programs to educate the public about the workings of the courts and legal system and help spur civic en-gagement," Wilson added. "I am eager to work with her, along with the court system's leadership team judges, non-judicial personnel, and justice partners, towards our goal of engaging and informing New Yorkers, particularly young people, in the work of the New York State Courts and our State government."

Taylor said she was "thrilled and honored" to be named to the new post.

"It is truly exciting to have the chance to assist the court system in community outreach and the development of programs to demystify court procedures and promote civic education and engagement," the Oueens attorney said.

Taylor's role will fall under the court system's communications office. The programming she develops in the position will be used to educate students, teachers and the public on the role of the courts in New York. The program ming will also inform people about specific legal issues and historical legal events.

Taylor, in the new job, will work with local courts to facilitate civic participation, and will report on the court system's progress in engaging the public in its work.

Chief Administrative

Judge Joseph Zayas, who himself served as a jurist in Queens for around a decade, celebrated Taylor's appointment in a statement.

"Ms. Taylor is an experienced attorney whose knowledge of the law and court system, combined with her leadership qualities and active participation in a wide variety of community outreach programs, will serve her well in meeting the multiple demands of this pivotal and challenging assignment," Zayas said. "I have every confidence that she will be an asset to our local courts throughout the State, to the communities they serve, and to the court system's many justice partners, helping advance our access to justice and civic engagement efforts.'

Taylor, who graduated from Howard Unirsity School of Law has served in Oueen County Supreme Court since 2019. As a court attorney referee, she's presided over kinship hearings and uncontested divorce matters. She's also worked to develop a number of training programs.

Prior to her court attorney referee role, Taylor worked as a private attorney for over 25 years, specializing in divorce, family law and trust and estate law.

As a solo practitioner, Taylor also spent time on the borough's 18-B panel, representing indigent clients.
