Top NYPD officials had very little to say Thursday when questioned by the City Council about a series of antagonistic social media posts authored by some of the department's top brass in recent weeks.

Despite the outspoken posts made by a number of the NYPD's leadership team on X, the social media platform formerly known as Twitter, NYPD Commissioner Edward Caban and his deputies were relatively mum when scrutinized for the posts by a visibly frustrated City Council Speaker Adreinne Adams during a Council budget hearing on Thursday.

The speaker, who also questioned NYPD of-

ficials on their social media posts in a previous budget hearing earlier this year, blasted police leadership for allowing the posts to continue, despite months of protest from lawmakers.

"These posts can often convey inaccurate or misleading information and could potentially incite threats of violence," the speaker said on Thursday. "This conduct is dangerous, unethical, unprofessional, because included in the department's mission is to preserve peace."

Though Adams said that she took issue in general with NYPD leadership expressing personal opinions on their official government social media pages, she appeared to be particularly incensed by one tweet in particular – a post sent by NYPD Chief of Patrol John Chell directed

at Queens City Councilmember Tiffany Cabán, who has no relation to the police commissioner.

The tweet by Chell, who was scheduled to appear at the hearing but did not show, prompted a long back and forth between the NYPD and a number of councilmembers at the start of the month and on Wednesday, the Department of Investigation unveiled that the tweet and potentially several others were the subject of an investigation.

Citing the investigation, NYPD officials declined to answer virtually all of the speaker's questions regarding the NYPD's recent X proclivity.

The Adams administration's 60-day shelter limit rule for families was poorly implemented and caused migrants to be haphazardly pushed out of the shelter system, a new report released this week claims.

A newly released report from the Office of Comptroller Brad Lander found that the implementation of the controversial 60-day rule – which evicted asylum seeker families from city shelters after that time frame in an effort to free up shelter space and get asylum seekers into more permanent homes – did little to help migrants move into better arrangements once they left the system. Even after pushing migrants out, the city did little to follow up and ensure they made it into a new home, the report claimed.

"The 60-day policy was implemented in a haphazard and arbitrary way, without adequate written guidelines in place, without training to the staff or contractors, without sufficient notices to families and with arbitrary outcomes," Comptroller Brad Lander, a frequent critic of See story on page 2

the mayor's handling of the asylum seeker crisis, said from Midtown on Friday.

The 60-day rule, which sparked outcry from lawmakers and advocates last year when it was announced, was intended to help migrants move through the system, and to lessen the financial and logistical burden on the city that was dealing with the massive influx of asylum seekers, the mayor said at the time.

According to the comptroller, as of April 28, the city has issued 60-day notices to 10,229 families with children, affecting 19,497 adults and 18,149 kids. Of those individuals, 51 percent left the shelter system entirely, 40 percent relocated to another shelter somewhere in the system and 9 percent are in the shelter where the 60-day notice was given.

Ahead of the rule's implementation, the administration had said it would provide case management for migrants to help them land on their feet once moved out of the shelter, something the report argues never actually happened.

"Our investigators found that there's very little case management of any sort," Lander said. "What there essentially are, are repeated screenings to insist that you must have somewhere else to go over and over and over again. There is no assistance in finding stable housing."

Though the administration set the goal of conducting up to five "exit planning meetings" with migrants, the comptroller's office found that those meetings were limited. When they were conducted, officials were more concerned with placing migrants with family members than they were with assisting them in finding permanent housing of their own, the report claims.

The report further found that once migrants moved out of the shelter system, the city did not track where they wound up, or whether or not they actually found suitable living arrangements or gainful employment.

"It was a policy designed to churn people through a system, to subject them to screening after screening, and to push them out of the shelter system with no regard for where they landed, with no regard for the impact on their kids' education, and with no regard for their actual path to stable housing, employment and self sufficiency," said Lander.

Queens – the borough with some of the highest shelter numbers in the city – has seen some of the negative effects of this lack of policy.

In February, officials found dozens of migrants living in the basement of a furniture store in Richmond Hill in less than ideal living con-

ditions. Some of the migrants there allegedly blamed the new eviction rule for their move to the store

"We saw that horrible situation where folks were in the basement of that store, so we know, and at least in some cases, people are winding up in very dangerous circumstances," said Lander.

Beyond allegedly not working as intended, the policy was also applied inconsistently, the report said.

According to the comptroller, some families were forced to relocate to other shelters after the 60-day limit hit while others were able to stay with no clear reason why.

Even when the city did create exemptions for some populations, like pregnant women in the third trimester, they did now follow up and create written guidelines for employees to implement that exception.

"No written policy was ever promulgated," Lander said. "Staff and contractors did not get that information...the policy was not actually established."

Since the beginning of the policy, which speakers on Thursday called "cruel," Lander and others had been against it, and say that the fumbled implementation only serves to affirm

those previous concerns.

"The findings within the comptroller's report should not be a surprise to anyone who's been paying attention," said City Councilmember Alexa Aviles, chair of the Council's Committee on Immigration. "The Adams administration designed the 30, 60-day rule to be a bureaucratic nightmare."

Aviles likened the policy to hostile architecture aimed at limiting homeless populations, like benches that don't allow people to lie down.

"This policy was simply made to push people out, to disregard their humanity, to disregard their experience, but to make them so uncomfortable that they would self-select to move on despite the real challenges that face them," she said.

Officials in Midtown on Thursday and the report itself argued that the city should fill the gaps in the rule's implementation, while also calling for the abolition of the policy at its face.

The report recommends the city create clear written policies and procedures and track the outcomes of migrants who come through the system

With the end of the school year on the horizon, Lander also called for the city to suspend the evictions of families with school-aged kids.

"Let those kids stay in their public schools and conclude the year with their teachers and their classmates," he said.

City Hall says that more than 80 percent of kids whose families were subjected to the 60-day rule remained enrolled in their original school.

Immigration and shelter advocates who spoke on Thursday argued that the 60-day policy's implementation harms a population that can help the city going forward.

"Overall, new immigrants bring so much to our economy and energize our city and are the future of the city," said Legal Aid Society's Joshua Goldfein.

Goldfein, a staff attorney at Legal Aid has been one of the lawyers fighting to keep the decades old Right to Shelter mandates in place when the city tried to skirt the responsibility.

That case was settled in March.

"When we have declining enrollment in our schools, and we have labor shortages, this is a time to be investing in helping people make our city better and not pushing them out," Goldfein said.

In response to Lander's report, City Hall defended its actions and the 60-day notice policy as it continues to manage the migrant crisis.

"With more than 195,000 migrants coming through our care since the spring of 2022 – more than 65,600 of which are still in our shelter system – and hundreds of more people arriving every single day asking for shelter, our 30-and-60-day notices are one tool in our very limited toolbox to help migrants to exit shelter because, as we have repeatedly said, New York City is long past its breaking point," said a mayoral spokesperson.

"Nearly half of all families who have seen their 60-day notices expire, and more than 65 percent of all migrants that have come through our care, have moved out of our shelter system — without a single migrant family with children being forced to sleep on the street," the spokesperson added. "While several suggestions made in the comptroller's report are already part of our policy, any ideas on how to improve our herculean work are welcome and will be considered."

City Hall also denied that they do not have a written policy for pregnant shelter residents, and have adequately trained its staff to provide exit planning and guidance to migrants.

Two men sentenced for \$10 million JetBlue fraud

Two men, including one from Queens, were sentenced to prison this month for defrauding a local airline of around \$10 million.

Julien Levy, from New Jersey, and Keily Nunez, from Jamaica, Queens, were sentenced to 40 and 20 months in prison, respectively, on Friday in federal court in Brooklyn for defrauding JetBlue Airways of millions of dollars through a fake contracting scheme.

The sentences were announced by Breon Peace, United States attorney for the Eastern District of New York, and Ivan J. Arvelo, special agent-in-charge of Homeland Security Investigations, following the duo's guilty pleas to committing honest services wire fraud.

Levy, the owner of Summit Aviation Supply LLC, and Nunez, who worked for the Queens-based airline, engaged in a scheme that involved manipulating contracts and the identity theft of a deceased employee to bypass JetBlue's internal controls

According to prosecutors, Levy bribed Nunez to approve fake aircraft part invoices that his company would never send over.

Their actions, which spanned from July 2017 to June 2021, led to the approval of over \$10 million in fraudulent invoices, directly benefiting their own interests at the airline's expense.

U.S. Attorney Peace commented on the case, emphasizing the commitment to holding

individuals accountable for corrupt business practices.

"These defendants shamelessly lined their own pockets by diverting millions of dollars in airline part contracts to entities they controlled," Peace said. "Today's sentence sends a clear message that those who betray the trust of their employers by disrupting marketplaces for their own personal gain will be held to account."

The investigation received support from the Internal Revenue Service Criminal Investigation. The prosecution was led by Department of Justice Trial Attorney Patrick J. Campbell and Assistant United States Attorney Nick Axelrod, with assistance from Paralegal Specialist Liam McNett



Winnie Greco, top Eric Adams aide, back at work after being sidelined by FBI raid

A top aide to Mayor Eric Adams who went on leave after her two houses were raided by the Federal Bureau of Investigation in late February is back in a government job, THE CITY has learned.

Winnie Greco, whom Adams appointed as his Director of Asian Affairs at a salary of \$100,000 in January 2022, was sidelined after the feds raided her homes in The Bronx and a mall in Queens where she had held numerous fundraisers for Adams' 2021 mayoral campaign.

At the time of the FBI raids on Feb. 28, an administration source told THE CITY that Greco was on medical leave after suffering a medical episode. That source added that, once recovered, Greco would go on unpaid leave after her vacation days were exhausted and that she would not be performing governmental work.

A City Hall source said Greco has been spotted since Friday at an office across from City Hall at 253 Broadway.

"She's back," the source told THE CITY. "Obviously, a lot of folks were like, 'Woah!"

THE CITY and Documented have previously reported that donors to Adams' campaign who worked at the shopping center, the New World Mall in Flushing, said they were illegally reimbursed for their donations or that they had no knowledge of donations made in their names

On Wednesday, a mayoral spokesperson said it was determined last week that Greco could return to work. The spokesperson said Greco was working under the "direct supervision" of the Commissioner of the Community Affairs Unit, Fred Kreizman, but did not respond to questions about Greco's salary, title or duties.

Later, the spokesperson said another mayoral staffer who was put on leave after her home got raided by the FBI in early November, Rana Abbasova, had not returned to work. The spokesperson noted that all employee decisions are made on a case-by-case basis.

In November, the FBI also raided the home of Adams' chief political fundraiser, Brianna Suggs, and confiscated Adams' cell phone and other electronic devices in a probe that reportedly centers on alleged illegal campaign donations that originated from Turkish nationals.

Even before the federal raid, Greco was already under investigation by the city's Department of Investigation after reporting by THE CITY on allegations that she tried to benefit improperly from her government position.

A business executive told THE CITY that Greco allegedly solicited a \$10,000 donation to a nonprofit she founded as a condition for attending an event at Gracie Mansion with the mayor.

A former Adams campaign volunteer also

said Greco allegedly required him to perform unpaid renovation work at her primary Bronx home for two months as a condition for helping him land a government job.

After the volunteer got hired by the city government, Greco continued to seek his assistance on the renovations — including during hours when he was supposed to be doing his day job.

Greco is a longtime volunteer advisor to Adams, starting during his early days at Brooklyn Borough Hall in 2014.

She worked for Adams for eight years, never earning a government paycheck, and was also a prolific volunteer fundraiser for his political campaigns. That fundraising continued even after Greco landed a position in city government.

Greco also led Adams' advocacy for a "Friendship Archway" to be donated from a district of Beijing, China to Brooklyn's Sunset Park, at the same time she headed a nonprofit that was ostensibly created to pay for upkeep of the structure. The nonprofit helped fund at least one of the mayor's trips to China.

Despite a decade of advocacy by Adams and Greco, the archway has not been built, and the nonprofit has lost its federal tax-exempt status after failing to file records with the IRS about the money that was raised and spent.

Commencement Isn't Just About Getting Degrees; Cancellations Leave Students Disconnected

Following the wave of protests over the war in the Gaza Strip, several U.S. universities have decided to cancel or ramp down commencement ceremonies. More are expected to follow.

Announcing their decision, these institutions cited security concerns related to the turmoil and division that followed the protests. This, however, may simply make a bad situation worse.

As an anthropologist who studies the human need for ritual, I have spent two decades investigating the role of collective ceremonies in creating meaning and belonging. I have also seen the flip side of that: Depriving people of meaningful rituals can lead to disillusionment and social disengagement.

Rites of passage

From the cradle to the grave, the most important moments of our lives are ritualized. From personal milestones such as birthdays and weddings to societal changes like the transfer of government power, all major transitions are shrouded in ceremony. The fact that these rituals occur without exception in all human societies highlights their importance.

The anthropologist Arnold van Gennep called these ceremonies "rites of passage." He noted that across cultures, they have a similar structure and achieve similar outcomes.

Rites of passage typically involve three stages. First, participants are separated from their previous way of life, physically or symbolically, and move toward a new status and identity. For instance, civilians may give up their familiar routines and move away from their friends and family to join the army. Students do the same when they leave behind campus life to join the labor force.

The second phase is the liminal period between stages. It is characterized by ambiguity and uncertainty, as initiates leave their former status behind but have yet to assume their new role. During that period, a cadet may feel as neither a civilian not a soldier; a bride neither single nor married; and candidates neither pupils nor graduates.

In the third and final stage, the transition is complete and the initiate is reintegrated into society with new status. As a military initiation turns civilians into soldiers, a commencement turns apprentices into qualified professionals.

Rituals can shape social reality

Rites of passage do not merely celebrate the transition to a new state – they actively create this new state in the eyes of society.

Research shows that people unconsciously perceive ritual actions to cause actual changes in the world. This is why even minor changes in protocol may leave the impression of failure. When Barack Obama uttered the words to the presidential oath of office in the wrong order, the legitimacy of his power was questioned. Eventually, he had to retake the oath. Moreover, when an action is ritualized, it feels more special and appealing.

This is why ritual accompanies all special transitions in our lives. And the more significant the moment, the more pomp is required. The grandeur and formality of the ceremony activate psychological processes related to how we appraise the world. Good things require expenditures of effort and resources. A ritual loaded with opulence signals that this is a moment worth remembering

The opposite is also true. Stripped of a meaningful rite of passage, an important transition may feel less real and its significance diminished. Imagine that no one remembers your 50th birthday; or that, as the clock strikes midnight on New Year's Eve, you find yourself on a deserted island. Assuming you had a clock with you, would that transition feel the same?

A passage without a rite

Not everyone cares about a graduation ceremony. Indeed, some graduates choose

not to attend theirs. But those are the rare exceptions. The vast majority of graduating students do care, and so do their families, as is evidenced by packed auditoriums and stadiums across the country.

and stadiums across the country.

In the spring of 2020, the University of Connecticut, where I teach, announced that it was suspending all campus activities in response to the COVID-19 pandemic. That day, the first question my students asked me was "Will we be able to have a graduation ceremony?" As with most colleges around the world, the answer was no. I still remember the disappointment in their faces.

Most high schools canceled their graduations in 2020, too. And now, many of those students are having a déjà vu. Once again, they will be deprived of an opportunity to celebrate their accomplishment.

Graduating from college can be one of the most important transitions in a person's life. Unless they are going to graduate school, it involves radical changes in their lifestyle, social relations and overall role in society.

The lack of a symbolic act to demarcate that change can leave graduates in Van

Gennep's liminal space, a feeling that the transition has not been properly completed. In the words of the anthropologist Victor Turner, they are caught "betwixt and between."

In addition to their personal importance, rituals also play important roles in shaping group identities. One might even argue that the only times a conglomerate of individuals truly becomes a group is during the performance of collective rituals. After all, the members of an extended family tend to gather together only at events like weddings and funerals. Religious adherents only congregate to perform a sacred ceremony. And a student body only comes together as one to partake in a commencement.

Graduation ceremonies embody not only the sacredness of education and the importance of student achievements, but also graduates' bonds to their institution and fellow students. In that capacity, such gatherings may be needed more than ever in a context fraught with division.

New Biden administration rule aims to speed up asylum screening for limited group of migrants

WASHINGTON (AP) -A new Biden administration rule announced Thursday aims to speed up asylum processing at the southern border, enabling it to quickly reject a limited group of people believed to have committed serious crimes or who have terrorist links.

The change comes as the administration has been struggling to demonstrate to voters during an election where immigration is a key issue that it has a handle on the southern border. Republicans have consistently slammed the Biden administration over policies that they say have worsened problems at the southern bor-

In a statement announcing the changes, the Department of Homeland Security said migrants who are deemed to pose a public threat are taken into custody but a determination on whether they're eligible for asylum isn't made until later in the asylum process. Under the proposed rule, asylum officers hearing cases at an initial screening stage that happens just days after a person arrives in the country will now be able to consider that criminal history or terrorist links when deciding whether someone should ultimately be removed from the country.

"This will allow DHS to

expeditiously remove individuals who pose a threat to the United States much sooner than is currently the case, better safeguarding the security of our border and our country," the department said in the

Under current law, there are certain mandatory bars that make people ineligible for asylum, for example, if you've been convicted of a particularly serious crime. But those usually come into play when an immigration judge is making a final determination on whether someone gets asylum and that process can take years. Migrants are usually detained during this time, the department said.

"The proposed rule would allow Asylum Officers to issue denial of claims within days after an individual is encountered when there is evidence that the individual is barred from asylum because of a terrorism, national security, or criminal bar, thereby significantly shortening the overall time between encounter and removal from the United States," the department said.

The agency gave no figures on how many people would be affected by the determination but said in the statement that it

Claxton Remains Top Priority For Nets

Unrestricted free-agent center should stay in Brooklyn

Jordi Fernández high has hopes for Nic Claxton next season and beyond.

But first, Brooklyn Nets general manager Sean Marks has to re-sign the unrestricted free agent center for his new head

That deal appears to be more of a likelihood than a question mark as the summer approaches.

With free agency looming after June 30, the Nets, who finished out of the playoffs for the first time in six years this season, are making Claxton's return their top "priority" according to Marks

"priority," according to Marks.

"I think Nic is the number one priority for us," Marks intimated shortly after Brooklyn finished 32-50 and went through former head coach Jacque Vaughn and interim Kevin Ollie before bringing in Jordi Fernández. "There's no doubt about that,"

Fernández, who is settling into his new position and preparing to coach Team Canada at the Paris Olympics, came here after two years as Mike Brown's top associate in Sacramento, where the Kings went from 30-52 to back-to-back playoff appearances following his arrival.

The 41-year-old native of Badalona, Spain knows his best chance of orchestrating a quick turnaround in Brooklyn is keeping Clayton in place

keeping Claxton in place.
"I believe he'll be Defensive Player of the Year," Fernández said at his introductory

press conference at the team's HSS Training Center in Industry City last month.

Claxton finished tied for sixth in the NBA with 2.1 blocked shots per game. He also averaged 11.8 points and 9.9 rebounds per contest

The 6-foot-11 former second-round pick ranked fifth in the league in field-goal percentage at nearly 63%.

All of those numbers, combined with his ever-improving skills in every offensive and defensive category, would make him a commodity on virtually every team in the league.

But Fernández and Marks agree that Claxton's original NBA home since he was picked out of Georgia with the 31st overall selection in 2019 is right on the corner of Atlantic and Flatbush.

"For us, he's a priority in this summer," Fernández reiterated.

"And the way we can play through him -- obviously he's great in pick-and-roll, he's quick to the rim, he puts pressure on the rim -- but also his ability to play the dribble-handoff game, which, as you guys know, lately in the NBA is a style that is very efficient."

The 25-year-old Claxton may be worth up to \$25 million per year this summer, a number Marks is obviously willing to fork over, as evidenced by his commitment to bring him back in the regular season's aftermath.

"We hope (Claxton's) a Net for a very long time," Brooklyn's GM said. "We hope we can continue to build around him, and build with him, and so forth."

Before the Nets made Fernández's hiring official, Claxton weighed in on what he'd want from the franchise's next coach.

"I just want transparency. Somebody that's going to keep it real with me, look at me as a man," he said.

Cam Thomas, the Nets' leading scorer last season, is eligible for an extension this summer, something he and Marks will likely iron out following the best of the shooting guard's first three seasons in our borough.

Thomas averaged 22.5 points per game while starting 51 of the 66 contests he participated in.

The 22-year-old Louisiana State alum paced the Nets in scoring in each of their

final 10 contests, including a 41-point effort against the archrival New York Knicks in Brooklyn's penultimate game.

Thomas wasted no time addressing his desire to remain a Net following the season.

"I love it here. I got drafted here, so I'll always have a place for it," he noted. "I never really had doubts about playing here."

Claxton will likely say the same as soon as owner Joe Tsai and Marks give him the contract he's earned this summer.

A costly school for autistic youth operates with little oversight – students have suffered

From the first months that Brett Ashinoff was at Shrub Oak International School in New York, his parents felt uneasy about the residential school for students with autism.

They worried that Brett, who already was thin, was losing weight. They said his nails weren't getting cut. He would refuse to get into the car to return to Shrub Oak after visits home, sitting for hours on the porch until his father coaxed him into the vehicle.

His parents' concerns, documented in email exchanges with school administrators, began soon after he started in April 2022 and grew over time. Brett's speech therapy was reduced because of limited staff. He wasn't given his medication for at least five days in a row. "Kindly accept our sincerest apologies," Lauren Koffler, a member of the family that operates the school, wrote in an email to Brett's mother about the medication. She said an error with the pharmacy was responsible for the lapse.

Then came a series of confrontations with overnight staff in February 2023. Brett, his parents said, had never been physically restrained at a school before going to Shrub Oak. But employees restrained the 18-year-old, who weighed 95 pounds, at least three times one week after he became aggressive with them. One of those nights, several employees took him to a padded room and held him down on the floor. He sustained injuries, including a cut on his leg, according to emails between the school and his parents.

When Brett called his mother crying and begging to leave, Russ Ashinoff, his father, got in his car and drove two hours from his home in New Jersey to Shrub Oak, located in Westchester County.

He said he arrived to find Brett shaking, his foot purple and swollen. His nose was bruised and cut. "He was inconsolable, not himself," Ashinoff said. He took Brett to an emergency room, where he was sedated, records show. Brett had never before needed to be sedated, his father said.

Ashinoff said he tried to report suspected abuse to several agencies in New York. The attorney general's office took his complaint but told him it didn't have jurisdiction and referred him to the New York State Education Department, according to the attorney general's office. The Education Department told Ashinoff that it, too, couldn't do anything, he said.

Ashinoff scribbled notes on the back of an envelope as he was repeatedly turned away.

"I never imagined you could have a school with a bunch of kids who are vulnerable that would be a free-for-all," said Ashinoff, a physician. "The health department comes in and looks at every McDonald's, but nobody is going to check out a school?"

He's right. No state agency oversees Shrub Oak, which enrolls a range of students with autism including those whom other schools declined to serve and who have severe behavioral challenges and complex medical needs. The private, for-profit school chose not to seek approval from New York's Education Department.

That means it has gotten no meaningful oversight and state officials have had no authority over the school — over who works there, whether money is spent properly and if the curriculum and services are appropriate for students with disabilities

Even without New York's approval, Shrub Oak receives public money from school districts across the country that pay tuition for the students they send there.

Shrub Oak opened in 2018 with grand promises: beautiful dorms, an indoor therapy pool, an equestrian stable, a restaurant-quality kitchen, sophisticated security, round-the-clock care and cutting-edge education for students with autism from around the world.

Some of those promises never materialized. A ProPublica investigation — based on records from school districts, court documents and interviews with nearly 30 families and just as many workers — also found accusations of possible abuse and neglect: unexplained black eyes and bruises on students' bodies, medication mix-ups, urine-soaked mattresses and deficient staffing. Many parents and workers, armed with confidential documents and photos of student injuries, described their futile efforts to get authorities to intervene.

Shrub Oak's leaders declined to be interviewed. In written responses to questions from ProPublica, the school said it "handles some of the most complex cases" of students who have autism and who struggle with "significant self-injurious behaviors," aggression and property destruction.

"Our success stories are now known among parents and many of the currently enrolled students were recommended to us via word of mouth," the school wrote in its response, provided by crisis communications specialist Richard Bamberger. He arranged interviews with four families who said the school has been a godsend for their children.

Shrub Oak is among the most expensive therapeutic boarding schools in America. Tuition for residential students is \$316,400 this school year. Many students require a dedicated aide for 16 hours a day, bringing the total to \$573,200. Shrub Oak currently enrolls about 85 students, ages 7 to 23, from 13 states and Puerto Rico.

Though the school touts its expertise with students who need constant care, police records detail young people swallowing aluminum foil, plexiglass, diapers and their own feces; putting their heads or fists through windows; and running away as recently as late March.

Last year, two Shrub Oak workers were criminally charged for abusing students, though one case has been dropped. The other worker is due in court on Thursday.

Shrub Oak struggles to maintain enough workers, particularly during evenings and weekends. It doesn't always provide the dedicated aides it guarantees, records and interviews show. And the school's leaders also have hired employees with criminal convictions for offenses including robbery and burglary — something that would be prohibited in many students' home districts.

The New York Education Department said it does not track how many unapproved schools operate in the state. It oversees hundreds of approved private schools, which gives them the ability to issue diplomas and take tuition money directly from New York school districts.

New York's position is that the states sending students to Shrub Oak are responsible for them. But some states and districts have struggled to monitor students' progress or well-being or didn't check on them in person, the ProPublica investigation found. The failures of oversight come at a time when more young people are being diagnosed with autism and school districts and fami-

lies are desperate for help educating them.

Shrub Oak said the school has been working with New York to get approved. But the state Education Department and other agencies that would need to sign off said Shrub Oak has not filed applications with them.

The school said its tuition rates are reasonable, especially given all the services it provides. It defended its hiring practices, saying it gives individuals with criminal histories a second chance as long as their misconduct didn't involve children. Shrub Oak investigates allegations of misconduct by staff members, involves police and "fires employees involved in an issue," the school said.

Shrub Oak said it could not comment on incidents involving individual students, citing the need for confidentiality, and asked reporters to have families sign a broad waiver provided by the school's lawyer. ProPublica's lawyers modified the waiver to enable the school to release information relevant to ProPublica's questions. One former adult student and a parent of another student signed that but two did not, including the Ashinoffs. Shrub Oak still declined to address individual cases without its version of the waiver.

Koffler, a top administrator at Shrub Oak, said the school uniquely serves all types of students with autism, from those learning basic life skills to others who will go to college. "It's a beautiful thing to be able to service the entire spectrum," she told reporters during a tour of the school.

The Ashinoffs never took their son back to Shrub Oak. They had a friend collect his things.

Brett, at home with his parents in New Jersey, would rather jump around in his bounce house or play with his dog, Otis, than talk about the nine months he spent at Shrub Oak.

"I hate Shrub Oak," he said, barely above a whisper. He dropped his head. "It's kind of sad," he said, and then decided he didn't want to talk anymore.

As Michael Koffler and his family were creating Shrub Oak in 2016, they were still dealing with the fallout from a state investigation into their alleged misuse of taxpayer money for personal gain

That October, New York authorities publicly accused Koffler and his two sons, Brian and Daniel, of using state money intended for students with disabilities at Sunshine Developmental School, a special-education preschool in New York City, to pay family members' inflated salaries, credit card bills and boat expenses. Some state money also paid Brian Koffler's law school tuition, and Michael Koffler claimed maintenance on his Westhampton beach home and purchases in St. Barts as business expenses, according to the investigation by the New York state comptroller, attorney general and tax commissioner.

"We won't allow special education programs to be exploited for personal financial gain," then-Attorney General Eric Schneiderman said in a press release.

The family and its business, K3 Learning Inc., "launched a scheme" to avoid paying millions of dollars in personal and corporate income tax and had also created a real estate company that it used to mark up rent to Sunshine, the tax commissioner said at the time.

The family did not admit any wrongdoing but agreed to pay New York \$4.3 million to settle the case. Michael Koffler's sons have paid what they owed, records show. But Koffler and his wife are delinquent. The state issued a tax warrant, and with penalties and interest the couple now owe \$2.9 million. Michael, Brian and Daniel Koffler did not respond to a request for comment. The school's spokesperson said "the tax warrant case is unrelated to Shrub Oak."

Six weeks after the settlement was announced, Brian Koffler applied to establish Shrub Oak International School, the family's first boarding school, as a business in New York. Michael Koffler used K3's business address and his company email address in financing documents to open Shrub Oak, records show.

Shrub Oak said in its responses to ProPublica that "K3 is unrelated to Shrub Oak." But some leaders are the same; Michael Koffler is the CEO, Brian Koffler is the general counsel and a consultant. Brian Koffler's wife, Lauren, is head of admissions, communications and client relations. In his LinkedIn profile, Michael Koffler lists himself as K3's CEO and under his experience there mentions Shrub Oak, calling it "a crowning achievement to date."

Shrub Oak took over the property, a former seminary on 127 acres of rolling hills in Mohegan Lake about an hour outside of New York City, in late 2017. The goal was to enroll about 400 students, and Shrub Oak's leaders worked to create buzz about their new project. Email blasts to school district officials touted the "extraordinary personal attention" that students would get. Advertisements promoted a luxe facility with impressive amenities. A piece in Architectural Digest extolled its renovation.

While the initial idea for Shrub Oak was to be a high-end school serving autistic students as they transitioned to adult life, leaders broadened the vision to include difficult-to-place students with immense challenges. The school then made direct pitches to public school districts, navigated states' varying rules for funding and helped families understand how they could get public money to pay the tuition.

Shrub Oak's leaders are currently responding to another market demand as they prepare to open their next venture this summer. The Pines at Shrub Oak, a 24-bed wing within the same building as the school, will enroll autistic students who are experiencing a psychiatric crisis.

In response to inquiries from ProPublica about Shrub Oak, the school's spokesperson arranged interviews with families who described similar traumatic experiences that led them to send their children to Shrub Oak and why they believe the school is essential.

Ed Dasso described the pain of realizing his two autistic sons couldn't stay at their local school or in his home because of their aggressive behavior. His school district, in a suburb west of Chicago, agreed that Shrub Oak was the best option after other schools closer to home turned them down.

As he prepared for an admissions call with the school, Dasso said he thought: "If this doesn't work out, I think I have to give up custody of the boys." His sons, who are 16 and 18, moved to Shrub Oak about eight months ago and Dasso said he feels that they are well cared for and are experiencing new things. "They basically saved our family and saved the boys."

Kristin Buck expressed the same gratitude. Her 13-year-old son, Teddy, interviewed for a spot at Shrub Oak from a juvenile detention center after a violent outburst landed him in custody. He had been there for six months and was terrified, she said. At Shrub Oak, Teddy gets more attention and the school has figured out what triggers difficult behavior for him, Buck said.

"There were no other schools for Teddy," said Buck, whose family lives in the suburbs of Chicago. "Everybody turned their back on us. What instance can you think of where the police can't help you, hospitals can't help you, schools can't help you?"

A few other parents, including those not provided by the school's spokesperson, said they are aware of troubles at the school but believe their children have done well.

"I know that it's not perfect," said Brandy Carbery, from Bartlett in suburban Chicago. She said that she doesn't know where her family would be without Shrub Oak, and that her 14-year-old son Alex has taken trips into the community and enjoys the school's sensory room. But, she added, "I know that some people have issues.'

As ProPublica was reporting on Shrub Oak, some state education officials and advocates for people with disabilities were looking more closely at the school.

Massachusetts acknowledged to ProPublica that it approved Shrub Oak two years ago in violation of its own requirements. The state allowed public money to pay students' tuition there after it failed to realize that New York had an approval process - and that Shrub Oak had not sought that approval. The Massachusetts education department discovered the error after receiving complaints about the school from at least two districts and parents. It gave the seven districts with publicly funded students at Shrub Oak until July to find other placements for them.

And last year, Disability Rights New York, the federally appointed watchdog for people with disabilities in the state, launched an investigation and visited the school. DRNY said in recent court filings that it has received more than 40 complaints about the school, including students being denied medical attention and staff being discouraged from calling 911 — allegations the school said are false. The organization can release its findings publicly and sue to seek changes, but it does not have enforcement authority.

The group filed a lawsuit last month against the state Education Department after the agency denied responsibility for Shrub Oak and argued it didn't have to provide records of any complaints. The department has cited the school's nonapproved status as a reason for denying the records, saying it does not have responsibility for "investigating incidents of abuse or neglect, injury or Shrub Oak.

mation but have not shared their concerns, leaving the school unable to respond.

DRNY declined to comment to ProPublica. Disability Rights Connecticut would not comment except to say that the group has "information that is of great concern to us."

Last October, soon after the school day ended, a Shrub Oak employee began menacing a student who was yelling, court records show. The man raised a desk over his head and threatened to throw it at the 22-year-old student from Chicago.

He also knocked on the student's forehead with his knuckles four or five times "similar to a way a person would knock very hard on a door," according to the sworn statement of an employee who said she witnessed the incident.

The student said, "Ouch, you are hurting me," according to that statement, and the student at one point grabbed the right side of her stomach and cried out that she'd been hit.

The employee was fired then charged with three misdemeanors - menacing, harassment and endangering the welfare of a disabled person. He has pleaded not guilty.

"You send your kid to a residential school because you can't handle all the things they need," said the mother of one current student. "So they go to a school where they will have a team of experts, and you trust that the school will provide that. They are not providing that.'

A current employee described his concern over a student who was isolated in his bedroom as punishment. Like the Ashinoffs, he found he had nowhere to turn. He tried the state Education Department and the Justice Center, which investigates allegations that students with disabilities have been abused or neglected. He said both agencies told him they had no authority over unapproved schools.

"It broke my heart," the employee said. "Who is watching out for these students?"

Other workers and parents expressed their alarm at failures to address students' basic needs: medicine, hygiene and food.

"I had a student almost die because he had a seizure and almost stopped breathing. They had stopped giving him medicine," said a former behavior specialist at the school. Police records and emails describe students taking the wrong medication or none at all. Shrub Oak told ProPublica that it has changed its medication practices.

Several parents also said their children uncharacteristically began urinating and defecating in their rooms because they were locked out of bathrooms overnight. Shrub Oak said some students have conditions that lead them to soil themselves — sometimes intentionally — and that staff are always available to let students in the locked

And for years, Shrub Oak leaders have been telling parents that a "restaurant-quality kitchen" would be finished "by year end" or in a few months, records show.

Instead, the food mostly comes from a nearby deli, though the school says Shrub Oak's chef and nutritionist "are beyond compare." (The therapy pool and equestrian stable also have not been built.) Shrub Oak told ProPublica on April 12 that the kitchen is slated to open "within days," pending completion of electrical work. As of Tuesday, the kitchen still was not open.

"The promise of this place was magic," one mother from California said. She pulled her son from Shrub Oak last year and sent him to an approved residential school for autistic students.

"Why they're even allowed to have a school, I have no idea," she said.

State lawmakers slam cannabis contract with private equity firm

A New York lawmaker called for the state to sever its relationship with a Chicago-based private equity firm helping to fund weed dispensaries run by people impacted by the war on drugs following a report from THE CITY revealing alarming details of the agreement.

"The state and the cannabis marketplace would be better served by investing our stake in non-profit community development funding and ending the relationship with these predatory stakeholders," said state Senator Gustavo Rivera (D-The Bronx), a member of the cannabis sub-

In 2021, Gov. Kathy Hochul announced a \$200 million public-private fund that would offer loans to a special class of retail licensees created for people impacted by drug convictions. Those loans would cover the costs of building out their own stores at locations scouted and leased by the fund. New York allocated \$50 million to the fund and secured additional private capital through a loan from Chicago Atlantic Group, a real estate investment group.

But last month, THE CITY revealed that the cannabis fund is locking licensees into loans as high as \$2 million to build out each dispensary with strict repayment terms that experts say are likely to lead those licensees to default. The details of the agreement, which state officials refused to make public, reveal that the state guaranteed Chicago Atlantic Group's return on its investment no matter how the stores perform-ultimately leaving taxpayers to pay if the dispensaries fail.

He said that he was "deeply concerned" that the deal is "placing an outsized, unsustainable debt burden on licensees with the potential to extract all of their profit and then some."

Concerns about the New York Social Equity Cannabis Investment Fund's deal with Chicago Atlantic surfaced last October at a hearing about cannabis legalization led by Sen. Jeremy Cooney (D-Rochester), who chairs the cannabis subcommittee. State officials defended the terms of the loan at the hearing and said they were committed to the success of the licensees' stores. But some licensees and advocates raised alarms about the

high costs associated with the loans.

The fund "is exposing the most vulnerable New Yorkers to predatory exploitation," Eli Northrup, a Bronx Defenders lawyer who works with license applicants, said in his testimony on

At the time, few details were known about the deal that state officials had agreed to in order to secure funding from Chicago Atlantic Group.

Assembly Majority Leader Crystal Peoples-Stokes (D-Buffalo), who sponsored the original cannabis legalization bills, said in an interview with THE CITY last week that leaders declined to share with her the details of the agreement. Cooney also told THE CITY that he had not seen the agreement.

'I do have a problem with the lack of transparency on what the agreement looked like. I'm not the only one who asked for an opportunity to take a look at it but it wasn't provided." Peoples-Stokes said. "This is government. We can't have things that are done undercover."

State agencies denied multiple Freedom of Information Law requests and appeals for the document by THE CITY, which eventually obtained a late draft copy of the agreement as well as internal agency documents that showed the Office of Cannabis Management was also concerned about

Peoples-Stokes said that while she was not surprised by the revelation that the state had agreed to guarantee Chicago Atlantic Group a 15% interest rate on its loan to the fund, it showed that the state could have simply directly offered the loans directly to the licensees.

"Honestly, we all would have probably been run out of here, but the state should have just funded this themselves," she said.

THE CITY also found that the loans offered to licensees by the fund in at least some cases contained inflated costs.

Last year, the fund offered a licensee, Keith Dalessio, a dispensary site in Astoria. When he learned that the loan to cover the construction costs would be at least \$1.6 million, it was so astronomical that he wasn't sure he wanted to accept a loan from the fund at all. Dalessio, who owns a nearby pet shop, later discovered a subcontractor had done the build-out work for only about \$250,000, according to invoices reviewed by THE CITY. Eventually he decided to walk away from the fund's loan offer.

Today, the storefront sits empty. The fund has spent more than \$2 million on the location between rent and build out costs.

Peoples-Stokes told THE CITY that she still supported providing loans through the fund because they offer an opportunity for people who may not qualify for small business loans. But she added that she wanted to see the costs associated with the loans lowered.

"Not every store needs to be a flagship location. There are people who are in business who did not take loans from the fund, and they have beautiful businesses. I've been to them," she said. "The costs of construction can be brought way down."

Cooney told THE CITY the deal with Chicago Atlantic deserved more scrutiny. "New York State should be doing everything it can to support the success of entrepreneurs impacted by the failed War on Drugs," he said. "The fact that the social-equity fund may be having the opposite impact is very concerning."

On the hot seat in Washington, Chancellor Banks defends NYC schools' response to antisemitism

New York City schools Chancellor David Banks defended his record on antisemitism during a tense congressional hearing Wednesday, maintaining that schools have consistently responded to troubling incidents with both education and dis-

Banks joined school leaders from Montgomery Country, Maryland and Berkeley, California, along with an American Civil Liberties Union staff attorney, in a hearing convened by the House Committee on Education and the Workforce about "confronting pervasive antisemitism in K-12 schools."

Wednesday's hearing came in the wake of previous high-profile committee hearings with university leaders that helped lead to the resignation of multiple college presidents. Republican members of Congress say the hearings have shown that higher education leaders have failed to adequately address antisemitism on their campuses in the wake of the Oct. 7 attacks on Israel by Hamas. They used the hearing to press K-12 leaders like Banks about similar concerns.

When he introduced the panel, GOP Rep. Aaron Bean said that the aftermath of last year's attack revealed "some of the ugliest" ideas, and that "our education system has failed" to stop those ideas.

"Jewish students fear riding the bus, wearing their kippah to school, or even just eating and breathing as a Jewish student," Bean said.

Banks, who presides over the nation's largest school system with more than 900,000 students and roughly 150,000 staff members, acknowledged that the system's diversity means "our classrooms have not been insulated from the global stage."

"There have been unacceptable incidents of antisemitism in our schools," he said.

Banks emphasized both an education-focused response, including the introduction of several new curricula on preventing hate crimes and on the Holocaust and Jewish history. But he also said that Education Department officials have "removed, disciplined, or are in the process of disciplining" 12 staff members related to incidents of antisemitism.

At least 30 students have been suspended for their roles in antisemitic incidents, he said.

The incidents of hate in city schools following the Oct. 7 attack have not just been directed towards Jewish students, Banks noted. Out of a total of 281 incidents of religious bias in city schools since Oct. 7, 42% involved antisemitism, while were directed against Muslim students, he

Asked by Rep. Jamaal Bowman, a New York Democrat and former Bronx public school principal, whether the city could combat antisemitism while simultaneously confronting other forms of bias, Banks said: "Not only can we, but we must."

Banks rebuts claim about antisemitism among school's students


Several of the most heated exchanges at Wednesday's hearing focused on the fallout from a raucous student demonstration at Hillcrest High School in Queens — Banks' alma mater — where students filled the hallway demanding the ouster of a teacher who posted a picture on social media shortly after the Oct. 7 attacks holding a sign that read "I Stand with Israel."

After the demonstration, Banks called the "the notion ... these kids are radicalized and antisemitic" the "height of irresponsibility."

When Rep. Burgess Owens, a Utah Republican, challenged him about that comment, Banks told Owens he stood by it, and argued that "the entire school was not radicalized." He added that "the kids who were responsible, who led that effort, engaged, clearly, in an act of antisemitism, and I dealt with that." A "number" of these students were suspended, the chancellor said.

Banks also stressed that he removed Hillcrest's principal, Scott Milczewski, midway through the year over concerns about his leadership. Milczewski was moved to a job in the Education Department's central bureaucracy.

Several representatives grilled Banks on why Milczewski was still employed by the city's Education Department and accused him of misrepresenting Milczewski's status.

"How can Jewish students feel safe in New York City schools when you can't even manage to terminate the principal of 'Open Season on Jews High School'?" demanded Rep. Brandon Williams, a Republican from New York.

Banks responded that while he didn't think Milczewski was fit to continue leading Hillcrest, employees have due process, and the chancellor doesn't have the authority to terminate someone just because he disagrees with what they've done.

Banks also faced heat over Hillcrest from New York Republican Rep. Elise Stefanik, who noted that, earlier in the hearing, Banks appeared to answer "yes" to a question about whether staff members about Hillcrest had been fired, despite his continued role working for the department.

"That's concerning to me that you have him in a senior position," she said.

(Rep. Lisa McClain, a Michigan Republican, asked Banks, "So, you fired the people?" Banks replied, "Yes, we moved people, absolutely.")

Emerson Sykes, the ACLU attorney, warned that while schools are required by federal law to respond to "hostile" educational environments, certain criticism of Israel and its government are protected under the First Amendment.

"Firing may be appropriate in certain circumstances," he said. "But I think we need to think about how we can address antisemitism, change hearts and minds, make children safe, without only looking to the most punitive tool in our tool-

Lawmakers highlight allegations of rampant antisemitism

Lawmakers raised concerns about the climate at other New York City schools in recent months.

For example, they brought up allegations of unchecked student antisemitism at Origins High School in southern Brooklyn that are now the subject of a federal lawsuit.

Among the claims in the lawsuit are that dozens of students marched through the hallways chanting "F*** the Jews.

Banks said Education Department officials found "no evidence" in their investigation of mass marching through the hallways with hateful chants. But he did say they found other "deeply troubling" antisemitic incidents at the school. He said he couldn't comment further because of the ongoing litigation.

Rep. Virginia Foxx, a North Carolina Republican, asked Banks about a map of the Middle East in an elementary school classroom at P.S. 261 in Brooklyn that omitted Israel. The school's Arabic arts program receives funding from a foundation tied to the Qatari government, and Foxx expressed concern that the foundation was pushing unvetted materials into city public school classrooms.

Banks, however, said that the map wasn't pro-

vided by the Qatari foundation. The teacher found it on her own during a visit to Jerusalem, he said. And while Banks thought the map was antisemitic and had the map removed, after talking to the teacher, he said that she didn't intend it to be antisemitic. (The map had been hanging in the classroom for more than a decade.)

Near the end of the hearing, Banks repeated a criticism that he had leveled in the days before his testimony: that the event was designed to produce "viral moments" rather than actual solutions to complex problems.

He also blamed the problem in part on young people's emotional but misguided responses to what they see on social media.

"Ultimately, if we really care about solving for antisemitism, it's not about gotcha moments, he said. "It's about teaching."

Bowman and Connecticut Rep. Jahana Hayes, a Democrat and another former educator, emphasized the need to combat other forms of discrimination, including Islamophobia, alongside antisemitism.





Council grills NYPD brass over tweets targeting Queens lawmaker and others

missioner of legal matters, rebuffed nearly each of the questions lobbed at those testifying regarding the posts.

At one point during the hearing, Adams began to direct her questions to Commissioner Caban, who, up until that point, had been allowing Gerber to answer on his behalf. Though he began to answer, Caban was cut off by the attorney, prompting a rebuke from Adams.

"The commissioner leads this department," the speaker said to Gerber. "I feel that was a very appropriate question for the leader of the NYPD to respond to this body."

'HORRIFYING AFFRONT TO DEMOCRACY'

Social media use among NYPD leadership began to shift earlier this year, when Chell sent out a tweet condemning a New York Supreme Court justice for releasing an alleged repeat offender on bail

Chell's tweet, which named the judge, caused a firestorm. It was picked up by media outlets, and posters online also began piling on the jurist

However, Chell got a number of his facts wrong. Not only had wrongly said that the case had taken place in Manhattan – it was in the Bronx – but he misidentified the judge.

Nonetheless, Chell stuck by his tweet, claiming that it was only his comments on the failure of bail reform that matter.

Chell's tweet appeared to mark the start of an escalation of the NYPD's use of its over 200 social media accounts, some of which are managed directly by top police officials, including Chell's

In the weeks and months that followed, the NYPD sent out a number of tweets targeting journalists, lawmakers and others, often engaging in back and forths that appeared to escalate the various arguments.

At the start of May, Councilmember Cabán sent out a tweet criticizing the NYPD's use of force against pro-Palistinan protesters on a number of college campuses across the city.

"Last night's authoritarian conduct by Columbia University administrators and Mayor [Eric] Adams' NYPD were a colossal disgrace, a horrifying affront to democracy and free speech, and an abject failure of public safety," the Queens lawmaker said in her post.

Though a vast majority of Cabán's tweet was directed at Columbia University leaders, Chell responded, calling Cabán's message "garbage," and referring to the elected official as "a person who hates our city and certainly does not represent the great people of NYC."

He then copied and pasted Cabán's message, replacing a number of nouns so that the

message condemned the protesters.

"Last night's criminal conduct by entitled non accountable students and the support they receive from Councilmember Tiffany Caban is a colossal disgrace," Chell said. "A horrifying affront to democracy and proper behavior from people who are not accountable for their behavior."

Chell signed off his message by urging his readers to "seek the change you want by getting involved."

"Then you know what to do," his tweet ended.

On Thursday, Adams asked NYPD leader-

ship what Chell meant by the tweet's ending.

"City law prohibits the use of city resources for political purposes," the speaker said. "That seems to be conveying a political message, and potentially even worse, a message that could be misinterpreted and lead to threats."

In response, Gerber declined to answer, expressing a desire not to compromise the DOI investigation, which was launched at Adams' request.

"It's important and necessary that we allow that investigation, that inquiry to play out as an independent investigation as requested by you," he said.

BEHIND THE BENCH

Christopher Norman is a part-time soldier but a full-time court clerk

Queens Court Clerk in the Small Claims Part Christopher Norman has been able to inform his court work with lessons learned in his second job as a U.S Army reservist.

When Norman, a Long Island resident, joined the court system, he already had more than a decade with the Army, and before and since has been deployed to places far away from Sutphin Boulevard.

Though he's been missed in the court system when he's called to service, the court system has "always been very accommodating."

"I go on temporary leave of absence and get deployed," Norman said.

Those deployments have seen him go to Iraq, Kuwait, Syria and Guantanamo Bay, Cuba.

"The military fully prepares me for anything that the court system will throw at me," he said. "Because everything in the military has to change five times before it's official and the court system seems like it only has to change about three or four times."

Also a father of a 10-year-old and a 13-year-old, Norman said that being in the military has

exposed him to a wide range of people and experiences, which he is able to translate back to his work in Queens courts.

"It just makes dealing with the public easier," he said. "Working on controlling a court-room and all that other stuff."

"When you're in a leadership role in the military, you have to be able to manage people," he added. "In the court system, you have to manage the courtroom, that's your job as a court clerk."

Norman says he's loved his work in Queens' courts, particularly in Small Claims.

"Small Claims is great because of the volume, and it's fast paced – there's never a dull moment," he said. "There's never any downtime, you're constantly busy. Which is good. I like that."

On Sutphin Boulevard, Norman has found the comradery and family mentality that one might generally associate with his other job.

"I have had wonderful mentors, and the people, the staff, everybody in the court system is like a giant family – the same kind of what is in the military," said. "I could die in Queen Civil and be happy."
